Evening Post newspaper 18 September 1924

Upper Hutt Town Board Election – The biennial election of Upper Hutt Town Board took place yesterday. Keen interest was taken. There were fourteen candidates for seven vacant seats. The voting was - Messrs J Blewman 342, C T Jones 312, A J McCurdy 283, J Martin 270, J Greenwood (re-elected) 243, T S Burrell 237. The ex-chairman, Mr W Greig, secured sixth place with 238 votes. The other candidates were Messrs W J Robinson 216, Osborne 178, Kitchen 156, Guthrie 148, Seller 140, Rogers 138, and Goss 93. Of a total roll of 1014 names, of which nearly a quarter were not residents of the district, over 50 per cent, recorded their votes. Over 75 per cent of the resident electors were polled, both percentages being Dominion records in local body elections.

Upper Hutt Town Board - The first meeting- of the newly-elected Town Board was held on Friday night, when Mr Angus J McCurdy was elected chairman and also appointed delegate to the Hutt Board Local Authorities Committee. The following committees were set up on the motion of the chairman - Works (waterworks, road works, river protection, etc.), Commissioners McCurdy, Greenwood, and Blewman, Health and Public Services (health, sanitation, and rubbish removal, first brigade, town band, electors, and ratepayers' lists, railway, postal; telegraph, and telephonic services, etc.) Commissioners Jones, Martin, and Burrell, Building and Bylaws (including legal matters), Commissioners McCurdy, Greenwood, and Craig. The first-named in each case is the convener of that committee.

#### Evening Post newspaper 12 December 1925

Sanitary Depot at Upper Hutt - The suitability or otherwise of the proposed site of Upper Hutt's new sanitary depot still continues to agitate the minds of local residents. Recently, in a letter to "The Post," Mr J Urwin criticised the scheme, and his remarks have called, forth in, contradiction from Mr Angus J McCurdy, chairman of the Upper Hutt Town Board. Mr Mc Curdy submits that some three years ago the Health Department condemned the existing dump at Ebdentown on the ground that the land was sewer-age-saturated. When the present Town Board took office in 1924 it had to face the position for the previous board had done nothing in the matter. Site after site was examined, and eventually the sewerage scheme of Mr H Toogood was approved. The septic tank site is located at the foot of Wakatike [sic] road, over a mile westward of Gibbons road. A sanitary dump is not available there owing to the proximity of Cluny Farm milking shed. Mr McCurdy and Commissioner Burrell, as a special committee have been examining sites for months past. Dr Boyd, District Health Officer, has approved of the Gibbons road site, and this without any recommendation or suggestion, from members of the Town Board. The Special Committee reported that the land was available at £550 that a road along the river front to give access to gravel deposits might be made and on the completion of the sewerage system in a year or two, the land could be converted into a recreation ground of some 4½ acres. The portion which was available for a dump would be a quarter of a mile from the Gibbons road frontage, and under the Health Department's conditions could not possibly create a nuisance. Mr McCurdy states that that report was ordered to be laid on the table. Since then Commissioner Burrell and Mr McCurdy had acquainted Mr Urwin of the whole facts. This Special Committee had had in view a site on the Moonshine road, across the Hutt River, and Dr Boyd's Department had duly approved of this site. The Town Board at its meeting unanimously authorised Commissioner Burrell and the chairman to acquire or lease the land mentioned.

Obituary - Thomas Samuel BURRELL - A well-known resident of the Upper Hutt district Mr T S Burrell died at his residence in Ebdentown on Saturday night last. Mr Burrell had been ailing for some little time but his death came as a shock to his relatives and friends. Connected with farming all his life he yet found time to interest himself in Rugby football and at the time of his death was chairman of the Upper Hutt Rugby Football Club in which organisation his loss will be greatly felt. The late Mr Burrell is survived by his widow, three sons and one daughter. The funeral took place on Monday last at Trentham where representatives of the business farming and sporting communities gathered to pay their last respect
