Public Confession - Councillors and Hosing - Upper Hutt Restriction

A confession was made by three councillors at the meeting of the Upper Hutt Borough Council last evening that they had disobeyed the restriction imposed in respect to hosing. The pressure of water became so low in some parts during the dry spell that all hosing had to be prohibited. Councillor W Fortune was the first to confess. He moved that the hosing restriction be withdrawn between 10 pm and 6 am, on the understanding that during that time the hose be held in the hand. Some people in the district he said derived their livelihood from horticulture. The need was not so great now as before as the dry spell seemed to have ended. He thought there would be ample pressure during the times he suggested. He had tried out the pressure at 6 am he said and found it ample. In supporting Councillor Fortune's motion Councillor J Purvis also admitted using a hose. Councillor A Howell also admitted being one of the culprits but he said that he rose earlier than the others to do his hosing getting up for the purpose at 3.30 am. The Mayor (Mr A J McCurdy) drew attention to what would happen if everyone wanted to water their gardens. While the weather was wet fewer people would want to hose. Councillor W Greig stated that he supported the Medical Officer of Health (Dr W F Findlay) when the restriction was imposed but he supported the proposal for hosing between 10 pm and 6 am when the pressure was ample. Councillor F P Keys said he had been away but had wondered when he returned at the nice gardens of some of the councillors. Councillor G H Guthrie thought that provided people held the hose in the hand there was no harm in allowing hosing. Councillor Fortune's motion was carried unanimously. Some jocular remarks were passed as to the consequences of councillor's admissions. Councillor Purvis said he hoped that if he was brought up before Councillor Greig who is a Justice of the Peace he would be allowed off with costs. Councillor W Fortune who is a solicitor jocularly suggested that summonses should be issued but the councillors also in jocular mood would not agree. "You're looking for work" they remarked to Councillor Fortune.
