Edward W Butler surveyor was charged by William Francis of the Upper Hutt with feloniously stealing a horse, saddle and bridle on the 21st October of the value of £10. Mr Cheeseman appeared for the prosecution and Mr Gordon Allan for the prisoner. William Francis farmer on being sworn deposed - I made an arrangement with the prisoner which was reduced to writing. I produce the document, Butler owed me some money, near £30, he told me he would let me have two horses and pointed them out to me, one was a grey mare, the other a dark brown gelding, there was a brand on the grey mare on the near shoulder. I took possession of both. The horse were then grazing on my own land. I took the receipt for the horses on the 13th August. I am not in possession of either of the horses. They disappeared without my knowledge. I should know the horses again. I saw one of them being shod at a blacksmith's shop on Monday last. I gave information to the police that my property had been taken away. I saw the horse again this morning in possession of Thomas Barton who was leading it in - it was the same mare that was taken off my premises. I value the mare with saddle and bridle at about £10. The witness and counsel then proceeded to examine the horse. Examination continued - The horse is my property. The saddle and bridle are mine. They were part of my purchase. R S Cheeseman deposed - About six weeks or two months ago the prosecutor came to my house and produced me a receipt. He requested me to meet him at Barrett's Hotel which I did. The prisoner was present at the hotel. The prosecutor and prisoner wished me to draw a bill of sale for the property mentioned in the receipt which had been produced. I told prosecutor, having possession of the property, having made a bona fide purchase, a bill of sale was unnecessary, as I considered the receipt quite sufficient. I was paid £1 for my advice by the prosecutor with the advice and consent of the prisoner. Cross-examined by Mr Allan - Prisoner and prosecutor wanted to secure the property from being seized by Mr Buck for rent. I am quite positive that the property was not held as security for a debt. I did not know that the money had not been advanced by the prosecutor. The prosecutor and prisoner wanted a bill of sale to prevent the property of Francis being seized. They wanted a bill of sale to protect Francis. I told them that the receipt and possession was sufficient for that purpose.

Thomas Barton butcher Upper Hutt deposed - I brought a mare outside the Court just now which is in my charge. It was handed over to me for a debt of £8 5s by the wife of the prisoner. I took possession of it in Wellington the prisoner was walking across the paddock at the time. The prisoner has not told me anything about this horse. I did not know the horse belonged to Francis. David Hughey deposed - I am a storekeeper residing at the Hutt. I have seen the mare outside the Court, I have seen her before. The prisoner never offered the mare for sale to me at any time. Mr Allan said that there was no case against the prisoner. The Court concurred in this view the matter and ordered the prisoner to be discharged.

#Obituary - Mr W Francis - With the passing a few days ago of Mr William Francis, of Monrad Street, there was removed another of the band of Manawatu pioneers. Born in Upper Hutt 83

years ago, the late Mr Francis came to the Manawatu when 26 years of age, following the trade of sawmilling for many years between Palmerston North and Ashhurst. He remembered Wellington before there were any wharves, and Palmerston North when it was a small bush settlement. Mr Francis eventually took up farming, carving his first little farm out of the bush at Ashhurst. For short periods he farmed, in the Pahiatua, Waikato and Glen Oroua districts, returning to Palmerston North some 20 years ago. Mr Francis married 62 years ago Miss Mary Williscroft, of Carterton, who is left to mourn his passing. He had enjoyed good health until about two years ago. He took part in the Jubilee celebrations and only the day before his death had walked into the city. He was of a quiet and unassuming nature, kind to all and ever ready to do a good turn. A warm welcome awaited friends at his home at all times. Mr Francis retained his interest in sport, particularly in football and cricket, in which he had participated keenly in his day. Of the family of eight, the eldest son, Mr Frederick Francis, made the supreme sacrifice in the Great War, the other sons being Mr Jack Francis (Wellington), Messrs Henry and Walter Francis (Longburn), and the daughters Mrs J F Reay (Oroua Downs), Mrs A H Butler (Palmerston North), Mrs D G Toogood (Hamilton) and Mrs G. Scott (Auckland). There are 19 grandchildren and 15 great-grandchildren. The funeral took place at the Kelvin Grove Cemetery, Rev. S J Holland officiating at the graveside, and members of the family acting as pallbearers.
