W Greig's Views – Though Mr Greig and his committee have not honoured us with their printing or advertising we have much pleasure in placing before our readers all he said in his speech relating to Town board matters. A glance through the list of those who had seats on the platform with him readily accounts for the boycott. Mr W Greig spoke for fifteen minutes at his meeting at the town hall on Thursday to a moderate attendance of electors. He confessed his ignorance of town board affairs and 'owned up' to only having attended no town board meeting in his life. In twelve months' time, if elected he would be able to answer questions on local politics. His policy would be to study the pockets of the people. He advocated the installation of a twice a week dust cart service a fire brigade and a gas works but did not indicate whose pockets he was studying when he suggested these additional burdens upon the unimproved values. A vote of "Thanks Only" moved by N J Bennington brought the candidate's meeting to a close.

## VIRGIL MCGOVERN

Virgil McGovern is a Young New Zealander born at Kaitangata (Otago), a quarter of a century ago. He was educated primarily at Kaitangata and Taita State Schools and afterwards attended a three-years course at St Patrick's College. He has considerable interests at stake in the township, the McGovern properties being valued at over £5,000 for rating purposes. This candidate has taken a keen interest in local politics and sports for the past ten years. At the Biennial Election of 1912 he withdrew his nomination on the Advance Upper Hutt policy side so as to avoid splitting votes. On March 4th while travelling to Wellington W Greig suggested to V McGovern that if McGovern would stand for election, would not be a candidate. Seeing that at the close of last Monday's, town board meeting no one had been nominated. McGovern decided to become a candidate lodged a nomination. He is in favour of carefully thought out progressive measures and is averse to increasing the present rates on properties. He is announced to address a public meeting in the town hall on Tuesday next at 8 pm. It is only a few weeks since articles appeared in city papers deploring that young New Zealanders took such little interest in local politics. The present election affords an opportunity to the electors to give an active aspirant to town board honours a chance between now and next September's Biennial Election, to prove his fitness for the position and to show their confidence in this Young New Zealander was not misplaced.

#### HEDLEY R PEARSON

Hedley Raynor Pearson is a native of the North of England and came to this district some four years ago when he acquired Bickerton's news agency and hair dressing saloon. He dropped the latter nosiness after a time but added that of Fruiterer and tea rooms in Robinson's Buildings. Selling out all but the news agency to Mrs Hagan he continued the news business at his residence until recently when he re-opened as fruiterer and news vender in Boyd's building. At the last Biennial Election he retired in favour of H W Shaw. He is interested in two allotments and bungalow at the corner of Royal Street and the Main Road valued for Unimproved Rating at less than £200. He has not publicly expounded any policy and has only attended about half a dozen meetings of the local town board. He has twice made application for the position of Town clerk but on both occasions his application was not considered.

## WILLIAM GREIG

This candidate is in the employ of the Government Railway Department as an engine driver and requires the permission of the head of that department under Amended Regulations issued in December last, before contesting a local election. He has shown, little or no interest in local matters save as a member of the School Committee. His attendance at town board meetings has practically been confined to those occasions on which word had been passed round by a certain coterie, to Roll up and see McCurdy get hell. He was an unsuccessful candidate at last by election, on which occasion he had five town commissioners and a number of No-License and Bible-in-State

Obituary - Mr William Greig J.P. - The death of Mr William Greig, JP at the age of 77 years, occurred yesterday after a short illness. Mr Greig was one of the oldest and most widely respected citizens of Upper. Hutt, and at the time of his death was a member of the Upper Hutt Borough Council and the borough representative on the Wellington Free Ambulance, the Hutt Valley Electric Power Board, and the Wellington and Suburban Water Board.

Born at Greenock Scotland on 01 February 1863, Mr Greig came to New Zealand with his parents at the age of 11 years. He joined the New Zealand Government Railways early in his career, and spent most of his time stationed at Upper Hutt. During these years he became one of the most popular and widely-known locomotive drivers in the Wellington district. At the age of 60 he retired on superannuation.

Mr Greig took a deep and active interest in anything calculated to advance the interests of Upper Hutt, in which district he had settled in 1886. He was a member of the school committee for 30 years, during which time he served as secretary and as chairman. When the public school was transferred from Trentham to, its present site at Upper Hutt he took a leading part in the activities connected with the transfer.

When the destinies of Upper Hut were controlled by a Town Board, Mr Greig was a member, and he served as chairman for a term. After the formation of the Borough Council he served as a councillor and occasionally acted as Deputy Mayor. For the past 25 years he has given faithful public service to the borough.

He was also deeply interested in the activities of the local Druids Lodge, of which he was a Past Arch, and delegate to the conference. Mr Greig is a keen bowler and an active member of the Upper Hutt Bowling Club, of which he was the sole selector. In his younger days he was an enthusiastic cricketer and a fine shot.

He is well remembered in the district for his pleasing and cheerful disposition and high sense of honour, and was never known to decline an appeal for help. He leaves a wife, three sons, and four daughters - Messrs W T Greig (Auckland), D Greig (Upper Hutt), and A M Greig (Mananui), and Mesdames F Whiteman (Upper Hutt), K Geange (Upper Hutt), E Russell (Whiteman's Valley), and W Donovan (Christchurch).

The funeral is to be held at 2.30 pm tomorrow at Upper Hutt. The pall-bearers will be Messrs W J Greig, D Greig, A M Greig, F Whiteman, K Geange, and E Russell. Members of local bodies will carry the casket from the church to the hearse, and members of the Upper Hutt Borough, Council from the hearse to the grave. The cortege will be headed by the Upper Hutt Band, followed by a parade of firemen from the Upper Hutt and Silverstream brigades.

Born in 1886, Mr Greig joined-the New Zealand Railways in 1903, and retired on superannuation in October, 1940. He was engine-driver with the Manawatu Railway Company in 1902, entering the Government service when the company was bought out. In the company days he drove the New Plymouth express, and when the Main Trunk railway was completed drove the first Auckland express on the Wellington Palmerston North section. In 1919 he was transferred from Wellington to Upper Hutt, where he completed his long career as a first-grade engine-driver. He was the oldest running driver on the Wellington Rimutaka section.
