Dear Sir

Mr W Mason who lately bought from the Government Land adjoining me has in running off his boundary thrown me 4 chains Eighty or ninety Links onto Mr Walter Hoder (Hodder) and has Mr Walter Hoder (Hodder) had his run off by Mr W Corbet and as Mr Mason had Mr McManaway for the same purpose to the Surveyors who have been employed by the Government I should wish you to send some surveyor to at least lay off the boundary on the road frontage as it is there that the dispute is grounded as yet and ask they (the Surveyors) both profess to have taken the view as a guide the difference of 5 chains would indicate the need of caution on my part to avoid litigation that might be memoirs. I should therefore feel it as an obligation if you would help me in this matter at the same time it seems so ludicrous that two professed surveyors should make a difference of five chains in the measuring of twenty five or six chains added by interments that one would think that they mean four but as Mr Mason is improving that taken and Mr Hoders (Hodder) has warned me against improving the land on the other side I am compelled to treat it seriously.

David HART died 1880 his “Will” and first probate actioned 1881 in the Wellington Court is missing at Archives NZ in Wellington. The 1881 Will was found amongst the 1884 Napier Court probate of David HART and now held at Archives New Zealand in Wellington under the years 1877-1884.

David HART original Will signed and dated 22 May 1877 bequeathed his estate in the Colony of New Zealand and in the Colony of South Australia to Purvis RUSSELL in the Hawkes Bay. Papers attached to his 1884 probate state that David was at the time of his decease entitled to certain property (under the will of his father who predeceased him). Purvis Russell was legally identified as Thomas Purvis RUSSELL of Woburn Waipukarau Hawkes Bay New Zealand Sheep farmer but at present residing at Warroch near Milnathort Kinross Scotland and also recorded as London England. The Wellington solicitor stated that the property consisted of a piece of land in Wellington district of six hundred and sixty three acres (663) more or less and a small village section in South Australia

#Death of an Old Settler - In another column is announced the death of Mr Robert Russell at the Isle of Wight on the 9th of December last. The late Mr Robert Russell was one of the pioneer settlers not only of the Wairarapa but also of New Zealand. He arrived at Wellington (says the Wairarapa Daily Times) in the ship Theresa in the year 1842 leaving the sea which he had adopted as a profession to join his eldest brother Ms Thomas Purvis Russell who was the (fifty five years ago) engaged in sheep farming at Wanga Moana. He remained in the Lower Valley till the year 1872 when he sold out his interest in the Wanga Moana property to his brother the present proprietor Mr John P Russell and retired to England where he has subsequently resided. Many old settlers in this district will recall Mr Robert Russell, who, for some thirty years, did his duty as a Wairarapa colonist. A new generation perhaps hardly realises the debt the district owes to the pioneers who first settled the lands and made it habitable for the smaller settlers who succeeded them

#Mr John Purvis Russell - The death occurred at his residence Wellington yesterday evening of Mr John Purvis Russell brother to Mr Thomas Purvis Russell formerly of Hawke's Bay who died in the Old Country about four weeks ago. The deceased was very well known in South Wairarapa where he resided for about half a century. He started life as a bank clerk in Scotland but came to New Zealand when a youth in 1852 soon afterwards settling at Wangaimoana South Wairarapa where he carried on sheep farming for a couple of generations. For some years he was president of the Wairarapa Racing Club (though he never made a bet in his life) and he always took a keen interest in the general welfare and the public affairs of his district even during the last seven years when he was more or less an invalid. Mr Russell was of a kindly nature and it has been said of him that he never sent a "swagger" away hungry despite the fact that the sheep-farming class is frequently imposed upon by undeserving mendicants. In the troublous times with the Maoris he had hardly any disagreements with them being accorded a popularity which stood him in good stead.
