- Map part section 116 showing McLeod Street and Whakatiki Street (image saved)
- There are a lot of letters from Upper Hutt residents requesting if there are any section for sale so they can build a home
- 06 February 1962 letter advising the Poultry plant in Gibbons Street would be recited to Wallaceville Animal Research Station and that the land would be free from developing. [Note it was not until 1970 that houses were built on the land and the first home in the subdivision to be occupied was 79 Gibbons Street Upper Hutt]
