### Folk Lore – Theories – Comments - Questions

#### Folk Lore:

[1] Pumpkin cottage was built by Thomas Cotter on Section No 83 and was moved to the other side of the road and relocated on either Section No 83 or 82.

[2] Pumpkin Cottage was once the cottage used by Chief Te Kaeaea and known as Whare?

#### Theories:

[1] The circa 1890 painting of Thomas Cotters Homestead in Silverstream by Christopher Aubrey shows a cottage behind the main homestead. Descendants of Thomas state that this cottage was moved to the opposite side of the road. Another circa 1890 painting of Silverstream by Christopher Aubrey show the railways line (opened 1876) and Whirinaki church (built 1859) but Pumpkin cottage does not appear in the painting on the opposite side of the road in Silverstream.

[2] Chief Te Kaeaea died in 1871 before the railway line was established. So if the cottage was used by the chief it was on the land owned and occupied by Thomas Cotter and previously his father Pierce Cotter.

#### Comments:

[1] Perhaps Thomas Cotter (1847-1889) built and lived in Pumpkin cottage behind the homestead before his parents moved to the Wairarapa around then perhaps Thomas and his family moved into the Cotter homestead.

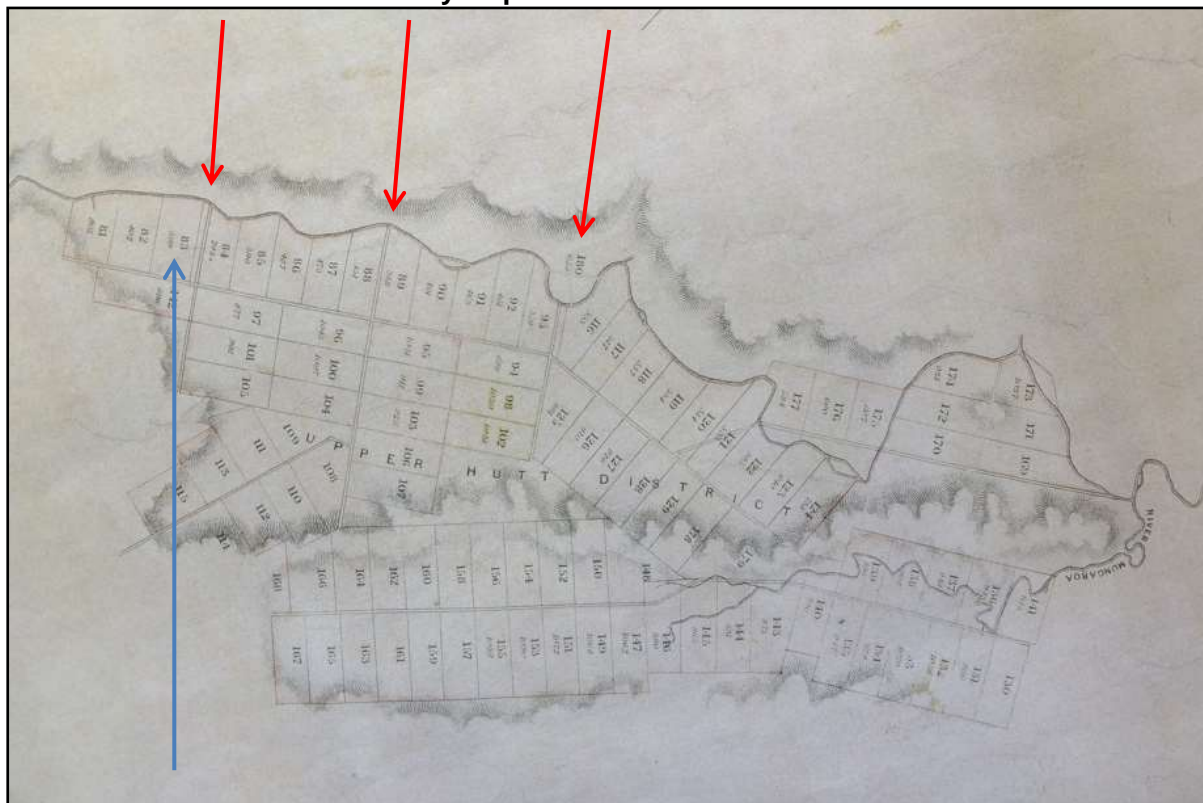
[2] Why would the chief stay in the cottage behind the Cotter homestead when the Native Reserve was situated on Section No 84 next to the Cotters land. On the opposite side of the road of the Whirinaki Church were two whares. In 1871 when Te Kaeaea was injured in the gorge we know he was taken back to Silverstream where he died. Perhaps the Chief was taken to the nearest dwelling which could have been pumpkin cottage behind Cotter homestead and this is why people say it was Te Kaeaea's whare.

[1] Who built Pumpkin cottage and when did they shift the cottage to the other side of the road?

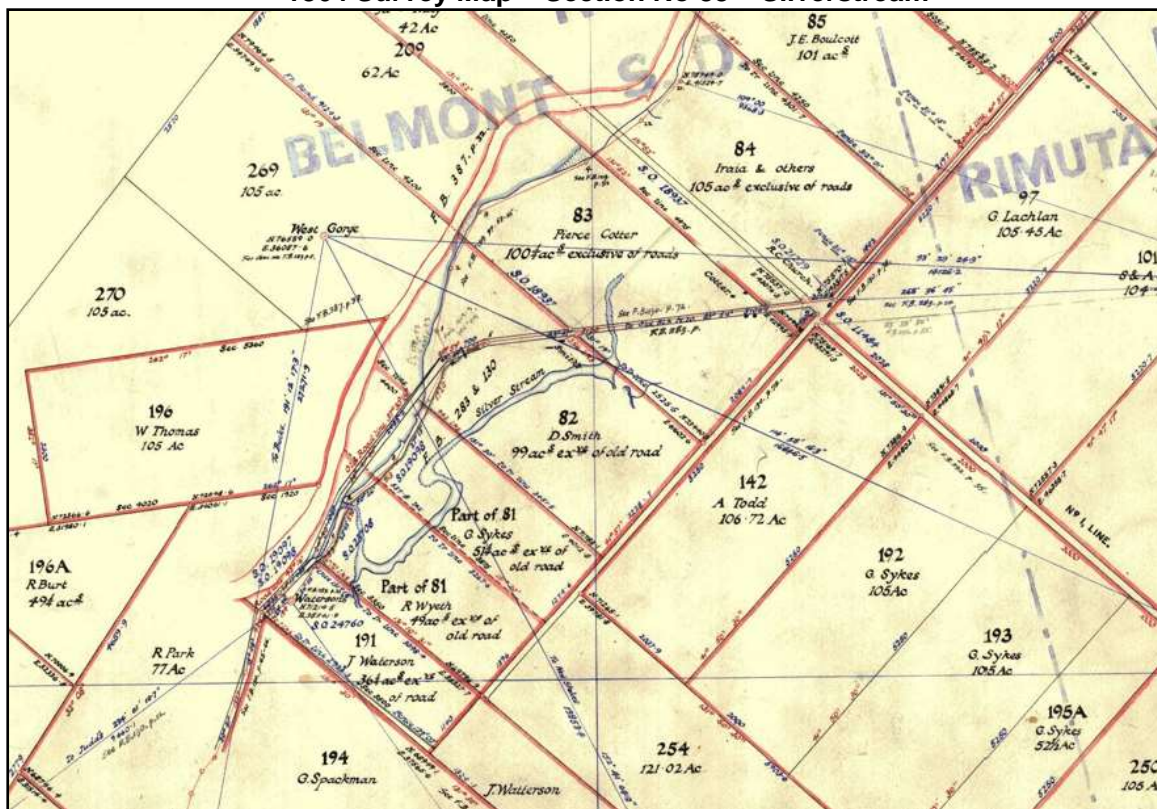

Tuesday 16<sup>th</sup> May Sale by Auction of Six Splendid Sections at Silver Stream beautifully situated close to Railway Station only 15 miles from the City. Mr R J Duncan has received instructions from Mr Thomas Cotter to sell by public auction at his sale rooms on Tuesday, 16th May at 2 o'clock 6 sections land on the main line of road from Wellington to Masterton adjoining the Railway Station admirably adapted for private residences for gentlemen or tradesmen anxious to possess a freehold in a charming part of the country yet within access of town by coach or rail. Although near the Hutt River and Silver Stream the property has never been flooded. The following are the actual measurements of each allotment viz.

No 1 (corner section) 150 links to main trunk road to Wellington by a frontage street of 100 links to road to station by a depth of 162 links. This lot is recommended for the erection of an hotel there being no public house within 6 or 7 miles and when built would supply a want long felt by the travelling public and residents of the district.

No 2 100½ links to road to station by a depth of 174 links.

No 3 100½ links frontage to road by a depth of 186 links.

No 4 100½ links frontage by a depth of 198 links.

No 5 92 links frontage by a depth of 206 links.

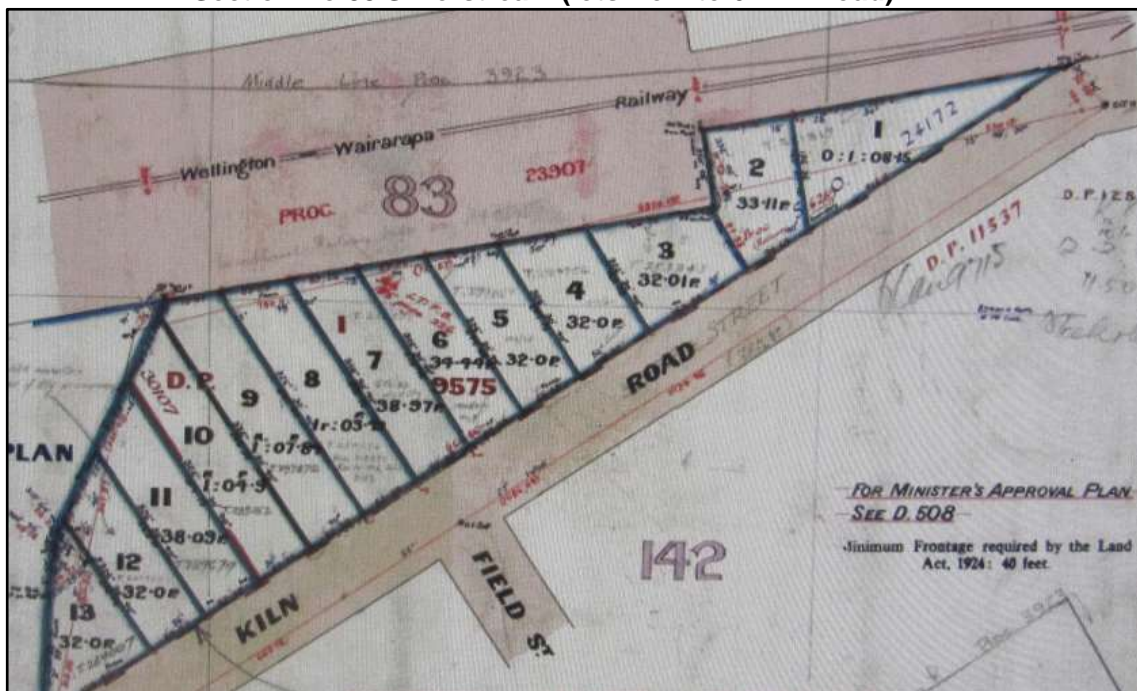
No 6 103 links frontage next to Railway Station by a frontage to railway of 158 links.

## 1890-1900

### Silverstream circa 1890s – Christopher Aubrey Painting

The railway line between Wellington and Silverstream was opened in 1876. The painting shows the Cotters homestead first on left of the road, followed by the Whirinaki church on the same side. Pumpkin Cottage had not been relocated from behind Cotter homestead to the opposite side of the road. I believe this painting is earlier than circa 1890s.

### Thomas Cotter Homestead circa 1890s – C Aubrey Painting

“The painting shows a view of a farmstead and outbuildings, on the higher side of the road in the foreground. A child supervises two cows entering a farm gateway through the mud, for milking, while two other cows await them near a shed. There is a formal garden in front of the house, and the trees around the homestead are pint and yew or cypress. The background hills are partially covered in bush. The small cottage immediately to the right of the main house is probable the one that later became “Pumpkin Cottage” the centre for a group of artists”.

Thomas COTTER died on 24 May 1889 at his Silverstream residence in Silverstream Upper Hutt New Zealand. The trustee of his will was Charles SEAGAR.

Charles SEAGAR resided in the neighbourhood of Thomas COTTER in Silverstream. When Thomas’s wife Susan died in 1877 he remarried in 1879 to Emma Ann nee HAYBITTLE. When Charles’s wife Frances died in 1909 he remarried in 1911 to Wilhelmina nee HAYBITTLE. Wilhelmina and Emma HAYBITTLE were sisters.

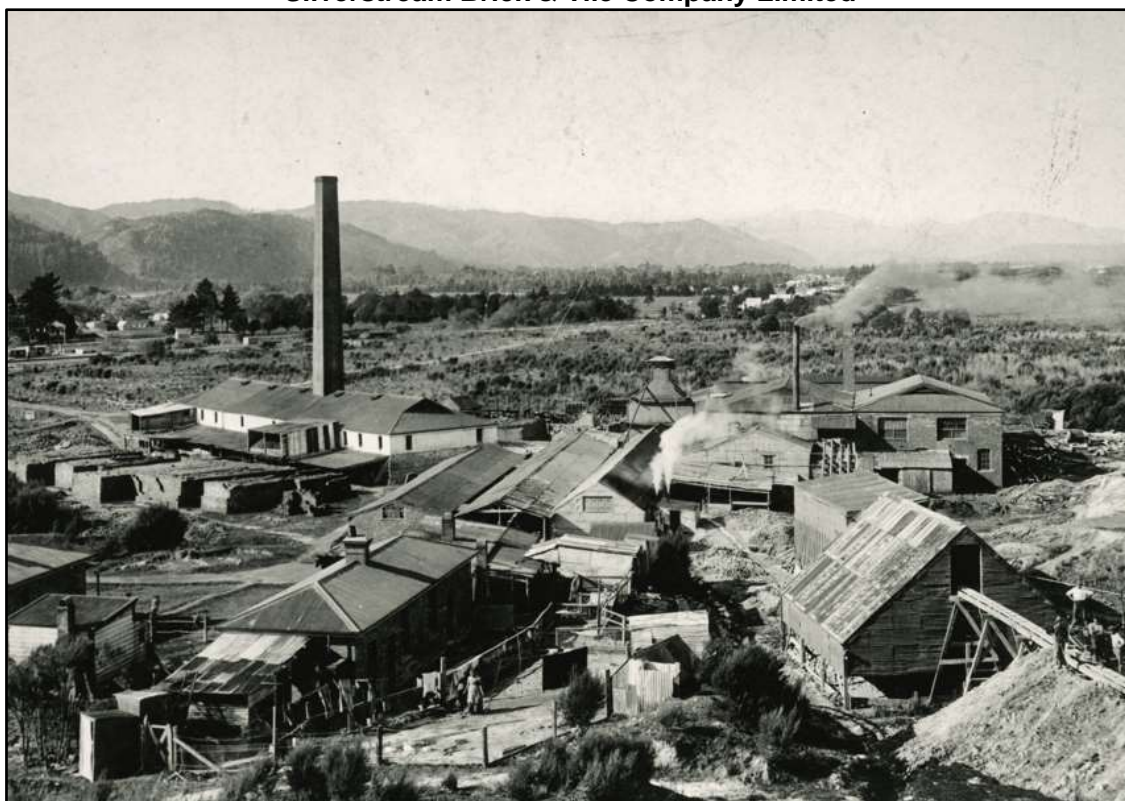

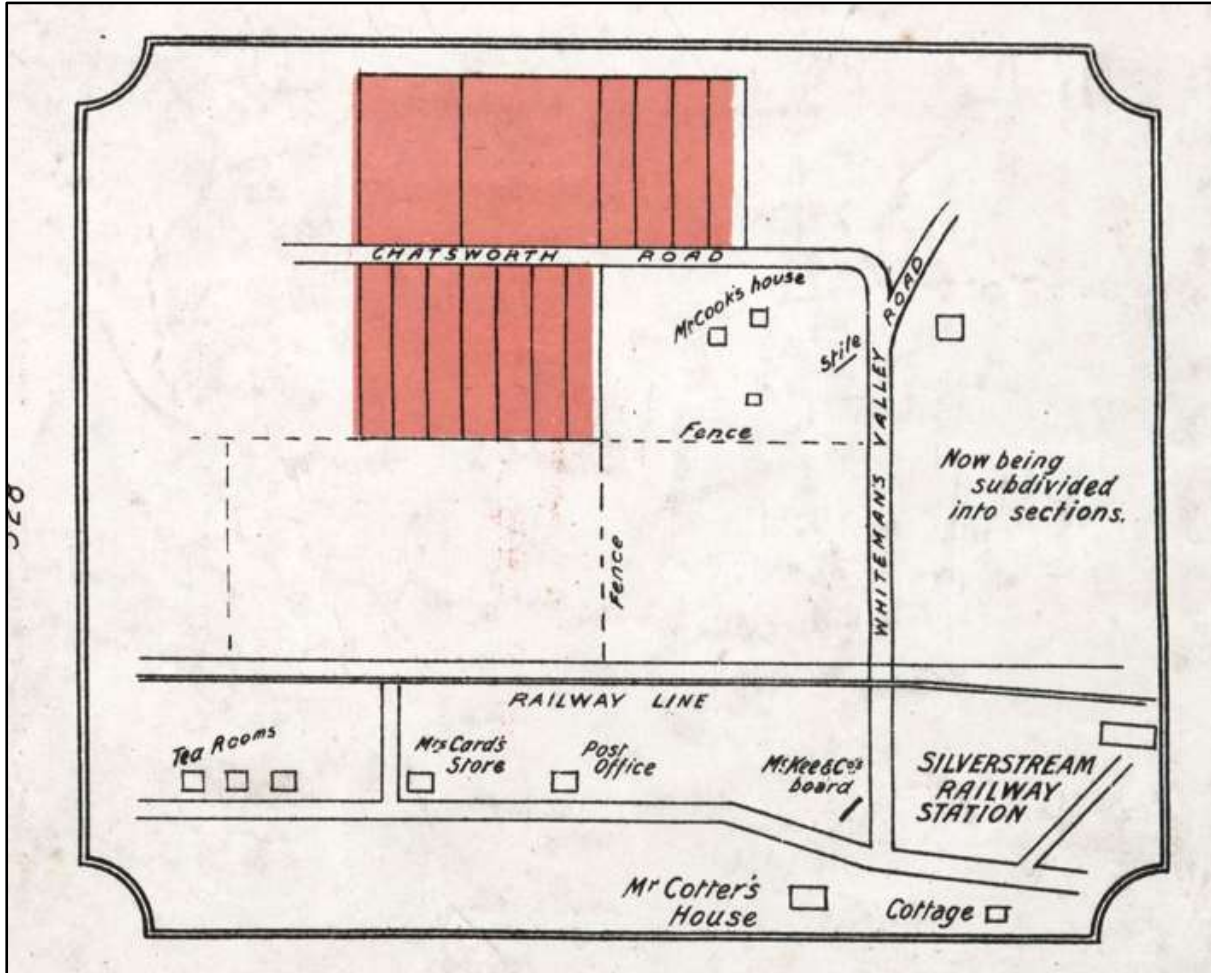

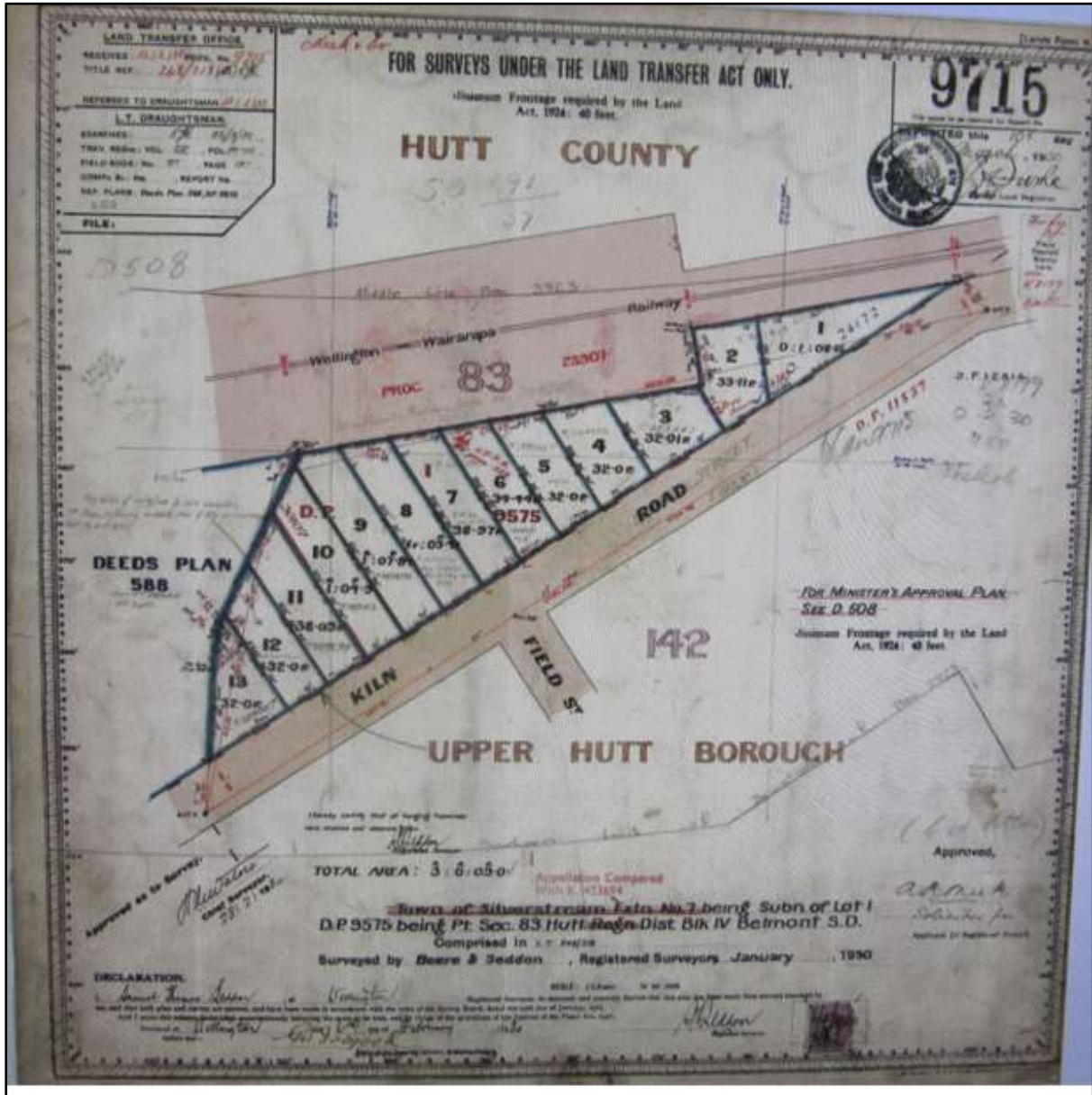

A feature of the progress of this College in recent years has been a remarkable increase in the number of day scholars of whom there are now about two hundred. The contract price for the new building is £76,020. It is hoped however to proceed with the Chapel before the present contract is completed and this will mean an additional £13,000. The Chapel is to be a memorial to deceased Old Boys especially to those who gave their lives in the Great War. The site is acknowledged to be one of the finest in New Zealand. The college authorities have secured 880 acres perhaps the finest property in the Hutt Valley bounded by the Heretaunga Golf Links on the north and the beautiful Wellington City Memorial Park on the south. The buildings are being erected on a terrace near the main road in the centre of a smiling plain surrounded by low forested hills. Grounds for football cricket tennis and golf will be laid out before the end of this year.

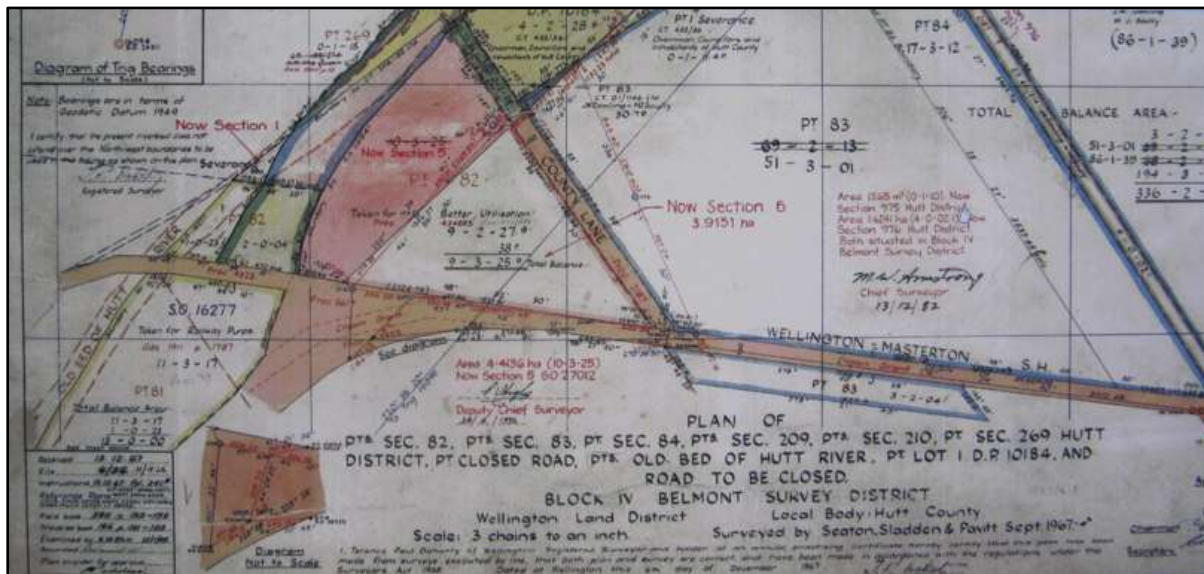
