

#### 1860s Map of Silverstream - Section No 97









Chatsworth Road is public and is 66 feet wide. Pengsey Pemysey, Marlborough and Gloucester Roads are now new and are 66 feet wide. The lots with the exception of 14, 15, 16, 29, 69 and 70 are laid off at right angles to the roads and all the lots are of good proportion. Please not Lot 80 contains s3.3r.13.3p which area is in excess of that allowed by the Regulation but the inclusion of that lot adds to the compactness of the scheme. The name of the Town is I think appropriate as it lies close to the Stream and Railway Station of that name. See accompanying tracing of locality. Under the circumstances enumerated above I have to recommend the plan be submitted to the Governor for his approval as required by the above mentions section of the Land Act.

- 12 Panama Street from Frank E Willis to Chief Surveyor Plan of Town of Silverstream Mr Hanify Surveyor has handed me your communication of the 18<sup>th</sup> April and I have interviewed Mr Gard the owner of the property comprised in the plan from which the Surveyor General has withheld the Governor's approval. I wish to state that Mr Client Mr Gard has made several unsuccessful attempts to obtain from the adjoining owner of the link strip a

contribution towards the cost of formation of that portion of Gloucester Road abutting the strip. He first approached this adjoining owner before the subdivision was actually made and has since done so after being notified of the refusal to approve but can come to no arrangement with his neighbour. Before making this subdivision by client was obliged to purchase the allotment of which this strip forms part in order to comply with the condition which require that a new subdivision must be connected with an existing road or Street my client having only a Railway Crossing to connect with the main road therefore could not subdivide his land without buying a piece of land to give him access to Chatsworth Road. By refusing to approve this plan In its present from my client will suffer great hardship and in justice as he will have to bear the total cost of forming and dedicating a road which is the street is deleted can immediately on dedication be used by the adjoining owner for subdivision purposes although such adjoining owner has had every opportunity of taking advantage of this road on payment of a small sum of money towards the costs of formation. I therefore on behalf of Mr Gard request that the Governor's approval be no longer withheld and am instructed that as the question of public interest is not involved at all to insist on the plan being approved otherwise my instructions are to proceed further with the matter. I return the plan herewith.

St Mary's Church is situated at 13 Terminus Street on Part Section No 97. The section lot once covered the corner of Terminus Street and Gloucester Street in Silverstream.

Part of Section No 97 consisting of 4 acres (1.6 hectares) of land was purchased from Mr G W Gard in 1919. The first St Mary the Virgin was built in 1931 for £600.

St Mary's church in Silverstream was originally mooted at a meeting on 08 November 1819 but construction was delayed by the difficulties of raising funds and the building was not completed until March 1931.

Other information recorded that St Mary's Church was built in 1928 not 1931.

St Mary's Church was built and opened in 1930-1931 then demolished in December 1978 to make way for a new church building which was opened 08 July 1979.

Further research on St Mary's church and land will be done when time permits.



Mr McKenzie met with an accident when young which compelled him to travel through life on one leg but notwithstanding this he had a shrewd indomitable disposition that led him to fortune. He arrived in Wellington in 1851 and for several years carried on the business of a storekeeper at the Hutt. Thence he removed to Taratahi where he purchased a farm and for the last twelve years he has been sheep farming at Woodlands. About a fortnight ago he was seized with pains in his stomach and early on Tuesday morning he breathed his last at the ripe old age of 75.
