The family history of Peter Jamieson BELL (SLOAN / SLOWAN) and Elizabeth Sarah MURLEY

Peter Jamieson BELL was born about 11 March 1841 Stirling Scotland. This is according to information written in a family bible.

The family story tells of Peter's mother a widow Elizabeth JAMIESON from Stirling Scotland arrived in Nelson with 2 small boys Peter and Alex. She was frightened by an earthquake and moved to Dunedin working as a mid wife. In Dunedin she met and married a man named BELL and had 3 more children then later the family immigrated to Canada.

Parts of the family story are correct but some is not quite right. Information about his mother and father and stepfather can be found in the document named "BE Jamieson Sloan Bell 1836 Scotland 1849 Australia chart 34-35".

Peter was actually Peter SLOAN / SLOWAN and was born in Australia. His parents were Jessie formerly JAMIESON and Patrick SLOAN / SLOWAN who were married on 08 May 1836 in Stirling Scotland. Peter's sister Janet was born about 1837 in Scotland. Jessie, Patrick and Janet SLOAN /SLOANE left London England on 01 August 1838 on the ship "SS Lloyds" and arrived in Adelaide Australia on 01 December 1838.

Peter and his brother Alexander (born between 1843-1845) were both born in Australia. There was another brother William who was born 05 April 1846 and died 14 June 1846 at Adelaide South Australia. We have been unable to locate any information about what happened to their father Patrick.

Peter's mother Jessie JAMIESON married Neil BELL on 31 March 1849 at Geelong Victoria Australia. While in Geelong Jessie and Neil BELL had 3 children, Christina born about December 1849, Angus born about 1852 and Jessie born about 05 October 1854. Their son Angus died in 1852 age 1 in Geelong Victoria Australia.

According to letters that Peter wrote when making an application for the New Zealand War Medal he stated that he arrived in New Zealand from Australia on the Schooner "Marchioness". This was the clue to locating the information below.

The family left Melbourne Australia on 15 December 1854 as steerage passengers on the "Marchioness". Port of arrived in New Zealand was Nelson/Wellington. The Country they came from was recorded as United Kingdom.

The ship "Alexander" left Melbourne Australia on 9th December 6 days before the "Marchioness" and both had their destination listed Nelson/Wellington.

Peter's older sister Janet SLOAN did not come to New Zealand with the BELL family but stayed in Australia with her husband John WILSON.

The BELL family settled in Nelson in December 1854. While there, the family was frightened by the 23 January 1855 earthquake that killed five people, so the family decided to packed up and move to Dunedin. The earthquake estimated to measure 8.1 shook both islands and was felt on ships more than 200 km off the coast. It was one of New Zealand's worst earthquakes and caused faulting and uplifting of the land. There were many after shocks. Brick buildings were destroyed in Wellington and the Wairarapa area and the roads leading out of Wellington were blocked.

The earthquake was felt in Nelson. Six months after the quake the family secured a berth on the "Gazelle" a brig, which arrived in Dunedin from Wellington on 26 July 1855. They settled approximately 6 kms from Dunedin City on the Otago Peninsular, Upper Harbour East side on a property called "The Hermitage". I believe the property was near Portabella opposite Port Chalmers.

Peter's mother practised her profession as midwife rowing a boat around the bays to settler's homes when needed.

The Rev Thomas Burns visiting book 1848-1865 makes mention of visiting the Bell family in November 1855.

In 1861 gold was discovered in New Zealand. The family may have heard from the miners about land becoming available in Cowichan on Vancouver Island in Canada. The BELL family made arrangements to leave New Zealand and took a long sea voyage to Canada. At the time Jess was age 44, with an invalid husband and five children the oldest being 10 years and the youngest a baby.

The family travelled to USA and then on to Canada then made the voyage to Cowichan on the "Hecate" in August 1862. The family were taken up the creek in canoes by the Indians to Somenos where their first log cabin was built. It had an earth floor, no windows, and an open fire construction of clay and rock and pine bough beds.

Peter Jamieson BELL and his brother Alexander (Alex) BELL both remained in New Zealand. Peter's older married sister Janet WILSON had remained in Australia with her husband and family. Slowly the family were scattering themselves to various places around the world.

According to letters Peter wrote when making an application for the New Zealand War Medal he stated that around 1863 he was a Gold Miner living in Lake Wakatipu Queenstown.

Peter enlisted on 04 September 1863 in Queenstown and served in the New Zealand Wars. He travelled North on the "Auckland". Later correspondence from Peter to the Government records his service during the New Zealand War period.

Gentlemen

I am in receipt of your reply of April 10th 1913 in reference to my claim for a Maori War Pension & Medal in which you state that you were unable to grant same as your records state that I was a deserter. I think the authorities must be under a misapprehension as to that statement for I was no such deserter. Perhaps if I shape the circumstances under which I joined & served it may enlighten you a little.

In 1863 I was at Queenstown Lake Wakatipu & whilst there I saw a notice wanting men for the Maori War. I went to Captain Anderson the recruiting officer in charge & I offered to join. He required volunteers for the militia & I stated to him I was prepared to join as a Naval Brigade man & only under that condition. I was accepted as a Naval Brigadier & sworn in as such. I received a signed paper from him stating that I was a Naval Brigade man. I then went to Auckland & was marched to Ohahau [sic] & was drilled there for a week or 10 days & then a company of us were drafted to join the 2nd Regiment No 9 Company Waikato Militia. I objected to this as I had not joined for any Militia being a Naval Brigade Man. Several other men objected at the same time in consequence we were put under arrest & sent to guard room. The following morning we were brought before Colonel Haulthain Commanding officer & the articles of war read out to us. He told us that if Martial Law had been proclaimed we were liable to be shot, and we were sent back to the guardroom again. The next morning we were again brought before the Colonel the articles of War again read to us. So I stepped out of the ranks & said, "Excuse me Colonel I have a written document from Captain Anderson Queenstown showing that I joined the Naval Brigade ¬ the Militia. The Colonel then ordered the Sergeant Major to see us to our huts & he said he would see what he could do for us. In a day or two we were told off to go to Onehunga to get the Boat "Pioneer on Waikato" ready for action putting shot & shell in her ready for going up the river. This took us

about 11 or 12 days when we were finished we were called aft & told we were not worked [sic] anymore. Then the Captain of the boat told us we would have to go ashore & march back to Ohahau, when we got there we were ordered to march to Galloway Redoubt & join Number Nine Company Second Waikato. Martial Law then had in the meantime been proclaimed. We went on then to Papakura eleven of us all told Naval Brigade men we then at Papakura caught up with the Second Waikato. We then marched to Riki Riki? [sic] (Kirikiri) Redoubt for a time to intercept the Wairoa Natives from swooping down on Auckland. We had many a skirmish round Reri Reri [sic] (Kirikiri) & many a night I volunteered with Captain Ring reconnoitring round Reri Reri [sic] (Kirikiri). After this we were taken to Raglan & camped there for a time & then went to Popatuna [sic] & also camped there for a time & then moved on to Waihatuna [sic] & there I was attached to No 8 Company Transport Corps.

My next camp was Te Rori where the Commissariat Transport Corps formed their headquarters. It was also General Cameron's headquarters. We took Pah Te Rangi & then General Cameron & all his forces captures Te Awamutu. The Commissariat Corps followed close on. Captain Pye our commanding officer formed his headquarters at Te Awamutu where I was made corporal for my diligence &my attention to duty. Myself & sergeant Sunnaway (Sunerway Edmund Darvil Private AD32/536 medal reject for desertion) we had daily to turn out ten to twenty teams of bullocks & twenty to thirty teams of horses so we had no easy time of it. After a fine Orako was fought. There myself & five others were told off to take provisions to the front of the Pah where the fighting was going on. That was about the end of the war. A short time after I was sent as Corporal in Charge of two teams of bullocks & four then to Rangihake Redoubt for dragging out logs & carting timber from the mill for building purpose for the troops. We then moved head quarters back to Te Rori. We were there doing nothing for months. I was doing nothing for months but riding about the country looking for stray horses & cattle. They told me the Military Settlers No 9 Company 2nd Waikato were going to draw their land so I went up to Alexandra & some of my chums told me my land was located with the Naval Brigade land & Colonel Haultain & Lieutenant Wiggin told me the same. I did not know what to do to find my land so I went down to Penrose, which was then the Headquarters of Transport Corps. They knew nothing there about myself or my land. I stayed there for a time to see if I could get any information & could not & then gave it up for a bad job. My money was running short so I thought rather than spare I had better get out of the Island. In those days to secure my discharge. (The war was then over) it would have been necessary for me to go from Penrose back to Alexandra (Alexandra Redoubt over Waikato river) & Te Rore a distance of 100 odd miles over rough unroaded maiden bush & as the war was over I saw no necessity & also having no funds to spare I id not get my discharge. I think gentlemen as I did my duty & all the service I was required to do & that conscientiously I was also wounded & was in Ohahau hospital for about eight weeks & did not receive any recompense & as there was a grant of 50 acres of lands for service which I was supposed to get & did not and also was also forced to serve in the Militia which I did not join for surely gentlemen my age being 73 I think it is only just & right that I should get my just dues: Your further consideration of my claim for a pension & medal will oblige.

Family legend has it that during the NZ Wars Peter was on guard when he heard a rustling in the bush, he yelled out to call the troops and a pig rushed out of the trees ran between his legs and gored him. Peter mentioned in his correspondence that he was injured during the New Zealand Wars. I wonder if this was the injury.

Work was very hard to find and Peter used to go travelling around looking for work. He began as a sawyer (pit) progressing to a saw filer (saw doctor today). He was a saw filer at the sawmill in Pareora Bush in Canterbury when a run holder lit a fire to burn tussock which accidently burnt down the mill around 1868. Peter stated that his discharge papers where lost in the fire.

Peter's intention to marry application in 1871 stated that he had dwelled in Timaru for 4 years. This meant that he was living in Timaru around 1867.

Elizabeth Sarah MURLEY was born 1847 in Poplar Middlesex England. Her parents were Rebecca formerly OLIVER William Walker MURLEY.

Peter was 5 feet 6inches tall and immensely powerful. He frequently played wrestling with his sons and until to age of 68 (about 1910) he was unbeaten in the art of

Cumberland wrestling at the Timaru Highland Games every year. The first South Canterbury Caledonian Sports were held at the A & P Grounds, Timaru on New Years Day 1876 and according to the large article in the Timaru Herald was one of the most successful events that had ever taken place on the district. Peter BELL was a judge for many of the events including Cumberland Wrestling. Presumably he started wrestling after this date.

Peter lived at 45 Theodocia Street Timaru before he died in 1917

Peter Jamieson BELL aged 75 years born Stirling Scotland occupation Billiard Marker died on 08 February 1917 in Timaru Hospital. He was buried on 10th February at Timaru Cemetery by Methodist minister Rev J A Boughen. Cause of death was recorded as Myocardial degeneration as certified by H.B. This pioneer was a shipwright and he arrived in NZ with his family around 1858 and lived in Lyttelton, Christchurch and Timaru.

James and his family lived at 118 Waipapa Road Haitaitai and they donated the land next to their house to the Council for use as a park. James was a very keen hunter and fisherman and built a cottage in Akatarawa by Baigent's mill as a hunting lodge. This first cottage was washed away in a flood. The second house was a riverstone cottage near Price's Mill at 144 Akatarawa Road Birchville with a garden of 4 acres and 2 full time gardeners. Here James indulged in his passion for gardening. "The property was surrounded by a Barberry hedge which was terrible to cut every year. The thorns were long and someone would get one in their foot every year, which had to be removed by a Doctor. They even went through gumboots". James was vice-president of the Rose Society, the Horticultural Society and the Beautifying Society and was regarded as a leading authority on horticulture. He used to grow and show daffodil bulbs and breed new roses. It took five years to develop new bulb and one occasion he had spent the five years on a new bulb when just before he was due to show it the whole plot was dug up and stolen. He apparently had a sideboard full of cups he had won for bulbs and roses. After his bulbs were stolen he donated a lot of bulbs to the Remembrance Gardens at the Botanical Gardens in Wellington. On a trip around the world he bought back many Rhododendrons from China. James organised the planting of native plants along the Hutt Road. The family used to go on many camping holidays with Bell's family. He took a keen interest in all Civic matters and was a foundation member of the Wellington Ratepayers Association. He was also a member of the Masonic Lodge (Leinster) and was a foundation member of the Haitaitai Bowling Club where there is a cup named after him. James made a lot of money-making uniforms during the 1st and 2nd World War. He sold the business after the 1st World War but the new owner went bankrupt during 2nd World War. He sold the business after the 1st World War but the new owner went bankrupt during the depre4ssion and he had to take it over again. Ian inherited the business.

I am trying to find out the dates my great grandparents arrived in Dunedin. Mr great grandmother was a widow named Jamieson from Stirling Scotland. We know she was a mid-wife with two small boys, Peter & Alex. She used to row around the Bays in Dunedin, delivering babies. I think her Christian name was Elizabeth. 1) One story I heard was that they landed in Nelson first but were frightened by an earthquake & moved to Dunedin. I doubt the story. We know she remarried a man named BELL had three more children before immigrating to Canada where she was the first woman to walk the trail from Cowiechar to Dunean's BC.

The other grandparents William & Rebecca MURLEY arrived on the ship Sarah M, also in Dunedin, with a son, name unknown, another daughter name unknown, & my grandmother Elizabeth age fifteen. William MURLEY & the son were shipwrights they later moved to Timaru where they made lighters for immigrant ships. I have a Victorian letter writer inscribed E. Murley, Blackwall, Upper Harbour, Otago. The letter examples are dates 185-, I think it could be about 1856 as my grandmother was either 83 or 84 when she died in 1928 or 9. The Murley family came from London.

Could you please advise me as whether the General Registry Office Kingsway London would have Rebecca MURLEY (nee OLIVE's) birth recorded she was born 13 may 1814. I seem to remember reading that Somerset house records only went back to 1830? I would like to know if possible whether East India Company records are kept also Naval records, as Rebecca MURLEY's father was a Captain in the East India Company & was on the HMS Minotaur during the Battle of the Nile in 1798. A cousin has the medal struck to commemorate the event.

My mother told me that her father was one of Von Tempsky's Rangers, he was wounded during the Maori Wars the bullet passed through his middle from front to back, could you tell me where I would find records of that, his name was Peter Jamieson BELL. Hoping you will be able to advise me on these subjects.
