The family history of Thomas BOYLE and Georgina MILES

Thomas BOYLE junior, the third son of Ellen nee FANNING and Thomas BOYLE, was born about 1843 in Ireland.

When Thomas left Ireland with his parents in 1847 the passenger list did not record his age only that there were 3 male children under the age of 10. The family embarked on the ship "Sir Robert Sale" at Cork on 30th June 1847 and the ship set sail on 4 July 1847.

The BOYLE children became sick and spent some time in the ship's hospital. The Medical and Surgical Journal of the ship "Sir Robert Sale" records details of passengers who spent time in the ships Hospital. Thomas junior would have been 4 years old at the time but is recorded as 4 and 5 years old.

The "Sir Robert Sale" arrived in Auckland on 11th October 1847 without having touched at any intermediate port on the journey to New Zealand. Life must have been tough for Thomas junior when he lost his mother on 14 October 1847 just a few days after the family arrived in Auckland.

Thomas his father and siblings left the "Sir Robert Sale" and boarded the Brig Victoria, which took them all to the fencible village of Howick where the family settled.

A Census of the Parish of Pensioners Villages was taken in 1849. Thomas BOYLE and his children are detailed as follows.

Thomas junior must have attended school in Howick New Zealand and learnt to write as I have found his signature on many documents.

Thomas junior was about 10 years old when his father Thomas BOYLE married on 7 July 1853 at Howick to Frances FLANNAGAN.

Inquiry into the Wreck of Scooner HOPE

An inquiry at the Customs house yesterdayI was last at Opotiki and bound for Mercury Bay.......the vessel belonged to my father Thomas Black......was caused by an error in my calculation and by the exceeding darkness of the night.

Thomas Boyle a seaman of the Hope deposed. "I have heard the statement made by the last witness and it is quite correct.

TRANSCRIBE complete document (Reference National Library NZ Paperspast Daily Southern Cross Volume XXIII Issue 3242 6 December 1867 page 2)

Gold was discovered in Thames and the Warden Court registers record information about Thomas BOYLE interest in the claim named "Bank of Ireland". Our Thomas would have been about of 25 years old at this time. I am not sure if this is our Thomas.

On 2 June 1868 the claim No 46 named "Bank of Ireland" was registered. This claim was bounded on the north by the "Victoria Cross" claim on the south by the "Young Colonial" claim on the east by the "City of Melbourne" and claim on the west by "Lough Erine" [sic]. The total size of the claim was about 7 men's ground. Also noted was locality Karaka block Waiotah.

Wardens Court - Daily Southern Cross 13 November 1868

Joseph Matton: I am a miner. Know the Golden Star. Brown had a full share in that claim. He sold three-quarters of his share to Boyle. At the present Boyle is in the possession of the share. Brown never held more than one share. I never claimed that share. I never held any interest in the claim other than that mentioned in the registration. By Mr Macdonald: I spoke to Johnstone about the share. I said I would not allow him to work because he had no interest these. By having no interest I mean that Boyle's share was represented.

John Fletcher: I know the Golden Star Claim. Mr Boyle is working the share in question. Since 1st September it has been in his possession. I believe Mr Brown sold three or four shares in the claim. Can't say which of the two shares Brown sold is being worked by Boyle. Brown first claimed two shares since this action commenced.

Thomas Boyle: I know the Golden Star Claim I have an interest in that claim. I bought an interest from Harry Mann. He bought his interest from a man name Brown. On the 28th August I bought in.

Coroners Inquest 9 August 1870

Thomas Boyle was a witness in a coroners enquiry into the body of John Winder who was found floating in the river. Thomas Boyle the packer mentioned by the last witness deposed to having been at the brother camp on the day in question and bought some gum of them. He was accompanied by another packer named Knoops. They stared for the town and with them the deceased who kept by them until Kirikiri settlement was reached. He dropped behind but sis not seem to be tired neither was there any peculiarity in his manner or appearance. This was the last witness saw of him. The jury returned a verdict of "Accidentally drowned".

There was a bankruptcy for a Thomas Boyle at Westland Hokitika of Waimea Miner. I believe this could not have been our Thomas.

West Coast Times newspaper 12 February 1878

Recorded a Thomas Boyle alias Michael Cain and Duncan Cruikshank. Another article records Miners rights for Thomas Boyle No 21976 Waimea December 2 1877. Makes researching our Thomas very interesting as there was also a Thomas Boyle at some time in Christchurch. This could also be the same Westcoast Thomas. I believe this could not be our Thomas.

There was an article in the Daily Southern Cross newspaper 29 December 1875 stating that a Thomas Boyle was married to a Bridget Boyle. They invited James Lambert to spend Christmas with them. I believe this could not have been our Thomas.

The 1876 Intention to marry application recorded Thomas BOYLE age 30 years and Georgina 26 years. It also recorded that Thomas had resided in Te Aute for 5 years and Georgina for 2 years. Place where the marriage was to be solemnised was recorded as "In the Church Te Aute". The Officiating minister was Church of England Rev Samuel William.

Thomas BOYLE, occupation Labourer, married Georgina MILES on 31 May 1876 at Te Aute. The Officiating Minister Sam WILLIAMS took the service. The witnesses were John PETTIL (sic), a Hotel Keeper, of Te Aute and John SUTHERLAND a labourer, of Te Aute.

Thomas and Georgina has a son, Thomas Charles BOYLE, who was born on 16 May 1877 at Napier. Father was recorded as Thomas BOYLE, a Labourer age 34 years, born Auckland, New Zealand. Mother's details were Georgina BOYLE formerly MILES, age 25 years, born London, England. The parent's marriage was recorded as 31 May 1876 at Te Aute, Hawkes Bay. Georgina BOYLE, the Mother, of Napier, registered the birth on 9 June 1871.

Although the father Thomas BOYLE was born in Ireland he spent all his early childhood in Auckland so this may be why his wife gave the birth details as Auckland but the age matches our Thomas BOYLE details.

Thomas's wife, Georgina BOYLE nee MILES was aged 26 years when she died on the 9 July 1878 at Waipawa. Cause of death was recorded as Phthisis. Georgina's parents were recorded as Georgina and Charles MILES, occupation Piano Maker. Georgina was recorded as born in London and had resided in New Zealand for 4 years making her arrival in New Zealand around 1874. Her husband was recorded as Thomas BOYLE and living issue 1 male but no age. The informant on the death registration was T BOYLE husband of Waipawa. The Church of England Minister, J C ECCLES, buried Georgina on 11 July 1878 at Waipawa.

Thomas BOYLE religion was Roman Catholic, but a Church of England Minister married him, and a Church of England Minister buried his wife Georgina.

Thomas BOYLE was living in Awhitu around 1880 as he was the informant on Ellen BOYLE his sister-in-laws death registration. She died on 15 November 1880 and was the wife of Edward BOYLE Thomas's oldest brother. The registration, dated 18 November 1880 recorded Thomas BOYLE, brother-in-law from Awhitu. He could have been just visiting his brother in Auckland at that time. (Reference RGO NZ death registration 1880 folio 1497 Auckland)

Thomas BOYLE, occupation labourer, aged 70 years died on 9 April 1912 at Opotiki. The cause of death was Heart failure and Pneumonia. The informant on the registration was A ANDERSON, Undertaker who conducted Funeral of Opotiki. "Not Known" was recorded for parents, wife and living issue. The Presbyterian Church Minister, R FRANCIS, buried Thomas BOYLE on the 11 April 1912 at Opotiki. (Reference RGO NZ death registration 1912 Folio 883 Opotiki)
