A Raglan Magistrate letter of reply from R O Stewart includes information that he requested Charles De Thierry to amend the account. There were 2 cases Graham V De Thierry in which he paid the costs and De Thierry V Graham in which he paid the costs. When Charles wrote out the bill he included costs from both court cases including wages for witnesses which included Wetini (female) and C de Thierry Junr but they were not material witnesses. Mr Stewart thought it possible that this was a mistake by Charles De Thierry. It was also noted that Charles employed his own son as a constable charging for his services without the knowledge of Mr Stewart. "I told Mr De Thierry that it was exceedingly bad taste in him as Clerk of the Court in a case where he was a party to charge for his son's service of subpoenas and I think that his whole conduct in the transaction has been exceedingly reprehensible. I have already written to the Commissioner Mackey on this matter"

The son leaves a widow in Auckland and several members of his family reside in the Auckland district. His age was 82 years.
