The last named wh, it seem, was pretty deeply involved in the matter managed to get off. On the 6th of September a session of the Native Circuit Court was held at Kauaeranga Mr Mackay presiding assisted by three native assessors Haora Tipa, Taniwha Kita, and Wirope Hotereni Taipari (Hauauru). The jury was composed of six Europeans and six natives, Mr Douglas acting as foreman De Thierry and Priestley were charged with transporting arms without a license. The principal witnesses were Mr Guilding, and a native policeman named Tirarua. It has been shown during the course of the trial that two of the guns belonged to De Thierry and that he possessed a license for them. It was also shown that he knew nothing whatever of the arms being concealed in the vessel stated that he had taken the arms down for a party of friends that he had expected from Auckland. No licenses could be produced by him. The guns seized are of various kinds, and it may be stated as rather a curious circumstance that one of them is a Government rifle. The number on the butt has been filed out but it still remains on the ramrod. The jury unanimously found Priestley guilty, but acquitted De Thierry. At about noon today, Henry Everett, master of Mr Bettis fishing boat Louisa, reported to the police that at day break this morning the Louisa was aground on the mud flat about three miles from the mouth of the Piako river, and he and his mate, a lad named Cavanagh, noticed a vessel lying on its side about half a mile from where the Louisa was lying. As soon as the tide rose far enough to permit of them getting away, they made sail to the capsized boat, which they sailed round and found her to be the Columbia. She was in about four feet of water, and the main sail and jib were set, her appearance indicating that she had been caught in a squall and suddenly capsized. The dingey, which was attached by a painter to the boat, was swamped; and, jammed between the throat halliards and the mast, they saw a man's leg. The body was under water, lying in the bight of the sail. They did not attempt to secure the body but returned to Shortland and reported to the police. Mr Bullen dispatched Constable Hogan and some men in the harbor master's boat to search for the bodies, and at 2 o'clock today the Buona Ventura was getting up steam to proceed to the scene of the accident. All three men are married, and leave families.

At about noon today Henry Everett master of Mr Bettis fishing boat Louisa reported to the police that at day break this morning the Louisa was aground on the mud flat about three miles from the mouth of the Piako river and he and his mate a lad named Cavanagh noticed a vessel lying on its side about half a mile from where the Louisa was lying. As soon as the tide rose far enough to permit of them getting away they made sail to the capsized boat which they sailed round and found her to be the Columbia. She was in about four feet of water and the main sail and jib were set, her appearance indicating that she had been caught in a squall and suddenly capsized. The dingey, which was attached by a painter to the boat was swamped and jammed between the throat halliards and the mast they saw a man's leg. The body was under water lying in the bight of the sail. They did not attempt to secure the body but returned to Shortland and reported to the police. Mr Bullen dispatched Constable Hogan and some men in the harbor master's boat to search for the bodies and at 2 o'clock today the Buona Ventura was getting up steam to proceed to the scene of the accident. All three men are married and leave families.

George's body is recovered

The late boat accident finding of De Thierry's body – Notwithstanding the strenuous efforts made to recover the bodies of the victims of the late boat accident all endeavors have been in vain until yesterday when Peterson a fisherman while fishing at a spot near the mouth of the Thames River two miles from where the Colombo was found observed something like a human body on the mud bank near low water mark. On coming nearer he found it to be the body of Mr George De Thierry one of the missing men. He brought the body over to Shortland last night. Fuller particulars are given in the report of the inquest below.

The Inquest - An inquest on the body of George De Thierry a victim of the late boat accident whose body was found last night was held at the Thames Hotel Shortiand today before Mr J E. Macdonald Coroner and the following jury - Messrs J E Dodd (foreman), T R Foughy, W J. Constant, Bullock, Jennings, B Donnelly, J Guilding, H T Bowe, J Gibbons, J Morwick, E Eckenberg and H McIlhone. The Jury having been sworn proceeded to view the body, after which the following evidence was taken.

George De Thieiry junior sworn gave evidence concerning the identification of the body.

James Thompson sworn deposed I am a hotel keeper residing at Shortiand. I recollect the evening of the 06th instant. On that evening I saw Thrupp and De Thierry at my hotel. Thrupp owned a boat called the Colombo. Thrupp came in and said to De Thierry "Come out we're ready to start." The two went out and went towards the wharf. I went down to the wharf with deceased and saw a man named Benney with the other two in the boat. I waited there till they cast off. It was a fine night with scarcely a breath of wind. All three were quite sober. I supplied them with sandwiches a bottle of beer and a flask of brandy. I have seen none of them alive since and recognise the body as that' of George De Thierry.

Peter Petersen sworn deposed I am a fisherman. I was engaged fishing on the night of the accident and was fishing all night. Several other boats were also out. It was a fine night with slight squalls occasionally. I was fishing about three miles to the west of the Piako river mouth. We left Shortland about 11 o'clock that night. I know the Colombo. She was originally a fisher man's boat and was lately purchased by one Jonathan Thrupp. In my opinion she is a safe boat. At daylight in the morning whilst aground I saw something to seaward of us, and when the tide made I sailed down towards the object, which was found to be the Colombo she was under water lying on her beam ends. I could see a portion of her sails and mast underwater. The mainsail and jib were set. I did not make any further search but returned to Shortland where Harry Everett had already reported the matter to the police. On the 07th I was in the Fairy and assisted to raise up the Colombo. She had not drifted from the place I had seen her first. When we raised her we found the ballast shifted to leeward. From my knowledge of the boat the ballast was likely to shift if she was caught in a sudden squall. I do not know if any liquor was found in the boat. Since the accident I have kept a good lookout for the bodies and yesterday at low water I with the other men in the boat saw the deceased Mr Thierry close to low water mark. We found him about two miles from where the boat was found. We brought the body over to Shortland and it was taken possession of by Constable Day.

By the jury There was a slight squall at two o'clock in the morning. All the sheets were fast. Constable J W Day sworn deposed I am stationed at Shortland. I yesterday took charge of the body of deceased from the last witness and had it conveyed to where it now lies. I have searched the body and find no marks of violence. In the pockets I found a sun glass a knife a piece of pencil and an india rubber ring. The pocket were fulls of mud. I recognise the body as that of George De Thiery. I know a bottle of beer was found in the boat.

This concluded the evidence and the jury found a verdict of "Accidental death by drowning." (Reference Papers past website Thames Star 17 August 1878 page 2)

James Thompson sworn deposed lam landlord of the Thames Hotel Shortland. I recollect the evening of the 6th instant at which time I saw deceased with Thrupp but not with Benney at my hotel. Thrupp was the owner of a yacht called the Colombo. Thrupp said to Thierry Come on we are ready to start. They wanted to go across to the other side for a witness for the Land Court. Thrupp then started off towards the boat De Thierry following soon after. I went to the wharf and saw Benney sitting in the boat and before I came away the three of them were in the boat. I bid De Thierry good night and soon after I heard one of them say Let go. It was a fine night and the men were quite sober. They took some sandwiches a bottle of beer and a flask of brandy. I recognise the body as De Thierry's. It was halfpast eleven when they left my house that evening and they started soon after.

Peter Peterson sworn deposed I a fisherman and was engaged in fishing on the night of the 6th and morning of the 7th instant. I was in company with several other fishermen. I left Shortland about 11 o'clock pm and dropped anchor at the west side of the Piako river next morning at 3 am. I know a boat called the Colombo'which Thrupp was the owner of and think her safe if properly handled. At daylight on the morning of the 7th instant I noticed something to seaward which attracted my attention. All the boats were aground at the time but as soon as the tide made I proceeded towards the object, and found it was the Colombo. She was abound and under water lying on her beam ends but her mast and a portion of her sails were above water. Her mainsail and jib were set. I did not make any search for anything in the boat but came direct to Shortland and reported the matter to the police. On the evening of the 7th instant I proceeded to where the boat was lying in the steam launch Fairy and helped to raise her in company with some persons who were on board the TeAroha. The boat was in the same place as she was when I left her in the morning. When they raised her she had the same sails set and her ballast had shifted to the starboard side. The ballast was liable to shift if caught in a sudden squall and the result would be that she would fill and sink. I did not see any liquor or know that any was found. At low water on Friday I saw something lying in the mud flat about 200 yards from my boat which turned out to be the body of deceased. I brought it to Shorthand and gave it in charge of Constable Day. By a Juror the sheets were fastened when the boat was raised. It was not a rough night but there was one squall which would necessitate the sails being unfastened. Joseph W Day deposed I received the body of deceased on Friday evening and had it conveyed to where it now lies. I carefully searched the body and found no marks of violence. I found a sunglass, a piece of pencil, an India rubber ring, and a knife in deceased's pockets which were full of mud. There was a bottle of beer in the boat when she was raised. This concluded the evidence and the jury without leaving the room returned a verdict That the deceased George De Thierry came by his death by accidental drowning on the morning of the 7th instant. The funeral took place yesterday and was largely attended by Europeans and

Nothing more was heard of the boat or the occupants until following morning when the fishing skiff Louisa manned by Charles Everitt and James Cavanagh which had been fishing during the night and was returning home at daybreak came upon the Colombo lying bottom up opposite the Miranda. Mr De Thierry has been staying at the Thames Hotel during the sitting of the Land Court and Mr Thompson the proprietor states that he and the other two men left his hotel about half-past 11 o'clock on the Tuesday night to proceed to the Miranda. They were quite sober at the time. The owner of the Colombo Jonathan Thrupp was a thorough seaman but was not accustomed to work small boats and it is supposed that she was caught in a squall and capsized as when she was first seen by the men in the fishing smack her mainsail jib and topsail were all set leading to the belief that she was caught in a squall and before the occupants could shorten sail capsized. A Benney who was helping Thrupp to manage the craft was well acquainted with the management of boats having been employed thus for vears both here and in Auckland. He leaves a wife and family in Grahamstown to mourn Thrupp was injured at the Piako mine about six months ago and was incapacitated from mining work for months. Subscription lists were opened and a good sum collected which was handed over to him and with this he purchased the Colombo and embarked as a fisherman. In this case a wife and five children are left to mourn the loss of their bread winner.

While off Waikawau on her passage to the Thames yesterday the Rotomahana picked up the body of James Benney a victim of the late boat accident. On arrival at the Goods Wharf the remains which were but slightly decomposed were taken charge of by Police and after being identified were conveyed in an express to the Shortland dead house. As all the facts were known in respect to the accident were elicited at the inquest on De Thierry's body an inquest was considered unnecessary.

It was proposed by Mr Lowe seconded by Mr Reddish and carried That the funds in hand and any further funds that may be received be distributed in accordance with the proposals of the Committee as read by the Chairman.

Dead Body Found - Information was received by Mr Sub Inspector Bullen this morning from Sergeant Egan in charge of the Police at Coromandel that the dead body of a man had been found at Te Kumo south of Coronandel Harbor. The body had on dark trousers. It is believed to be the body of Jonathan Thrupp who perished with De Thierry and Benny by the Colombo accident some weeks ago. An accurate description of the clothes worn by Thrupp on the night of the accident has been sent to Coromandel which as far as dark trousers is concerned agrees with the description of the body found.

George DE THIERRY was born 20 July 1823 in England and drowned 06 August 1878 while crossing the Tamaki River in New Zealand. George's occupations were listed as tidewaiter, settler and launch licensee. His residences were listed as Hokianga, Wyndham Street Auckland, Kitahi, Coromandel, Tarapeit, Ohinemuri district. He was overseer to many construction gangs and spoke fluent Maori. He became interpreter for the Colonial government and also a Land administrator the equivalent to the head of the present Maori Affairs.

The engine driver and fireman knew that they had struck an obstacle but thought it was either a cow or a calf and consequently proceeded on the journey. When they pulled up at Frankton Junction station however they found traces of a human being. The tablet porter at Rangiriri and a ganger went to the scene of the accident on a jigger to find the dead body of de Thierry. It was assumed by the Department that the unfortunate man must have been trespassing on the line and that as the train was a special he would not be keeping a lookout for it and consequently met his fate. An inquest into the circumstances was held at Huntly on Friday when the Coroner's finding was that deceased died through being into contact with a moving engine no blame being attachable to the engine driver. The scene of the accident was not a level crossing. It is understood that the young fellow worked as a surface man on the railway and that he has a brother in the employ of the Waikato Shipping

Company. He was of French extraction. The latest accident particulars of which came to hand this morning took place at Frankton last evening at 10.30 as far as can be ascertained it concerned a man named Leonard Ellis. He was standing on the platform and just as a shunting engine was passing fell off and was dragged some distance being severely cut and bruised but not dangerously injured. The other accident resulted in a young married man named John Henry Kennedy employed by the Railway Department at Mercer as a signal man being crushed and admitted to the Auckland Hospital. It appears that Kennedy was passing between several wagons some of which were portions of a moving train and was caught between them. He underwent an operation shortly after admission.
