Car Accident On Grey-Dobson Road - Hokitika Residents Injured. A serious motor accident took place shortly after 8 o'clock last evening on the Greymouth-Dobson Main Highway about 5 miles from Greymouth. A Chevrolet sedan car driven by Mr Malcolm Houston senior of Hokitika was returning from the races at Reefton when it met a Hudson car being driven by Mr J Smeadon Mayor of Brunner. In passing the front hub caps of both cars met causing them to swerve across the road. Mr Smeaton's car swung to the right hand side leaving the road and coming to rest in a clump of blackberries. Mr Houston's car swung to the opposite side and fell over an 18 foot bank into what is known as the County gravel pit. The car came to rest upside down turning the occupants underneath part of the side of the car and the front seat having to be removed before they could be extricated by Messrs J McLeod and F L Turley who were following in the wake of the ill-fated vehicle. The accident also caused a hold-up with a considerable number of other cars that were returning from Reefton. The names of the injured persons, all of whom were removed to the Hospital are Mrs M Hall aged 63 of Hokitika suffering from severe shock and minor injuries. Mrs J Boyd aged 59 of Hokitika licensee of the Occidental Hotel suffering from a broken tight arm and shock.
