## Whitehouse Hotel - Invercargill 1860-2022

(website HA Whitehouse Hotel)

The Whitehouse Hotel was known by many names during its history. Some of the names were the Junction Hotel, Grand Junction Hotel, Great Junction Hotel, Wallacetown Junction Hotel, Lorneville Hotel and the finally the White House Hotel. The Hotel is situated on North Road Waikiwi Plains south of Makarewa at the Junction of Lorneville and Waikiwi, Invercargill, Southland, New Zealand.

In 1860 the Junction Hotel opened its doors for the owner and proprietor William WOOD. (Reference publication North Makarewa Lorneville by Joan MacIntosh 1979 page 92)

William WOOD received Crown Grant block IX section 36 of Invercargill hundred and his neighbour David MITCHELL received block IX section 37 part 1.

There was no name recorded on block IX section 37 part 2 on the original Crown Grant. At the beginning of 2010 the legal description of the land on which the Hotel was currently situated on was Block IX Sub-sections 1 and 2 of Section 37 of Invercargill hundred not section 36.

Perhaps the first Junction Hotel was built on William Wood's block of land section 36. As you can see this block of land was actually situated on the main road just south of the junction between Makarewa and Waikiwi. If we could locate the original owner of section 2 of 37 then we might locate the answer as to where the first hotel was situated.

I was informed that the OTT family was known to have purchased block 2 of 37 but their name only appears at the bottom of section 36 which was William Wood's block of land. The OTT family did not purchase the land that the hotel was situated on until around 1870.

An 1886 newspaper article confirmed that a new Hotel was built by the Ott family (after a fire) on a different site. "The contractors Walker and Burnett have made a start to erect a new house this time at the other end of the (Ott's) trust land and adjoining the Invercargill Public Sale Yards".

William WOOD served on the Jury for Invercargill on 13 and 18 October 1864 (Reference National Library of NZ papers past website Southland Times newspaper 13 & 18 October 1864 page 2)

William WOOD was nominated on 05 March 1866 as a Candidate to Represent Invercargill residents in the next General Assembly and was later elected as a Member of the Privy Council represent Invercargill and Southland. Details were published in various Southland Times newspapers. I also found reference to William being the Mayor of Invercargill. (Reference National Library of NZ papers past website Southland Times newspaper 07 March 1866 page 3)

I have been able to locate any information that links William WOOD with the Junction Hotel between 1860 and 1863. William was busy with Local and National politics during this period and would not have had time to operate the hotel so I believe he leased the hotel.

William WOOD remained the owner of the hotel but the early newspapers record the names of the various proprietors who held the license for the Junction Hotel.

It was not till 1874 that Jacob OTT purchased section 36 from William WOOD. Jacob OTT had previously purchased section 37 from David MITCHELL in 1870 and the land description may match that of the current hotel. I have researched only some of the land deeds and transfers records and the details can be found at the end of this document. With additional research I will be able to uncover the full history of the hotel.

During 1862 and 1863 a J G HUGHES was the proprietor of the Eagle Hotel Bluff Harbour Invercargill and later had an interest in an express coach service between Invercargill, Riverton and Bluff. Around the end of 1863 Mr J G HUGHES appears as the licensee for the Grand Junction Hotel which was another name given to the Junction Hotel.

The legal description of the land where the hotel is now situated was Invercargill Hundred Block 9 section 102 of 37 Lots 102. Perhaps Hughes has a mortgage n the land with Brayton Town.

Bluff Harbour report by correspondence - - Bye-the-bye, I forgot to mention in my last, that the Eagle Hotel has changed hands, the former proprietor Mr J G Hughes, having rented it to Mr J W Wagner a gentleman long and well-known in connection with the coach firm of Cobb and Co. Both gentlemen met with hearty well wishes from a circle of friends who met on the evening of the going out of the one and the coming in of the other.

Perhaps Mitchell originally owned the land and now Hughes has agreed to purchase the land. But a few months later it goes up for auction by order of the mortgagers. I will have to search the bankruptcy records for the full story.

I do not know who took over ownership of the Hotel in 1864 or if it was actually sold but the answer should be in the land transfer documents held in the Dunedin Office at Archives New Zealand.

Mr J G HUGHES managed the Grand Junction Hotel for about 1 year then later became the proprietor of the Prince of Wales Hotel in Dee Street Invercargill from 06 August to 02 November 1864 when he put it up for sale.

Since the beginning of 1864 I have been unable to locate any additional information about Mr J G HUGHES. I did however locate on the 1870-1871 Invercargill Electoral Roll a John Gethin HUGHES household Esk Street Invercargill Clarendon Hotel. I believe Mr J G HUGHES was actually John Gethin HUGHES.

The Junction Hotel was still operating after 1864 but by whom I do not know. A Mr B BAIN is recorded as the proprietor around the beginning of 1867.

Between 1864 and 1867 the Junction Hotel was used by the local community as a meeting place and the surrounding land for various events.

## Southland Times newspaper 18 December 1876 DESTRUCTION OF JUNCTION HOTEL BY FIRE

A sensation was created on Saturday morning last when it became generally, known that the Junction Hotel, on the North Road, 4½ miles from Invercargill, had been totally destroyed by fire under circumstances of a peculiarly painful nature. Rumours had been current for some weeks past to the effect that domestic troubles had shaken the reason of the proprietress and landlady, Mrs Ott, and the facts below narrated prove that the rumours referred to were, unfortunately, too well founded. Sergeant Tuoby went out to the Junction at half-past eight in the morning, and succeeded in gleaning much information regarding, the disaster. "It appears that Alfred Ott, a boy about 18 years of age, called the servant, Caroline Colinson, in the morning, saying that his mother had set fire to the house upstairs. The servant then met Mrs Ott herself, who said that she had set the place on fire. The girl then ran upstairs and found the window curtains in the six rooms in a blaze. On asking Mrs Ott why she had done such a thing, the reply was- "They were going to burn me out, and I thought I would do it myself." Mrs Otts, who had gone upstairs with the servant, then, returned to the ground floor, and tried to lock herself and her boy up in her own room, but the girl succeeded in keeping the boy, back, yet could not prevent Mrs Ott from locking herself in. When Mrs Ott went upstairs the girl followed her for the purpose of imploring here to come down. Mrs Ott's clothes had then caught fire, and she said that, she had gone up for the purpose of getting burned. She wished to burn with the house, as some people wanted to take the house and burn it. The girl states that Mrs Ott appeared guite well on the previous evening, and that she retired about 11 o'clock. John Sutton, barman at the hotel, told Sergeant Tuohy that on getting up in the morning at about half-past six, he saw Mrs. Ott, half-dressed, in the kitchen. She appeared to be in a wandering state of mind and she asked him if he was going to take here away, as they were going to burn her out. After reasoning with her a little, he went to milk the cows. About twenty minutes later, Alfred Ott came running towards Sutton, crying, "Ma is burning the house". He at once ran to the house, and was told by the servant girl that Mrs Ott had set fire to the place, and had locked herself up in her own room, which was also on fire. He then went to Mrs Ott's room, found the door locked, called, but received no answer. He tried to burst the door open, but could not, and he then ran to the window, which he broke and thereby entered the room. He found Mrs Ott lying on the floor with her body placed against the door, and the bed and window curtains were burning. Mrs Ott had the key of the door in her hand, and this he took from her, opened the door, and dragged her, for she would not walk, to the kitchen. After doing this he returned to the room, threw the burning bedclothes out at the window, and with his hands put out the fire in the window curtains. On finding that the house was on fire upstairs, he ran for Mr Brass, who lives about a quarter of a mile off. On returning they found Mrs Ott in the kitchen, and she told them that she was going to burn with the house. They then took her out into the yard, and Mr Brass remained with her while Sutton went to look after the furniture. By this time William Fryer and Mr Grant had arrived on the scene, and Sutton at once proceeded to catch a horse for Fryer in order that be might convey intelligence to the police in Invercargill. On returning, after this, Sutton found about 12 men at the house, saving things from the fire. He then sent for Mr Horman, who, on arriving, took Mrs Ott away with him to his own house. Sutton did not see Mrs Ott start any of the fires. There were six bedrooms upstairs, five of them being furnished, and one sittingroom, and downstairs, Mrs Ott's own bedroom, servant's room, a nursery, sitting-room, store-room, dining-room, tap-room, a kitchen, and bar. On-going out in the morning, Sergeant Tuohy found it necessary to apprehend Mrs Ott, as she was apparently, quite insane, and she made frequent attempts on her own life. She was evidently quite, unconscious of the fire, and wished to return to her own house. She was conveyed to town in the evening, and is now in custody. The case will probably be brought into

Court on Tuesday. The property was insured in the National as follows: - On the building, L500 furniture, L300; stock, L100. The National had, however, re-insured the furniture for L300, and the stock for LIOO with the Royal Insurance Company. # Southland Times newspaper 20 December 1876 INQUEST ON THE JUNCTION HOTEL FIRE

An inquest touching the origin of the fire which destroyed the Junction Hotel on Saturday last was held in the Schoolhouse, Waikiwi, on Tuesday afternoon, before District Coroner Dr Monckton. Mr Henry Hawson was chosen to act as foreman of the jury, and Inspector Fox conducted the proceedings on behalf of the police. John Sutton, barman at the late hotel, said that there were no strangers in the hotel on the night previous to the fire. Besides himself, Mrs Ott, her four children, and a female servant were the only persons on the premises. After rising at 6.30 on Saturday morning, he saw Mrs Ott come out of her room half dressed. She asked him if he was going to take her away, as the Irish were going to burn her out. He saw she was wrong in her mind, and after reasoning with her, he went to milk the cows. In about 20 minutes the boy Alfred came and told witness his mama was burning the house. He left milking, went to the house, met the servant girl, and in consequence of what she told him, he tried to get into Mrs Ott's room, and failing to force the door, he broke the window entered, found Mrs Ott lying against the door, took the key out of her hand, and having put out the fire in the window blinds and curtains, he unlocked the door, and pulled Mrs Ott outside and took her to the kitchen. After that she went upstairs, and witness noticed that an upstairs bedroom was on fire in the ceiling. Mrs Ott entered this room, he followed her, and she asked him to let her burn with the house. He could not move her from the top of the stairs, and he ran for the assistance of the next neighbour, Mr Brass. On returning he found Mrs Ott in the kitchen; the men Fryer and Grant were on the scene, and the top of the house was all in flames. Witness then despatched a messenger to the police. He was certain that Mrs Ott was out of her mind at the time of the fire, and had been so for a month, more or less. Mrs Ott's clothes were on fire, and it was extinguished by the servant girl, Caroline Collinson. He was certain Mrs Ott intended to burn herself. The servant and children were in bed when the fire The house was burnt to the ground. Caroline Collinson gave commenced. corroborative evidence. Henry Horman, farmer, residing within a mile of the Junction, had known Mrs Ott for nine years. She had been strange in her mind for the last month - at times reasonable, at others quite insane. Having noticed at seven on Saturday morning smoke issuing from the Junction Hotel, he went thither, found the place in flames, and the roof fallen in. Mrs Ott being violent was conveyed to witness's house. Of his own knowledge, witness could say nothing about Mrs Ott's business or insurance. Her husband died on the first of January, 1876. George Gohl, hotel-keeper and farmer at Woodlands, said he was an uncle of Mrs Ott's. About three weeks ago her brother in law, George Ott, had asked witness to see her. He did so, and found her very queer in her mind. He took her to his own place for a change, but she getting worse he brought her back, and she appeared to improve with the presence of her children, and to get nearly right. It was proposed by witness that the hotel should be let, that Mrs Ott should live quietly in a cottage in town, and tenders were advertised for the hotel accordingly. He did not take steps to place Mrs Ott under restraint as he observed she got worse when removed from her family, but Sutton had been told by witness and George Ott to keep a good look-out on her as well as the business. He considered the house, which was a superior one, to have been, together with its contents, worth LI6OO. Sergeant Tuohy said that on, seeing Mrs Ott on Saturday morning she conducted herself like a dangerous lunatic, and he arrested her. The jury returned as their verdict, that the house had been wilfully and feloniously set on fire by some person or persons unknown.

On the other side of the hall is the dining room, 20ft. x 18ft., with slide communicating with kitchen, 16ft. x 14ft., adjoining which is a large landlord's room. The building is of two storeys, and on the first floor there are two private parlours and six good bedrooms. The house has been finished throughout in first-class style, and reflects great credit on the contractors.

Sudden Death - A man named James Anderson died suddenly at Mr J. McIntosh's Junction Hotel yesterday morning. He had been staying in the hotel since the date of the reaper and binder contest on Mr Hormann's farm, the 27th February, and had frequently complained of asthmatic shortness of breath. On Sunday be went for a drive to the West Plains, and on his return appeared to be suffering more than usual. He went to bed, staring that in the morning he would come to town to see a doctor. During the night he became worse, but he refused to allow Mr McIntosh to send for a medical man, as he said he would see one himself in Invercargill in the morning. About 9.30 a.m., after he had taken a little breakfast, he was being assisted downstairs by Mr McIntosh, when he suddenly sat down on the stairs, and shortly afterwards expired. Mr McIntosh despatched a boy for Dr Hanan just before Anderson's death, and that gentleman arrived as soon as was possible. An external examination of the body did not disclose the cause of death. The deceased was a man about forty years of age and a native of Glasgow. He came to the colony about eight years ago, and since then has been principally about the Wyndham district, where he was well-known. For four vears he was employed by Mr Allan Galt, of Tuturau, and last season he travelled with an entire house for Mr James Galt, of Edendale. He had no relatives in New Zealand, and was unmarried. An inquest will be held to-day.

Had it not been for the change in the wind the hotel might also have been consumed by the flames. It was not known when the intelligence of the occurrence reached us, what if any the insurance were.

A 1900 a newspaper article confirmed that the two-storey wooden Junction hotel building was destroyed by fire so perhaps it was 1900 when Farrell and Harris supposedly rebuilding the hotel using Makarewa bricks.

I was given information that after the fire of 1886 the contract for rebuilding the Junction Hotel using Makarewa bricks was given to <u>Farrell and Harris</u> but I now know this is incorrect. When the Hotel was rebuilt as a two-storey wooden building not a brick building.

Harris was actually George Thomas HARRIS a carpenter and an ancestor recorded on the website www.lynly.gen.nz/index.htm document "Harris Morris 1878 New Zealand chart 12-13". Harris's other building partner was James FARRELL a bricklayer who dwelled in Avenal around this period. Perhaps George HARRIS made some additions and/or alteration to the Hotel when his two sons became proprietors of the Hotel.

After the fire a new hotel was built and opened for business in November 1901 with John ROBERTSON as the hotel's proprietor.

On a visit to the Hotel around 2008 a local told me that there had been two deaths in the Hotel during its history. One was a china man who died outside in the stables and the second a lady guest who died around 1918 in the Hotel.

There was a well-known China man (Looee) who lived opposite the Makarewa Junction station but I could find no link for him with the hotel and he was still living in 1929. I also could not locate anything regarding the death of the lady at the hotel in 1918. I did however discover a death at the Wallacetown Junction Hotel for Bernard MULLAN in 1903.

The known deaths at the Hotel are:

- 1. John Jacob OTT died 02 January 1876
- 2. Louisa Maria OTT died 04 September 1876
- 3. George Frederick OTT died 21 October 1876
- 4. James ANDERSON died 28 February 1884
- 5. Bernard MULLAN died 03 July 1903

### Southland Times newspaper 04 July 1903

Fatal Accident - A very sad affair occurred at the <u>Wallacetown Junction Hotel</u> in Wednesday night resulting in the death of Mr Bernard Mullan farmer of West Plains. The deceased had been in town on Wednesday and went to the hotel in the evening, retiring to his room about 10 pm. About 6 am next morning he was found on the ground unconscious, he evidently having jumped from his bedroom window to the ground, a height of about 20 feet. He was brought in to the hospital on Thursday morning and it was then ascertained that his skull was fractured and that both arms were broken. He died of his injuries yesterday morning.

INQUEST – An inquest was held yesterday afternoon in the hospital before Mr S E McCarthy coroner, and Messrs A Bain (foreman), W Handyside, J D McGruer, W Strang, J H Kirk and R Allen. Inspector Mitchell conducted the inquiry on behalf of the police. The Coroner said that the police had not yet had time to make exhaustive inquiries into the affair. It was proposed that the jury should hear formal evidence of identification and then adjourn to a convenient date when fuller information would be available. Michael Daley tally clerk residing at Winton identified the body as that of Bernard Mullan who was his brother-in-law and resided at West Plains. The hotel was about four miles from deceased home. Witness had not seen deceased for about two years. He was not more than ordinarily fond of drink except on rare occasions. Had no reason from what deceased's wife had told him, to believe that deceased was much

addicted to drink. To Mr Bain: Probably the distance from the hotel to deceased's home was just over three miles. This was all the evidence taken. Inspector Mitchell said that the police desired to secure every possible atom of evidence to clear the affair up inasmuch as it took place on licensed premises, and to help in this he suggested that an adjournment should be made at this stage. The inquest was accordingly adjourned till Friday next at 10 am in the courthouse.

The Junction Hotel Fatality - The inquest touching the death of Bernard Mullan farmer West Plains who died in the hospital on the 3<sup>rd</sup> inst., having been taken there for treatment for injuries received by a supposed fall from a window at the Wallacetown Junction Hotel, was continued yesterday in the Courthouse, Invercargill. Mr S E McCarthy coroner, presided, and the jury were; Messrs A. Bain (foreman), W Handyside, J H Kirk, R Allen, W Strang and J D McGruer. Inspector Mitchell conducted the case on behalf of the police. Detective McIlveney gave formal evidence as to the position of the rooms in the hotel.

Dr Fullarton gave evidence that he visited the Junction hotel on the morning of the 2<sup>nd</sup> inst., witness understood at the request of Mr Robertson. Found deceased lying on a bed, guite unconscious. Was informed that the man had been found lying in front of the hotel, as if he had apparently fallen out of the window. Found that deceased's skull was fractured, and that he was suffering from concussion of the brain. The left side of the face cut und bruised, and there was rather a big cut over the left eye. The injuries had evidently been caused by the fall from the window. The injuries must have been received two hours or more before witness saw deceased at 8.30. Witness considered deceased's condition serious, and recommended Robertson to remove him to the hospital; said that the man had very little chance of recovery. To the foreman: Did not detect the smell of liquor on deceased. Did not examine the wrists, but had since heard that they were broken. To the Inspector: It was quite possible that two doctors and two nurses detected the smell of stale liquor on deceased. Witness had not told anyone that he could account for this by the fact that he had poured a bucketful of liquor into deceased. He gave him nothing of the sort. James Jelly, farmer, West Plains, deposed that deceased's place was on the boundary with him: they had been neighbours for eight or nine years past. Knew that deceased was in the habit of taking strong drink, at times to excess. He was a very kindly disposed man - the best-hearted man witness ever knew. Deceased, as far as witness knew always preferred going to his home rather than absenting himself. On Tuesday 30<sup>th</sup> June, witness saw deceased last at the Wallacetown vards during the day till about 12 o'clock: Deceased was perfectly sober at that time. Witness left his own horse and trap for deceased to bring home in the evening. Deceased returned with the horse and trap about 6 30 that evening. He was not drunk then, but drink could be observed on him; he was bout half-drunk, but capable of taking care of himself. Deceased had bought three dairy cows that day, and tried to take them home; he was hampered with the horse and cart. A man named Gillan took them with his lot. Deceased had tea at witness place that night; he did stay to sober up, but after tea he appeared much better. On Wednesday evening deceased did not return home; never knew him to absent himself before. Knew of nothing, to prevent him going home. Witness did not hear of the accident till Thursday evening at 10.30, when Detective McIlveney told him. Mrs Mullan was then informed for the first time. Fred A Price, cattle-dealer, Waikiwi gave evidence that he saw deceased on the Wednesday at the hotel with Messrs Culhane. Robertson and Cusworth and they had two or three drinks. When witness left the hotel deceased was in the bar with Culhane. Deceased

at that time was without doubt perfectly sober. Would say that Culhane was telling an untruth if he said deceased was not. Had been asked to come to the inquest by Detective McIlveney and Constable Emerson.

David Patterson labourer Ryal Bush said that he was at the hotel at 11 a.m. on the Wednesday. Among others, a little worse for liquor though he saw Culhane and another man presumably deceased; both of whom were quite able to look after themselves.

Michael Lauders farmer, Makarewa said that he saw Culhane and deceased at the hotel at 12 o'clock on Wednesday. They both showed signs of drink Saw them again shortly after 6 p.m. at the hotel in the bar. Did not see them having any more drink. Witness left the hotel at 9 p.m.

Louisa Benn employed at the Wallacetown Hotel said that Cultane and deceased called at the hotel about 3 p.m. on the Wednesday and had a drink. There asked where Mr Jenkins lived as they were looking for cattle. They had no more drink and went away. They returned about 4 p.m. and had two more drinks each, of whisky. A man named McMasters shouted on this occasion, and Culhane might have shouted. Did not think that Mullun shouted; he might have done so. Mullan said that a girl at Jenkins had tried to convert him. Witness had heard that she had said that Mullan was looking stupid with drink. Witness did not think he was in this condition. Was sure that they only had three drinks in the hotel. To the Foreman; the men walked steadily down the street; they were quite sober. Did not know that it was an offence to serve drunken men with liquor until Detective McIlveney had seen her last Wednesday. Only served in the bar when her grandfather (the licensee) was out.

Janie R Jenkins residing at Wallacetown said that deceased and Cultane called at her brother's place looking for some cattle. Noticed that deceased looked very strange and peculiar; smelt drink on him. Witness thought at first that he was insane he stood and looked at her, and could not get his words out.

To the Foreman: Had never come in contact with anyone who was the worse for drink, so could not say the deceased was drunk. He was very strange. Patrick Culhane, farmer, West Plains, said that he was a neighbour of deceased, and had known him well for 23 years. Attended the Wallacetown sale on Tuesday 30<sup>th</sup> June, and met deceased. Could not say how many drinks they had that day. They bought eight head of cattle at the sale, and attempted to drive them home. He was in Kelly s trap with deceased. One of the cows got away and witness got down to drive it back. When he did so the other seven got away and were lost. Saw deceased at 7 30 next morning, and had breakfast at his place. They went out to look for the cattle, and about 9.30 reached the Junction Hotel. They had three drinks each with Price and others. Witness shouted once during the day. Witness suggested, about 10.30, that they should stay and have dinner. Deceased agreed to do so, and they remained in the bar the whole time. Did not have any more drink before dinner. Left the Junction about 1 p.m. and went to the Wallacetown Hotel, where they had one drink. They then went to Jenkins's to make inquiries, and then called at the hotel again. Had two more drinks, and went back to the Junction Hotel about 5.15 p.m. Could not say exactly what time they arrived, as he had had a good few drinks. Did not remember having any more drinks before tea. After tea went to the sitting room and had more drinks. About 9 o'clock deceased and witness thought of going home, but it was decided to stay all night, as a more convenient place to start from in the morning. Witness was not quite sober: deceased was worse, in his feet, but that was not the reason they stayed at the hotel. As far as witness remembered they had five drinks after tea. James Fahey helped deceased upstairs; witness went by himself, and occupied the same room. Fahey put deceased to bed with his clothes on. Could not say what time it was then. Did not know whether the window in the room was closed during the night, though his bed was next it. Was awakened next morning by the wind coming in; did not see deceased about. There was nothing in front of the window. They were both in a state of intoxication when they went to bed. Did not think they should have been supplied with the last round of drinks they had. In the morning Mrs Robertson (wife of the licensee) told him that his mate had gone out of the window during the night. James Vincent Fahey traveller for the Southland Freezing Company gave evidence regarding the proceedings at the Junction Hotel. He went upstairs with deceased, but did not assist him. Put deceased in bed; pushed him, as he did not wish to go - he could have gone himself if he had liked. Deceased was under the influence of liquor when he went upstairs, and was a good deal worse in the room. Connel McDavitt, who was with deceased and the others in the sitting room, was of opinion that, deceased was thoroughly sober.

Mrs M.F.H. Robertson, wife of the licensee also gave evidence. John Robertson, licensee, detailed the arrival of the deceased and Culhane at the hotel at 9.30, their departure after lunch, and return at 5.15 p.m. After tea he remembered three drinks, one of which witness shouted. The men appeared to be quite sober. Witness had told the detective that they were showing signs of drink, but he thought that they were capable of having one or two more. When they went to bed Fahey was not in the room as far as witness knew. Witness left two candles burning, and trusted to Culhane and deceased to put them out. Fahey did not assist deceased upstairs. Ethel Maud Carry Mortimer also gave evidence re the discovery of deceased lying in front of the hotel on the Thursday morning. Dr Hendry gave evidence that when making an examination of deceased he noticed a smell of drink. Deceased's arms were broken just above the wrist, the skull was fractured, and the brain had received a severe shock. The face and chin were severely cut. Attributed death to the shock and concussion of the brain.

Archibald Wilson, butcher at the freezing works, deposed to the discovery of deceased lying unconscious in front of the hotel.

The Coroner having shortly addressed the jury, the retirement took place about 7 p.m. and at 7.30 the following verdict was returned: "That the deceased Bernard Mullan, came by his death by a fall from a window in the Junction Hotel some time during the night of the 1<sup>st</sup> July or morning of the 2<sup>nd</sup>. We believe that the fall was the result of the deceased being supplied with intoxicating liquor in the Junction Hotel whilst in a drunken state."

The Junction Hotel Fatality - The Licensee before the Court

At the Magistrate Court yesterday before Mr S E McCarthy S M John Robertson licensee of the Wallacetown Junction Hotel was charged with on July 1<sup>st</sup> (1) unlawfully selling liquor to Bernard Mullan deceased he being already in a state of intoxication (2) with selling liquor to Patrick Culhane under similar circumstances (3) with permitting drunkenness on his premises – Mr Stout defended on entering a plea of not guilty and Inspector Mitchell conducted the prosecution. In reply to Mr Stout inspector Mitchell said that he proposed to take the three cases together. The Court would understand that the one set of facts did not cover the whole of the information's but he would endeavour to marshall the evidence to cover the whole ground. Mr Stout said that if there were different facts for each information it would not be an easy matter to combine them in the one hearing. He would agree to them being taken together and the

inspector would agree to the only penalty I the event of a conviction being recorded. The inspector said that he could not bind himself by such an undertaking and Mr Stout then objected to the information's being taken together. The Inspector elected to take the case of supplying Culhane. The facts were on all fours with those elected at the coronial enquiry. Detective McIlvery gave evidence of a statement made by the licensee taken down in writing and signed relative to the death of Bernard Mullan. David Paterson Labourer Ryal Bush said that he saw Culhane at the Junction hotel about 11 a.m. on the morning of the 1<sup>st</sup> July. He was quite sober at that time.

Janie Jenkins was called to give evidence but the Inspector said that the evidence was more important in Mullan's case and did not put any question. Patrick Culhane farmer West Plains said that he had three drinks in the morning at Robertson's hotel and three in the afternoon at the Junction and did not remember any drinks before tea at 6 o'clock. After tea went to the sitting room and had two more drinks there. Later on he went into the hotel passage with Mullan and some others and had three drinks: thought that each one present had three drinks. Had three beers that day; all the rest were whiskies. When he went to bed was under the influence of drink but was not drunk. Though a man was drunk when he was not able to do anything for himself. Witness went upstairs himself and undressed without assistance. The drinks in the sitting-room were shouted by Mullan and Mr or Mrs Robertson James Fahey put Mullan to bed. To Stout; Had not been accustomed to liquor previously for about a month. Had been drunk on occasions knew Robertson as he used to go to the hotel on sale days. When in the passage in the evening did not remember doing anything out of the way to draw attention to himself. In the bedroom Fahey and Mullan were talking about bone manure which Fahey was trying to sell. Fahey blew out the candle when he went away. Witness said at breakfast next morning that he thought they were sufficiently sober to look after themselves. To the Inspector: Had given Fahey an order for the manure when in the sitting-room they were talking over its merits when in the bedroom. Did not know that he was correct in saying that Mullan could look after himself. Did not think that he told Detective McIlveney that Mullan was helplessly drunk. Remembered telling the Detective that he had more drink than he should have had and that he just managed to get to bed. What he said on that occasion would be true to the best of his knowledge.

Mr Stout for the defence submitted that the information must be dismissed as the evidence disclosed that no liquor had been actually sold to Culhane. The evidence was that the persons who shouted were Mullan, Fahey, McDivitt and Robertson and the liquor was supplied to Culhane by one of those persons. If an authority were wanted the case of Dwyer against Hermann decided by the Chief Justice in Wellington in which it was held that to constitute an offence under section 146 of the Act the liquor supplied to a drunken person must be paid for and consumed by that person himself could be quoted. The evidence in the present case was distinctly that Culhane did not call or pay for any liquor and there was no evidence of a single drink being sold to him at all. Counsel quoted an English case bearing on the same point.

The Inspector asked his worship to hold the point over till the others were disposed of. The Magistrate said that before the case quoted by Mr Stour before the case quoted by Mr Stout has been decided he had a similar case before him and had held then that in the event of a sober and drunk man going into an hotel and the sober man shouting for his drunken companion the actual sale must be made to the drunken man or an agent before a prosecution could come within this section. He would look into the evidence and see whether there was any ground for believing that Culhane had paid for and consumed liquor in the hotel.

The case for supplying liquor to Bernard Mulllan was then taken.

Evidence was given by Detective McIlveney, D Paterson and M Landers. The last witness said that Mullan looked as if he had drink, did not think he was drunk, though a man must be lying on the road or somewhere else before he was drunk.

Jane Jenkins gave evidence that Mullan and Culhane called at her brother's farm in search of some cattle. She spoke to Mullan, and thought he was acting strangely. Thought he was under the influence of drink, - To Mr Stout had no doubt that his conduct was the result if indulgence in drink.

Patrick Culhane gave evidence that Mullan shouted in the passage once in the evening and he thought Fahey a Mr or Mrs Robertson also shouted Fahey took Mullan's arm when going upstairs and they went into the same room as witness. Thought Fahey kept his arm under Mullan's elbow until they reached the bedroom Fahey took off Mullan's boots, turned the bed-clothes over and put him to bed with his clothes on. Did not know why Fahey did this thought that he having taken more drink than Fahey, Fahey did it for him. Mullan was under the influence of drink and probably unable to take his clothes off

To Mt Stout: Fahey went out of the bedroom for a few minutes and came back. He was talking to Mullan about bone manure; did not notice that Mullan was particularly talkative. Did not remember Fahey telling Mullan to shut up and go to bed. Did not remember any discussion about the way Mullan's name was spelt. Mullan took part in spoke quite sensibly. He was a man who was affected in his legs, before his head the conversation during the evening and to the best of witness belief, Fahey went upstairs with Mullan holding his arm.

Connal McDivitt farm labourer Makarewa wanted to know who was going to pay his expenses for attending Court but was informed that it was too late to raise the point. Witness was in the hotel at tea-time and saw Mullan. At the table Mullan said that it was his duty to make a speech. Whether he pushed himself or his foot slipped witness could not say but he went right back with his chair. Mullan might have been slightly stunned as his head hit against the wall. They had one drink in the dining-room and witness shouted for Mullan and Culhane in the passage. They had intended up to this time to go home and had made arrangements with witness for doing so. Left the hotel at 9.30 – To Mr Stout. There was matting on the dinning-room floor, and it was not unusual for people to trip on it as Mullan might have done. Noticed nothing unusual about Mullan's behaviour.

James Vincent Fahey gave evidence that he saw Mullan and Culhane, with several others in the sitting-room of the hotel. Witness did not seen have more than one drink; did not know if Mullan had any. Later on the three of them went into the passage; the licensee was there. Witness shouted the first round of drinks the licensee the second and Mullan the third. Thought Mullan was drinking whisky. No more drink was supplied. Witness Culhane and Mullan went upstairs together he had a distinct recollection of what took place. Mrs Robertson came out of the bar and locked it up before they went away. Witness went upstairs first thought Mullan was next and Culhane third. Did not remember whether he was walking abreast of Mullan might have passed him. Did not remember having his arm under Mullan's elbow. At the top of the stair witness lit two candles; took one himself and gave one to Mullan. Did not remember whether he went into Mullan's bedroom then or not. Went to his own room first, and then to Mullan's. (Witness corrected himself after some hesitation admitting that he had gone half-way into the room) Could not say why he went in or what he did. Mullan was sitting on the bed smoking when witness went away that time. Was absent about 10 minutes. The candle was on the dressing table, which was half-way along the room. Returning to the room and found Mullan sitting on the bed smoking. Witness chatted to Culhane and Mullan for some time and then told them to go to bed. Took off Mullan's boots in a playful way, he was a little intoxicated and did not want to go to bed. After getting and order from deceased for manure he did not like to run away and leave

him. Did not know why Mullan did not take his own boots off, put deceased to bed with his clothes on; pushed him back on the bed and puled the blankets over him; also took the pipe out of his mouth. Did not think the man was helpless at that time. Deceased was slightly intoxicated and that was the reason witness put him in bed. Culham was still standing when witness left the room. Thought he (witness) blew out the candle first, was not sure thought there was danger of a fire if he left it alight, owing to their being two intoxicated men in the room. Saw Mullan after the accident, he was dressed as on the previous night.

To Mr Stout Mullan spoke sensibly and was standing when in the passage there was no occasion for witness to help him upstairs. His condition was worse when he reached the bedroom was not positive that Culhane had not gone positive that Culhane had not gone to bed before he left the room. – To the Inspector: Considered a man drunk when he was stupid and helpless did not consider Mullan drunk or helpless.

The defendant's evidence at the inquest was put in the Magistrate ruling that the full notes could not be admitted as evidence.

For the defence Mr Stout said that he proposed to call evidence that before doing so wished to make a few remarks on the case as presented. As his witness had remarked nothing that took place at the inquest except as to the statement of Robertson had anything to do with the case before the Court. His Worship was now having the case on an alleged breach of the Licensing Act and must be guided by the evidence then given and not by knowledge of the case gained as coroner. The real question was not the condition of the deceased when in the bedroom or at any time subsequent to that, that his condition when supplied with liquor in the passage. The accident was a very sad one and no one regretted it more than the licensee but that tragedy should not interfere with justice being done him, it could not be suggested that the licensee had been endeavouring to get money out of the men by plying them with drink and the evidence was to the effect that the company generally has been extremely abstemious. At 9.30 p.m. the licensee went to the sitting room to let them know it was time to prepare for bed and to induce them to do so he shouted for them. The ordinary object of a licence supplying a man manifestly in a state of intoxication was absent in this case. Miss Jenkins evidence of the deceased's conditions was subject to qualification as she admitted that she had conversed with the man for some considerable time. She was admittedly ignorant of the appearance of a drunken man and on smelling the liquor from him had jumped to the conclusion that the man was drunk. As to Mullan's fall at the tea table, that had been explained by McDivitt in a manner that must have satisfied the Court that the fall was not due to drink. The witnesses were agreed that the man was sober when in the sitting-room and in the passage. He was practically sober till he got to his bedroom but on going into the colder atmosphere the liquor took effect and he got so talkative that he would not go to bed. Counsel quoted the Chief Justice's ruling in Brown v Bourne that a state of intoxication was being in that state in which through intoxicating liquors the person had lost normal control of his bodily and mental faculties. There was no evidence that Mullan was so affected in fact all the evidence was the

Eric Kenneth Mackay schoolmaster Makarewa and W Burgess employed at the freezing works gave evidence that they considered the men in the sitting room sober enough to look after themselves. The latter denied that he had told his brother that both Culhane and Mullan were drunk.

John Robertson the defendant gave evidence that he was not intimately acquainted with either Mullan or Culhane and did not see them on the evening of 1<sup>st</sup> July till some time past 9 o'clock when he went into the bar parlour. Witness asked them and the others to go into the passage as he wished to prepare to close and they did so. They were all quite sober. Witness asked them to have a drink and they did so. After that they went upstairs witness going up first. Mullan was last and it was incorrect that

Fahey had his arm in deceased elbow. He did not require help. Saw Culhan and Mullan go into their bedroom looked into the room and saw they were all right and went downstairs. – To the Inspector Considered his statement made at the inquest was quite consistent with his present evidence said nothing to Fahey about looking after the candle before they went upstairs. Could not account for Fahey not seeing witness going upstairs. Witness lit the candle not Fahey. The dressing table on which the candle was placed was near the window. Did not know anything about the third drink in the passage. Deceased condition as described by witness would indicate that the whisky had taken effect after he got to his room.

Mrs Robertson wife of the licensee gave evidence that five drinks were supplied to the men during the evening Fahey followed her husband upstairs Culhane was next and then Mullan it was incorrect that Fahey assisted Mullan upstairs. — To the Inspector: Her husband called the men out of the sitting room they were in the passage when he asked them to have a drink. Mullan shouted the last drink.

This concluded the hearing and his Worship reserved his decision. It was agreed that the Magistrate in dealing with the thirds information should base his decision on the evidence given in the two previous cases. Mr Stout stipulated that he should have the right to address the Court on the legal aspect of the case.

The Hotel Prosecutions - Convictions Recorded in Both Cases - The Junction Hotel At the Magistrate's Court yesterday, Mr S E McCarthy, S.M., gave Judgment in the cases, against J.J. Robertson; licensee of the Wallacetown Junction Hotel, charged with selling liquor to Bernard Mullan and Patrick Culhane (two informations), and permitting drunkenness on his premises. Inspector Mitchell -prosecuted and: Mr Stout defended. His Worship said that the information's were laid under section 146 of the Licensing Act 1881, which makes it penal for an innkeeper to premises or to sell liquor to any person already in a state of intoxication. Before a conviction can take place in respect to the first-named offence there must be proof that the licensee or his authorised servant knew that the persons, the subject of the charge, were drunk, while in the second such knowledge was immaterial. It was, however necessary to prove in the latter case that the sale was actually made to the person alleged to be in a state of intoxication, and were supply at the instance of some person to whom the sale was actually made, would not suffice. It was also important to hear in mind that the New Zealand Act differed from the English Act in that in the latter the offence was for selling to "any drunken person", whilst in the former the words "to any person already in a state of Intoxication". This state had already been defined to be that in which, through intoxicating liquors a person has lost normal control of his bodily and mental faculties and the decision was that the state signifies some degree less than, absolute incapacity. The three alleged offences were committed on July 1st, and were founded on the same set of facts. is Worship, reviewed the evidence regarding Mullan, pointing out that at 11 a.m. on the day in question as D. Patterson said, "it could be seen that Mullan had taken liquor, although he could control himself and, in witness opinion, had not had more than one glass." Landers deposed that he noticed signs of drink on deceased at noon, and later on between 6 and 7 p.m. Miss Jenkins testimony was reliable but was subject to the criticism that she had had but little experience of drunkenness. Immediately after leaving Miss Jenkins, Mullan had a drink at Powell's Wallacetown Hotel and returned to the Junction. His Worship referred to the deceased's conduct at the tea table, and his subsequent acts in the sitting room and passage. At least three out of the four drinks supplied in the passage were supplied to Mullan in defendant's presence the last of the four having been paid for by Mullan upstairs, put him to bed and had in Court admitted after considerable reservation,

evasion and prevarication, that he did all this because of the state Mullan was in through drink although he would only admit that the latter's state was one of slight intoxication. He admitted that he put out the candle because both Culhane and Mullan were intoxicated, and he was afraid of fire. Mullan either jumped or fell out of the window, receiving fatal injuries. Culhane was sleeping with his head alongside the window, and seeing that he was not awakened by the noise and had taken an equal number of drinks with Mullan, it was difficult to escape the conclusion that he was sleeping off the effects of a carouse. From all the facts the Court found that Mullan was under the influence of liquor at 11 a.m., was still further under the influence at 6 p.m. after which he had five more drinks and when finally put to bed was helplessly drunk. Clearly when his last drink was served and sold to him a little before 10 p.m. he was to the knowledge of the defendant and his wife in a state of intoxication. The defendant in his statement to the detective referring to the condition of Mullan and Culhane before serving them with the last drink said "I had a good look at them to see that they could stand a liquor before I spoke. They showed signs of having had one or two drinks, but I thought they were quite capable of standing another drink or even two more. Why this superabundance of caution if Mullan and Culhane were not in a state of intoxication. But they were actually supplied with three more drinks. Further, all the witnesses except Miss Jenkins were palpably endeavouring to shield the defendant, some of them going on to say that they did not consider a man drunk or in a state of intoxication unless he were helpless. It was in the light of the expression of this opinion that their evidence had to be read. The case in respect to Culhane must fail, because there was no proof that any liquor was actually sold to him, the sale having been made to one or other of his companions. There was, however, proof, of defendant having permitted, drunkenness. As all the information's, were laid in respect to the same set of circumstances and under the same section, which provides only one penalty, only one conviction for selling liquor to Mullan, he being already in a state of intoxication, would be entered, the other to be dismissed.

After hearing that the costs were £6.12s 5d his Worship fixed the fine at £5, the license to be endorsed.

Mr Stout said that while he had the greatest respect for the judgment of the Court, in the interests of defendant he would like his Honour to fix the amount or as to enable him to have the decision reviewed if he were so advised. The Magistrate said that he had considered this case and the remarks made on such cases by the Chief –Justice. Although the evidence was lengthy, he had taken some time to look into and review it, and he had been forced into the decision he had come to. Looking at the difficulty of proving these cases and this particular case where the witnesses were not prepared except under pressure to tell the whole truth, he thought that the proper course was only to fix a fine which should allow the defendant to appeal on common law. To allow a rehearing in the case only pointed towards perjury, and he therefore refused the application.

Mr Stout said that it was a matter of very great moment, not only to the licensee, but to the house also. For a shilling more they would have the right of appeal as a matter of course. His Worship: I have thought over that matter, and this is my decision. Mr Stout: It is quite a new departure, even in your own Court. His Worship: That may be so, but it is the course I propose to take.

On 30 June 1906 Liquor sales ceased in Invercargill and 'Prohibition' began. Another newspaper published in 1993 gave the year as 1905 not 1906. Check the Government publication NZ Gazette and New Zealand newspapers to confirm.

In the Theses of Janette Lee Mollison there were two photographs of the Whitehouse Hotel. The images came from the Invercargill Licensing Trust.

In 1905 Invercargill residence elected to go dry. On Saturday 30 June 1906 Invercargill Hotels closed their bars and it was not until another 38 years would they be opened again. There was nothing to prohibit the brewing of beer inside the town limits but over time the two breweries moved their operations beyond the town limits one being in Waikiwi.

Drunkenness cases still appeared in the Invercargill courts over this 'Dry' period. There was a national increase of drunkenness in 1919 when the World War One soldiers returned from overseas duty. There was a decrease in drunkenness in Invercargill during the depression years between 1929 and 1936. Drunkenness increased again during the World War Two (1939-1945) period. Invercargill drunkenness remained higher than that of New Zealand as a whole showing that 'Prohibition did not work. There was plenty of 'Sly grogging' around the district and for those who could afford it a tramcar could be taken to Waikiwi where three taxi services waited to take them to the 'White House Hotel'.

# NZ Licensee Journal - ROARING 1920'S

The "White House" had its heyday in the 1920's when it enjoyed one of the biggest bar trades in the country. With Invercargill "dry" shuttle transport services were rum between Waikiwi and the Hotel and dozens of barmen were kept busy behind the mammoth bar.

The story is told of the visitor to New Zealand to whom the hotel was pointed out as "one of New Zealand's richest gold mines". "Really", replied the visitor, "Do they use the cyanide process there?"

It is also known that a celebration was held at the hotel whenever prohibition was returned in Invercargill.

After 1921 Thomas Alfred and his wife Isabella Agnes DOUBLE ceased managing the Wallacetown Junction Hotel.

William had a daughter Doris (my mother) who shared with me some stories about living in the hotel. It was a sociable time for Doris and her sibling they would wait for the bar to close and when it was vacated they would put on their skates and skate around the famous long horseshow bar. Often her young brother would go missing and she always knew where to find him. Yes in the coal shed covered from head to foot in coal and with a piece in his mouth". He loved the taste of coal. William and Harriett's two youngest children were born in the hotel. All of William and Harriett's seven children are now deceased.

An uncle told me that William's father George Thomas HARRIS occupation carpenter assisted in rebuilding the Wallacetown Junction hotel along with partner James FARRELL occupation brick maker after the 1900 fire destroyed the Hotel. I think Farrell and Harris may also have assisted in making some additions and/or alterations to the Hotel while William was living in the hotel with his wife Harriet and their seven children.

The Wallacetown Junction Hotel had been a profitable thriving business during the prohibition period and trade continued to be busy during the World War Two (1939 to 1945) period. After the War there was a reduction of patrons and in time the financial effect from this would change the overall outlook of the Hotel.

The White House Hotel at Lorneville in its heyday one of the most celebrated houses in New Zealand – is now the property of Mr James Muir a 40-year old man who has been in the hotel business for most of his life and whose parents formerly Southlanders also spent about 35 years in the business.

Mr Muir who bought the hotel from the estate of the late Mr W T Hazlett has also purchased about 20 acres of land between the hotel and Cooper's corner on the Queenstown-Invercargill main highway. On this land which has a 10-chain frontage in the main highway he plans to build motels a wholesale bottle department and a covered garden.

#### WIDE EXPERIENCE

Other hotels Mr Muir has been interested during his career include the Oban and Gresham at Dunedin, the Elbow at Lumsden and the Cave Rock at Sumner. He was licensee of the Wanaka Hotel when it was burned down in 1958 and managed Wain's Hotel in Dunedin for the Estate of W T Hazlett before it was sold last May.

Since the <u>Hazlett of Mr W T Hazlett in 1947</u> both Wain's and the Lorneville Hotels had been under the control of the <u>trustees Messrs W E and L J Hazlett</u>. These were the only hotels owned by the estate.

The new owner of the Lorneville Hotel was a prominent Rugby player and a featherweight boxer at Canterbury University. He won a blue for rowing in 1945. His mother formerly a Miss Looney was one of the best-known nursing sister in Southland and his father Tom Muir represented Southland at Rugby.

ROARING 1920'S

The "White House" had its heyday in the 1920's when it enjoyed on of the biggest bar trades in the country. With Invercargill "dry" shuttle transport services were rum

between Waikiwi and the Hotel and dozens of barmen were kept busy behind the mammoth bar.

The story is told of the visitor to New Zealand to whom the hotel was pointed out as "one of New Zealand's richest gold mines". "Really", replied the visitor, "Do they use the cyanide process there?"

It is also known that a celebration was held at the hotel whenever prohibition was returned in Invercargill.

Powley's owned four hotels in the Dunedin area – the Masonic, Fitzroy, St Kilda and Royal (Green Island) – while Meenan's owned the Law Courts and Shiel Hill Hotels in Dunedin, the Mosgiel Hotel, White House (Lorneville) and New Eagle (Bluff). In May 1971 New Zealand Breweries bought the Victoria, one of the biggest sellers of draught beer in Dunedin.

In the early days the Whitehouse Hotel was known as the Wallacetown Junction Hotel. The convenient placed hotel was an ideal stopping point for travellers making there way to and from Kingston.

A colourful history for the Whitehouse

They've been drinking beer there since 1860. The Whitehouse Hotel had been a favourite stopping point for many generations.

In the beginning the hotel caters for Waggoner's and coach drivers travelling from Invercargill to Kingston. Then the hotel was known as the Wallacetown Junction Hotel. Stables accommodation meals and the bar room tempted passing travellers to tarry.

In 1886 a fire ripped through the hotel completely destroying the building. Thoughts were that the fire had started in an upstairs bedroom but hotel manager Mr PATTON was convinced it had started in the cellar.

The fire did not stop business for too long as the hotel was rebuilt and opened again in 1887.

The new building was built of red bricks from the Makarewa brickworks and became the Lorneville landmark. Later these red bricks were plastered white and dramatic changes were made to the exterior and interior of the building.

Prohibition in Invercargill in 1905 meant city drinkers had to travel to Wallacetown Junction Hotel for a thirst quencher.

Patrons would board a horse drawn tramcar out to Waikiwi from there it was over to enterprising horse and gig drivers or a "tin Lizzie" owner to finish the journey.

When management introduced a long U-shape bar to cope with the increasing crowds it was the longest bar in the Southern Hemisphere. Forty-five bar men stood behind the polished counter ready to serve the thirsty.

There has always been confusion over the Wallacetown Hotel and the Wallacetown Junction Hotel. Because of certain physical characteristics, the Wallacetown Hotel became known as the Greenroofs and the Junction Hotel became the Whitehouse. (Reference Invercargill Public Library vertical files subject Hotels)

Popular Meeting Place and Social Centre

The Whitehouse Hotel at Lorneville had been a popular meeting place and social centre for 100 years

The present building was erected in 1887 in red brick from the Makarewa brick works.

In those days the hotel was known as the Wallacetown Junction Hotel, a name which stood until 1922. The name was changed by the Licensing Committee to the "Whitehouse" to avoid confusion with the Wallacetown Hotel just three miles away, which also received a name change to the "Greenroofs".

A hotel was first opened at the Wallacetown Junction by William Wood in 1860 (the same year as the Wallacetown Hotel). Trade was brisk and William Wood's wooden establishment provided employment for people in the vicinity as well as accommodation and refreshments for weary travellers and their horses.

A fire destroyed this building on May 17 1866 (1886) without loss of life and a new building was quickly re-built, re-opening in 1867 (1887).

William Wood remained as owner until 1873 when he sold out to Jacob Ott and family. The Ott family sold to John Thomson in 1912, who in turn sold to W.E. Hazlett in 1918.

Jim Muir bought the hotel in 1962 and sold to Messrs Manan and Company in 1968. The hotel is now owned by Lion Breweries Ltd.

During the years of prohibition in Invercargill the Whitehouse experienced "bonanza" years. People from Invercargill came out to Lorneville by horse drawn tramcar to Waikiwi, then transferred on to a privately owned horse and gig transported or a "tin lizzie" to travel over the rough road to the hotel, to quench their thirst.

When the electric tram service began and lines were extended to Waikiwi service cars ran a shuttle service to the hotel.

To cope with the increasing crowds especially those who arrived for special rugby matches management introduced a long U-shaped bar which became known as the longest bar in the Southern Hemisphere and History records that 45 barman stood behind the polished counter.

From the early times the hotel was often used as a venue for meetings.

The Whitehouse Hotel is still a popular meeting place for locals and entertainment venue for young Southlanders.

Celebrations planned over the next week have touches of nostalgia, which will bring many reminiscences alive once more as people recall past personalities who have played an important role in the hotel's long colourful history.

New Owners for Hotel

There's more to running a pub than just pulling a pint reckons one of the new owners of the Whitehouse Hotel, Sinclair Little.

The Little and O'Conner family became proud owners of the popular country hotel two weeks ago, the first private owners for many years. The hotel had been leased and managed by Lion Nathan since the 1970's but this year the company decided to sell the business

Owning and managing a hotel is a new experience for the Littles but not for Michael O'Conner who has worked at the Whitehouse for the past 18 months. The Littles are learning the ropes very quickly. It is a case of having to say's Sinclair Little.

We're aiming to build it up into a thriving family business. The Hotel requires working long hours so you really need the support of family members Sinclair says.

Changes are being looked at but nothing too dramatic is planned. There are thoughts of incorporating the Rafters nigh club into a functions centre although the owners are waiting to see how the place develops in the next year. One thing is certain they won't be destroying any of the charm that the Whitehouse has known throughout Southland for.

The regulars love the way they can enjoy a quiet beer ion their "local" and catch up on the gossip. They've seen the "townies" come and go but Lorneville folk are a loyal bunch and wouldn't go anywhere else.

The staff at the Whitehouse Hotel like to keep an eye on their patrons. They encourage non drinking drivers. A courtesy coach will deliver them back home to town it they're over the limit.

"We want to be known as a responsible drinking venue. We've bought back the courtesy coach so people can come out and not worry about the drive home" Sinclair said.

Punters can place a bet at hotels TAB facilities and if hunger sets in patrons can enjoy a meal at the Bistro. It's open from 6.30pm Monday to Saturday serving up large Country platefuls at a country price.

If you prefer to up a home, Whitehouse Super liquor is part of the nationwide chain. The store is separate building – just a stone's throw from the hotel. This allows the Whitehouse to having monthly nationwide specials although leading up to Christmas the store will have weekly bargains.

The Whitehouse Hotel had comfy and excellent accommodation facilities and a separate quest's dining room.

Since moving into the hotel the Little's have been amazed at the diversity of the business in the area.

It's a hive of activity out here. There's four garden nurseries a berry farm a store fish and chip shop poultry farms cars sales service station a discount centre boarding kennels small engine workshop and a concrete works.

When you start listing them you realize there's a lot more to Lorneville than meets the eye". Sinclair said.

The Whitehouse Hotel has probably been in the area longer than any other of the Lorneville businesses with its origins dating back to 1860. The owners of the well-known pub are keen in retaining its country character and welcome regulars as well as newcomers to visit the establishment.
