Rights Under Will - Shares In An Estate - Validity Of Marriage - A Missing Wife Rather unusual features complicated an action heard by Mr Justice Reed in the Supreme Court yesterday, In which <u>John Thomas William Kempton</u>, a contractor, sought a declaration as to the legal rights of his half-brothers and sisters, six in all, under the will of his grandfather, the late <u>Thomas Kempton</u>, farmer, of Elmgrove, near Greytown, who died on 30th April, 1910. The question, turned on the validity of the second marriage of the plaintiff's father, <u>Henry William Kempton</u>, the contention being made that the marriage was irregular, and that as such the six children of that marriage were not entitled to share in the will of Thomas Kempton.

First Wife Leaves - Henry William Kempton married Margaret Ellen Heslop at Napier on 16th January, 1883, and in addition to the plaintiff there were two other sons of the marriage. Mrs Kempton left her husband in the early part of 1887, and it was set out in the statement of claim that the plaintiff did not know whether she is living or not. On Ist April, 1892, Henry William Kempton married Esther Jane Swan at Pahiatua, and there were six children, the defendants. According to the statement of claim, to the best of the plaintiff's knowledge and belief his mother (Margaret Ellen Heslop) was still living at the time of the solemnisation of the second marriage. The Public Trustee was appointed to administer the estate of the grandfather (Thomas Kempton) in October, 1926, and since then he has collected the income from the residuary real estate and has made distribution of it among fifty-one grandchildren. In view of the doubt existing as to the rights of the defendants the Public Trustee I has made his distribution on the basis of there being fifty-seven shares and holds in suspense a sum of £639 3s 6d representing the shares to which the defendants would be entitled on establishing their right thereto as lawful grandchildren of the testator.

Friendly Action - Counsel for the plaintiff said it was a somewhat remarkable thing that although the grandfather, Thomas Kempton, died twenty-two years ago, the question of the rights of the defendants yet remained, to be determined and upon the Court's decision rested the distribution of the grandfather's estate in part. The proceedings necessarily were brought before the Court in the form of an action, owing to the fact that the sole matter in dispute was the validity of Henry William Kempton's second marriage in 1892. The plaintiff unfortunately was placed in the position of impugning the legality of his father's second marriage, but he had no alternative. The matter came before the Court, however in the nature of a friendly action. From the time the Public Trustee was appointed trustee of the estate, continued counsel, he had been endeavouring to find a solution of the difficulty. Inquiries had been made both in Australia and in New Zealand for Henry William Kempton's first wife, but no trace of her had been found and no record of the registration of her death either in Australia or New Zealand had been discovered. Counsel said there was specific evidence that the missing lady, sometime after 1892, when Henry William Kempton's second marriage had taken place, wrote a letter to the police constable stationed at Greytown to the effect that she would expose him (Kempton) if he married again. Another factor was that the marriage of 1892 was not

recognised as a valid, marriage by the testator and his wife, and by the other members of the family generally

Multitude Of Presumptions – "We seem to be faced with a curious legal position in the multitude of presumptions we have to deal with," said counsel. The plaintiff, <u>John Thomas William Kempton</u>, said that all the time he had lived with his grandparents they, did not recognise the children of his father's second-marriage. Replying to counsel for the defendants, witness said he was unable to say whether his grandmother had had any evidence to support her contention that his father's second marriage was irregular. His grandmother always maintained, however, that his mother was alive when his father married the second time. Other evidence was given by <u>Alice Mary Hawke</u>, of Carterton, sister of <u>Henry William Kempton</u>, and <u>Alfred John Kempton</u>, of Greytown, a brother.

The Defence - Evidence was led for the defence, .with a view to showing that the grandparents, Mr and Mrs Kempton, sen., did not adopt an unfriendly attitude toward the second wife of Henry William Kempton or the six children of the marriage and that there was evidence of the death of the first wife. Witnesses called before the Court adjourned until to-day were Dr. D. G. Johnston, formerly of the Wairarapa and one of the early trustees of the testator's will; Henry William Kempton and his second wife, Esther Jane Kempton and a married daughter of the second marriage. Dr Johnston said the evidence for the plaintiff he had heard in Court regarding the second marriage was quite new to him. As far as he was aware the grandfather, in the disposition of his estate, did not intend making any differentiation.

Valuable Letter - Much of the evidence of Henry William Kempton related to a letter (produced) which he said he received from his first wife's father in 1890, notifying him of the death of his wife in Sydney. His wife had deserted him three years before, and from the outset he had believed she went to Australia with another man. Crossexamined by counsel for the plaintiff, witness alleged that the letter was stolen from among his effects about 1912. He employed a private inquiry agent to look into the matter, and eventually, in 1927, the letter reached the Public Trust Office through the post. Witness was asked why it had been stated to the Registrar at the time of his second marriage that his first wife died in February 1889, if as the letter stated, she died in November, 1890. Witness gave a long explanation. He said he had been away working on the East Coast before the marriage to his second wife and did not have the letter with him. The mistake, he said, was an absolutely honest-one. Replying to other questions, witness denied that his second wife and their children were not allowed near his mother's place while his mother was alive. Esther Jane Kempton, the second wife, said that before she was married she saw the letter Mr Kempton received stating that his first wife was dead and also a death notice in the Greytown "Standard." She married Mr Kempton with the honest belief that his first wife was dead. The Court adjourned until this morning.

Family's Rights - Matrimonial Tangle - Validity Of Marriage - Was Former Wife Dead Was the second marriage on 1st April, 1892, of <u>Henry William Kempton</u>, a Wairarapa farmer, to <u>Esther Jane Swan</u> at Pahiatua, a valid marriage? Upon the answer to, this question, brought before Mr Justice Reed in the Supreme Court for determination, rests the legal, rights of the six grown-up children of this marriage to a share in the residuary real estate of the late <u>Thomas Kempton</u>, father of <u>Henry William Kempton</u>. The plaintiff in the action, which was commenced yesterday is <u>John Thomas William Kempton</u>, a contractor and one of three sons of <u>Henry William Kempton</u>'s first marriage. He has stated that to the best of his knowledge his mother was living at the time of the second marriage. Evidence given yesterday showed that <u>Henry</u>

<u>William Kempton's</u> first wife deserted him in 1887. It was believed that she; went to Australia, and a letter was produced purporting to have been written by the wife's father in 1890 to <u>Henry William Kempton</u>, informing him of his wife's death in Sydney on 15th November of that year. Reference was made in the evidence for the plaintiff to another letter, supporting to have been received by a, Greytown constable sometime after 1892 from the first <u>Mrs Kempton</u>, threatening to expose her husband if he married again. Other evidence related to the attitude adopted by the testator and his wife (the grandparents) in regard to the six children of the second marriage. The evidence for the plaintiff was that they were not recognised, whereas the evidence for the defendants (the six children of the second marriage) was that the old people were not unfriendly toward them. It was also stated on behalf of the plaintiff that, although inquiries had been made in Australia and New Zealand, no record had been traced of the registration of the death of the first Mrs Kempton.

The Second Marriage - Evidence for the defence was completed to-day. Mrs Emily May Armstrong, a sister of Henry William Kempton, said that as far as she knew her brother's second marriage was not disputed. My mother didn't make any comment about it at all to me, added witness. Counsel for the defendants: Did, as your sister Mrs Hawke said, the news of the second marriage cause great displeasure and pain – I don't think so. I think my mother and father were rather pleased, that my brother had settled down again. Mrs Armstrong said she remembered hearing of an announcement in the Greytown, "Standard" of .the death of the first Mrs Kempton. She had never, heard her mother disown the children of her brother's second marriage. The children used to visit Mr and Mrs Kempton, senior, frequently. This concluded the evidence for the defence.

Alfred John Kempton, brother of Henry William Kempton, was recalled by counsel for the plaintiff. In regard to the letter he said the Greytown constable had shown him in 1890, he declared emphatically that he knew the first Mrs Kempton's handwriting. He was prepared to swear that on his dying oath.

Legal Argument - Counsel for the defendants submitted that the presumption that the first wife was alive conflicted with the presumption of the validity of the second marriage, and that one presumption cancelling the other, the matter became one of fact. His view was that the burden of proof was on the plaintiff and that there must be specific proof. He submitted that on the cases where the parties had been married for thirty or forty years, the irrefutable presumption of law was raised against the marriage being invalid. Counsel, in dealing with the evidence, claimed that the plaintiff had not brought forward a scintilla of proof that the first wife was alive at the time of the second marriage. There was only the evidence of Mr A J Kempton as to having seen a letter, but it was submitted the Court would, not attach much importance to that. An important factor, it was suggested, was the fact that there, was nothing clandestine about the second marriage. It was public property. Counsel submitted that, Mr Henry William Kempton's story rang true in every detail; and that there was no proof that his first wife was alive in 1892.

Father-In-Law's' Letter - Dealing with the letter, purported to have been received from the first wife's father, counsel for the plaintiff said it conveyed the news that some third party had informed the wife's father of her death. It was a most remarkable thing that an official record of the wife's death had not been obtained at the time. His Honour pointed out that Kempton's father-in-law died shortly afterwards, and Kempton had said that he had received information from shepherd friends in Australia that his wife had adopted an alias. Counsel: He evidently had knowledge of her existence sometime after her disappearance. He did not assert however, that his shepherd friends told him his wife was dead. 'His Honour said that the letter Kempton said he received from his father-in-law presented the appearance of an old letter. He thought it was obvious the letter was written probably about the time it

purported to have been written. Whether it was a forgery was another matter, but if it were a forgery it was a very far seeing act. Counsel submitted that, the letter was the only concrete evidence of the first wife's death. After Mr Kempton contemplated his second marriage, it was as material for him to have such a piece of evidence then as it was now. The most extraordinary thing to his mind was that at least six months before the letter mysteriously arrived at the Public Trust Office through the post in 1927 Kempton had made a declaration in accordance with the date given in the letter that his first wife died on 1st November, 1890, whereas at the time of his second marriage the date of his first wife's death had been given as 19th February, 1889. Henry William Kempton went into the witness box again at this stage, and in reply to his Honour said that when the Public Trust official asked him the date of his first wife's death he answered him straight away from his memory. Counsel contended that another extraordinary fact about the letter was the statement annexed to it upon its receipt at the Public Trust office.

In A Quandary – "Quite frankly", said counsel I'm in an absolute quandary as to whether the document is genuine or not in itself, but I do suggest that Mr Kempton himself sent that document to the Public Trustee. His Honour: I cannot see what the object could be. Counsel: All I am saying is that the circumstances are suspicious. His Honour: Isn't there a strong presumption that the first wife must have died somewhere about 1890, or else would have been heard of? - I submit not, particularly in view of the letter Mr A J Kempton said he saw. His Honour: That letter is a very unsatisfying piece of evidence. His Honour said the case was an important one and he would take time to consider his decision. His view was that it was a pity that it should have been found necessary to bring the case before the Court. - Both counsel assured his Honour that every endeavour had been made to settle the case out of Court.

Shares in Estate - Marriage held valid - Kempton case decision - Only one inference -Reserved judgment was delivered in the Supreme Court to-day by Mr Justice Reed in the case heard last week in which John Thomas William Kempton sought a declaration as to the rights of the six grown-up children of the second marriage of his father, Henry William Kempton, to share in the estate of his grandfather, the late Thomas Kempton. The validity of the second marriage was attacked, and also the legitimacy of the children of that marriage. Mr Justice Reed said he was satisfied that the only inference possible on the proved facts was that the first wife was dead when the disputed marriage was contracted. His Honour made a declaration that the defendants, exclusive of the Public Trustee, are the legitimate and lawful children, of Henry William Kempton and as such are entitled to share according to the terms of the will, in the estate of the late Thomas Kempton. The Public Trustee claimed no pecuniary interest in the result of the action and in the formal statement of defence that was filed stated that he submitted to the Court's judgment. For some years the residuary real estate of the late Thomas Kempton has been administered by the Public Trustee, who has annually divided the proceeds among 51 grandchildren of the testator, less a sum of money retained in suspense and sufficient to satisfy the claims of the six children of H W Kempton's second marriage on their establishing their rights as lawful grandchildren of the testator. This amounts at the present time to £639 3s 6d, and there is an unrealised property valued at £1100.

Plaintiff's Contentions - <u>H W Kempton's</u> first wife (the mother of the plaintiff) left him. in the early part of 1887, and on 1st April, 1892, he went through a form of marriage with <u>Esther Jane Swan</u>, and the issue of this, marriage are the six grandchildren whose claims were disputed. The plaintiff (<u>John Thomas William Kempton</u>) claimed

that at the date of his father's second marriage the first wife was living and that therefore this marriage was invalid and the children born of it illegitimate and therefore not entitled to share in the estate. After reviewing the various aspects of the case his Honour said the position was that there was no acceptable evidence that the first wife was alive when the disputed marriage took place, he attached no value to the evidence of the letter supported to have been received shortly after H W Kempton's second marriage, by the local constable at Greytown from the first Mgrs. Kempton. Nor was there any evidence, continued his Honour, that she died prior to that date; the letter received by H W Kempton from her father, Thomas Heslop, to the effect that his daughter was dead, spoke from hearsay. The factum of the second marriage was fully proved.

The Legal Presumption - There was no legal presumption in favour of the continuance of life up to any particular, period; it was a question for a jury as a matter of fact. On the other hand there was a legal presumption, against the commission of a crime against Henry William Kempton having committed bigamy. This latter presumption was not fully effective in the present case, for if Henry William Kempton was able to prove that he honestly believed on reasonable grounds that his first wife was dead when he went through the second ceremony of marriage that would be a complete answer to a charge of bigamy. Nevertheless, the marriage would be invalid if the first wife was in fact alive at that time. The full extent of the presumption, therefore, was that Henry William Kempton had, reasonable grounds for believing, and honestly believed that his first wife was dead when he went through, the ceremony of the second marriage. Other presumptions of law applicable to a marriage de facto were discussed by his Honour. In this connection, his Honour said that a marriage, prima facie valid, being established, evidence of cohabitation with a general reputation of marriage, afforded a strong presumption that there, was no legal impediment to the marriage. His Honour found on the facts of the case that the first Mrs Kempton was dead when the disputed marriage was contracted.

Reason For The Action - After judgment had been delivered his Honour heard the three counsel representing the parties on the question of costs, ultimately reserving the matter, for further consideration. His Honour reiterated the view, which he expressed at the conclusion of the trial, that it was a pity the case had been brought before the Court. For a son to take action to show his father up, as it were, appeared to hint to be an extraordinary state of affairs. Counsel for the plaintiff agreed that on the face of it that certainly appeared to be the position. However, the matter did not rest with the members of the first family. The second family had taken no action to establish their rights, and the deadlock having continued so long it was essential that the matter should, be brought before the Court. Counsel representing the Public Trustee also said that the general feeling among the many grandchildren of the testator was that the matter, should be tested in Court.

Henry William KEMPTON first wife Margaret Ellen HESLOP left him about 1887 and disappeared. Evidence from a Court case reported in an newspaper article stated that efforts were made in New Zealand and Australia to locate Henry's first wife but with nil results. Henry gave evidence that he receive a letter from his first wife's father notifying him of the death of his wife in Sydney 15 November 1890. He had believed she went to Australia with another man. The Registrar at the time of his second marriage said that the first wife noted that she died on 19 February 1889. There was also a statement that a death notice was placed in the Greytown "Standard" newspaper.
