HUTT VALLEY LAND DEEDS 1845-1851

I have not fully transcribed Deed Volume 1 but have listed information where it links to someone residing in the Hutt Valley or where the Hutt Valley district is recorded. Recorded in register No 1 are details regarding the shareholders and absent land owners in England with full names and residence. The French Company purchased land at Akaroa and the deed lists the names of the immigrants. The most important are the deeds that cover the sale of land by the Maori in Wairau, Wellington and Rangitikei Wanganui and where the treasured marks and signatures of numerous Maori chiefs and Elders are recorded.

The deed was signed by Robert HART Solicitor of Wellington, William SWAINSON, Emma SWAINSON, Mary Frederica SWAINSON and Henry SWAINSON settler of River Hutt

Deed Volume 1 folio 201 to 205 No 58 date 12 December 1842 mortgage (Wellington district) between Richard BAKER Esq. of Wellington and John SMITH Esq. bank manager of Wellington. Folio 205 contains an image which details a Public House situated next to the Native Pah on Section 3 at Kai Warra north of Wellington towards the Hutt.

Deed Volume 1 folio 530 to 531 No 166 date 30 May 1849 Conveyance between William SWAINSON Esq. of Hawkeshead House River Hutt and Richard OÇONNELL Captain of the 65th Regiment of Wellington. Sections 567 Tinakore Road Wellington.

Deed Volume 1 folio 532 to 533 No 167 date 02 April 1847 Conveyance between John DOREST surgeon of Wellington and William DORSET merchant of Wellington. Various land situated in Wellington. Section 75 in the lower valley of the Hutt selected by land order number 347 to be leased to Henry STILLING. Mentioned also is Samuel Charles BREES and David LEWIS. Section 75 boarders section 28, sections 115, 129 & 186 and river Hutt section 37 and sections 31 which are next to road Lower Hutt District sections 29, 32, 35, & 38. (image)

Deed Volume 1 folio 559 to 560 No 180 date 27 October 1849 Conveyance between William SWAINSON Esq. of Wellington and George HART sometime of Wellington but now of London England and The New Zealand Company. Wai Nui Glen in the district of Wai Nui Omata section 34 (west part section 26, north west un-surveyed, north east section 35, south east un-surveyed) section 35, section 36 and section 37. (image folio 560)

Deed Volume 1 folio 563 to 566 No 182 date 30 June 1849 Conveyance between The New Zealand Company and Laurent RAILLARD No 20 and Rue de Vaugerard Paris France present Taboliniere Hotel Leicester square London England acting as a liquidator for the French Company of New Zealand also known as Nauto Bordelaise Company formed in France with the sanction of the French Government for the acquisition of land for a party of immigrants to Banks Peninsular named "Akaroa". Folio 565 and 566 list all the names of the purchasers and other details. Well worth looking at if you have French ancestry.

Deed Volume 1 folio 590 to 591 No 194 date 01 September 1848 (01 August 1838) Conveyance between Daniel RIDDERFORD sheep farmer of Oronga Oronga in Port Nicholson and James Nelson BURCHAM Licensed Victualler of Lower Valley of the Hutt area. District of Lower Valley in the Hutt section 17 (Mary MOLESWORTH & Daniel RIDDERFORD) (situated north untended, south Whites Line, east by the river, west old line road up the valley). Witness Henry Shafts HARRISON Settler River Hutt. (image folio 591).

Deed Volume 1 folio 599 to 609 No 198 date 11 March 1850 Trust Deed for the benefit of creditors between James SMITH & John Howard WALLACE merchants and auctioneers of Wellington and William FITZHERBERT and William Barnard RHODES merchant creditors of Wellington. Land in Wellington, Porirua, Kinapora and Horikiwi. Folio 608 & 609 list of Debtors and records 2 pages of names and amount due from each to the creditors Smith & Wallace. This is a rich list of people who not only reside in the Wellington district but also other parts of the region including the Hutt Valley. (image folio 608 to 609)

Akaroa settlement on Banks Peninsular with land description and map (image folio 622)

Also mentioned John WRIGHT, Robert MUNRO, Harriet wife of George Samuel EVANS, Joshua EVANS, Richard David HANSON & Edward CHETHAM.
