Peter Anderson WILKIE was the Postmaster at Upper Hutt from 24 October 1859 to 30 June 1875.

Mr Michael MAHER stationmaster <u>Postmaster and Telegraphist at the Upper Hutt</u> was born in Clonmel Ireland in 1842. He attended the National School until eleven years of age when he accompanied his parent's to Melbourne in the "Oceanic" landing in Wellington in 1856 from the mail schooner "Marchioness". The family secured a farm at Te Aro and the subject of this notice worked in the farm with his father for some time after which he was appointed overseer on the farm of the late Hon W D Rhodes at Wadestown. Mr Maher occupied this position for fifteen years joining the railway service in 174 as goods clerk in Wellington. When the railway was

opened to Eketahuna in 1889, Mr Maher was sent to take charge of that station from which he was transferred to the <u>position he now holds in April 1894</u>. As a volunteer Mr Maher belonged to No 1 Company Thorndon Rifles during the time of the Titokowaru disturbance but was never in action.

He retired on superannuation after 40 years service (1881 to 1921). His first appointment as stationmaster was at Pukerau 91 miles south of Dunedin and 9 miles north of Gore whence he was transferred to <u>Upper Hutt</u>, Te Aro, Taihape, Waipukurau, Hastings and finally Petone in that order. On retirement in 1921 he took up residence in Miramar. 

The first Post Office in the Upper Hutt district was once situated on the corner of what is now Fortune Lane (marked Road Way) and Ferguson Drive. Mr Peter Anderson Wilkie was appointed Postmaster at Upper Hutt on the 24 October 1859. The Post Office may have been opened at an earlier date but the first records available recording Mr Wilkie as postmaster was in 1859.

The first purpose built Upper Hutt Post Office was situated on part Section 128 land owned by the Wellington to Masterton Railway but originally owned by the pioneer settler James Brown. The block of land was purchased by Railways to accommodate the Upper Hutt Railway Station and staff housing. The first Post Office was built on the corner of Geange Street (formerly Station Street) and Main Street in the Upper Hutt township.

It is not known were the Post Office was situated perhaps it was in the dwelling of Mr Wylie. It was not as some state near the south corner of Main Street and Geange Street (formerly Station Street). The land for the next post office was not purchased until 1878.

The Post Office site of 30 perches was purchased in 1878 for £3 9s 0d. When the office was removed from the non-permanent status to the control of the Railway Department the office was established in the Railway Station and the old building was leased to various tenants until in 1894 it was handed over to the Justice Department for use as a Courthouse. Owing to increased population entailing extra work for the Railway Department's Staff it was decided to erect a permanent post office at Upper Hutt. Tenders were called and Messrs R A Wakelin and Sons Wellington were successful. The two storied brick building was opened by Sir J G Ward on 02 April 1909. This new building was built on the site of the Courthouse which was moved back to make room for the new post office. Renovations and repairs were carried out in 1924, 1929, 1931, 1932, 1934 and 1936.

Comment: As a result of the 1986 State Owned Enterprises Act, from 1987 the services previously performed by the NZ Post Office were split between NZ Post Limited, Post Office Bank Ltd., and the Telecommunications Corporation of NZ Ltd (Telecom). Telecom was sold in 1990. In the late 1980s Archives & Museum Section of Telecom Corporation of NZ Ltd in Wellington had a set of cards listing details of the employees at the different early Post Offices in the Upper Hutt district. Many of these cards are over 100 years old and include information about the other smaller Post Offices in the Upper Hutt district.

Question: Where are these cards now? Are they accessible to research for the general public?

The Telecom shop at Upper Hutt was transferred to Lower Hutt on 21 September 1987 thus ending an area of service which has been provided locally for more than 75 years.
