**Comment**: As a result of the 1986 State Owned Enterprises Act, from 1987 the services previously performed by the NZ Post Office were split between NZ Post Limited, Post Office Bank Ltd., and the Telecommunications Corporation of NZ Ltd (Telecom). Telecom was sold in 1990. In the late 1980s Archives & Museum Section of Telecom Corporation of NZ Ltd in Wellington had a set of cards listing details of the employees at the different early Post Offices in the Upper Hutt district. Many of these cards are over 100 years old and record details about the other smaller Post Offices in the Upper Hutt district.

Question: Where are these cards now? Are they accessible to research for the general public?

The Telecom shop at Upper Hutt was transferred to Lower Hutt on 21 September 1987 thus ending an area of service which has been provided locally for more than 75 years.

## Heretaunga South Post Office 1983-1986

(Formerly Trentham Camp P.O. relocated 1983 to back of Central Institute of Technology)

### 21 November 1986

Chief Post Office Wellington – Trentham Camp Post Office was relocate in early 1983 to the back of the Central Institute of Technology grounds in Heretaunga and renamed Heretaunga South. Since the shift transactions at Heretaunga South have been on a rapid decline. A major factor is the location of both the Trentham and Heretaunga Post Offices. In the case of Trentham this office is located in a shopping complex which as you will appreciate attracts customers because of the shopping environment. Furthermore Heretaunga is located on a busy

thoroughfare and as a result attracts customers. In comparison Heretaunga South is located in a complex which has very little if any public access and deals almost solely with staff and students from the Institute a situation similar to that of the Herd Street Post Office. In this regard should Heretaunga South close I can foresee no problem with customers transacting their business at either Heretaunga or Trentham which are both in close proximity to Heretaunga South.

Agnus McCurdy - Born in Birmingham England father Scottish wife Mary Ann nee JONES who lived to 104

In 1880 came to NZ as a Telegraphist and electrician for the Telegraph department and was dismissed in 1904 for secondary employment activities as organiser for New Zealand Farmers Union (now Federated Farmers).

In 1908 He was on the Town Board as Town Clerk, Health officer and inspector of Nuisances. His salary was £50.

1891 He started to build a lodge on opposite side of the River to Whakatiki Street and named it Bonnie Glen, the lodge was to be used as a Hotel for Hunters of deer which he intended to introduce. The lodge was never finished.

He built the first picture Theatre. It was the first Theatre in Upper Hutt to have talkies.

He was a publisher, editor and reporter of Upper Hutt's first newspaper.

He was Upper Hutt's first Mayor the election was on the 26<sup>th</sup> February 1926. He had four terms as Mayor 1926-27, 1931-33, 1933-35, 1935-38

He died in 1941 at the age of 90.

Chief Post Office Wellington – Trentham Camp Post Office was relocate in early 1983 to the back of the Central Institute of Technology grounds in Heretaunga and renamed Heretaunga South. Since the shift transactions at Heretaunga South have been on a rapid decline. A major factor is the location of both the Trentham and Heretaunga Post Offices. In the case of Trentham this office is located in a shopping complex which as you will appreciate attracts customers because of the shopping environment. Furthermore Heretaunga is located on a busy thoroughfare and as a result attracts customers. In comparison Heretaunga South is located in a complex which has very little if any public access and deals almost solely with staff and students from the Institute a situation similar to that of the Herd Street Post Office. In this regard should Heretaunga South close I can foresee no problem with customers transacting their business at either Heretaunga or Trentham which are both in close proximity to Heretaunga South.
