#### Transcription of the Chatsworth Estate subdivision plan

Silverstream – The Sylvan Retreat of the Hutt Valley – Charming sites for Week-End Bungalows or Permanent Residences. Situated between the Railway Station and the Golf Links – Served by 18 Trains Daily – CHATSWORTH ESTATE – To be sold at Public Auction by Geo. Thomas & Co in conjunction with McKee & Co Ltd – Chamber of Commerce, National Mutual Buildings, Customhouse Quay on Wednesday the 27<sup>th</sup> February at 8 pm.

Silverstream is generally conceded pride of place as the most Beautiful Spot in the far-famed Hutt Valley. Progress is indicated on every hand. Silverstream is destined to be the Sports Ground of the Metropolis. Already on eof the finest Racecourses in New Zealand is located The Rifle Range too is an attractive feature, and now the Wellington Gold Club (numbering 200 members) has bought the freehold of about 100 acres for its Links. ## **Chatsworth Estate street name origins**

**Chatsworth Road** 

Chatsworth Road was perhaps named after Chatsworth House in Derbyshire England. Wises NZ Post Office Directory volume 2 1955 & 1959 & 1961-1962 recorded Chatsworth Road.

### Whitemans Valley Road

Whitemans Valley Road was named after the George Whiteman who discoverer the valley while pig hunting. George was the first to settler in the valley and George & William Whiteman established their farm in 1871-1875 in the Valley. Wises NZ Post Office Directory volume 2 1955 & 1959 & 1961-1962 recorded Whitemans Valley Road. The Upper Hutt Borough Council made a decision to rename Whitemans Valley Road to Bathurst Street – "Whiteman's Valley road to be called Bathurst street" reference Papers past website Evening Post newspaper 30 April 1930 page 16. The Silverstream ratepayer and Upper Hutt residents objected strongly to the Whitemans Valley road being change to Bathurst street so the Council at a meeting decided that the road would remain unchanged reference Papers past website Evening Post newspaper 05 August 1930 page 15. Whitemans Valley Road was later renamed Whitemans Road as it is the road that leads to Whitemans Valley.

# **Chatsworth Estate Silverstream Newspaper Articles**

## Evening Post newspaper 16-27 February 01-07 March 29 October 1907

Preliminary Notice – Silverstream - The Sylvan Retreat of the Hutt Valley - Charming Sites for Weekend Bungalows or Permanent Residences. Situated between the Railway Station and the Golf Links, and served by 18 Trains daily. George Thomas and Co. (in conjunction with McKee and Co Ltd) have received instructions to sell by public auction, at the Chamber of Commerce, Customhouse Quay, on Wednesday Evening, 27<sup>th</sup> instant at 8 o'clock. That well-known property, The Chatsworth Estate, comprising 30 acres of almost level land, subdivided into 13 Sections, ranging in area from 1½ to 6½ acres. Several of the sections are partly adorned with native bush. Further particulars later. Plans may be had on application. McKee and Co., Ltd., 1, Panama-street.

#### Evening Post newspaper 02 January 1908

During the holidays an individual's carelessness was responsible for much damage at Silverstream. The flames were started in a section of the Chatsworth Estate and marched onwards through a portion of the bush on the hill to the cast of the railway station. A week ago there was a beautiful wooded slope now the verdure has an ugly scar. The fire swept through an orchard owned Mr McKee and ruined several acres of fruit trees. Inmature apples, apricots, peaches, paers, baked saddened the proprietor when he visited the spot yesterday. The flames also devoured some of the bush on property owned by Mr F Earle and advanced to the Government Reserve and into other bush beyond the estate named before their appetite had been satiated. Yesterday several holders of land were obliged to devote their holiday leisure to the burial of smouldering logs which threatened further conflagration.
