Township of Hokowhitu & Reayville Upper Hutt – 1905

Part section 120 Block 1 Rimutaka district

The Township of Hokowhitu subdivision was submitted for approval in 1905. There was already a Township of Hokowhitu in the Palmerston North district so the subdivision was renamed "The Township of Reayville". The Township of Reayville in Upper Hutt was developed in 1905 on part Section 120 Block 1 Rimutaka District. Messrs Mabey and Benge were the developers.

I have located 3 plans of the subdivision [1] first was submitted under the title Township of Hokowhitu [2-3] the two other maps under the title Township of Reaville.

Township of Reayville street names and their origins

Hutt Main Road / Main Hutt Road

Main Hutt Road no longer exists and was renamed Fergusson Drive. The first road from Wellington was completed to Taita in 1843 and to Upper Hutt in 1844. The road was first known as the New Zealand Company Road, followed by Company Road, then Great North Eastern road, then Old Military Road, Main Hutt Road and/or Hutt Road, Main Road & Main Road North and/or Main Road South & and finally Fergusson Drive except for Main Street which is situated in the Central Business district of Upper Hutt. Fergusson Drive was named after His Excellency the Governor General of New Zealand Sir Bernard Fergusson. He declared Upper Hutt a City in 1966. Fergusson drive runs between the districts of Heretaunga, Trentham, Elderslea, Upper Hutt, Ebdentown, Clouston Park and ending at Brown Owl.

Fergusson Drive

Fergusson Drive was named after His Excellency the Governor General of New Zealand Sir Bernard Fergusson. He declared Upper Hutt a City in 1966. Fergusson drive runs between the districts of Heretaunga, Trentham, Elderslea, Upper Hutt, Ebdentown, Clouston Park and ending at Brown Owl. The first road from Wellington was completed to Taita in 1843 and to Upper Hutt in 1844. The road was first known as the New Zealand Company Road, followed by Company Road, then Great North Eastern road, then Old Military Road, Main Hutt Road and/or Hutt Road, Main Road & Main Road North and/or Main Road South and finally Fergusson Drive except for Main Street which is situated in the Central Business district of Upper Hutt.

Queen Street

Queen Street was named after the Queen of England. Queen Street was already established when drawn on the 1908 Plan of Upper Hutt Township Estate. Wises NZ Post Office Directory volume 2 1955 & 1959 & 1961-1962 recorded Queen Street.

<u>Unnamed Street</u> on 1 plan [later named King Street]

On the Township of Reayville subdivision plan the street was unnamed. It was later given the name King Street.

King Street [unnamed Street]

King Street was named after the King of England. King Street was recorded on the 1908 plan of the "Upper Hutt Township Estate". Wises NZ Post Office Directory volume 2 1955 & 1959 & 1961-1962 recorded King Street. The Dominion Estate also recorded a King Street on their subdivision plan but the name was changed to Gibbons Street.

Lands and Survey Department records

- 12 February 1906 = Letter from Surveyor General to Chief Surveyor Referring to your memorandum of the 28th December last, I return in separate parcel, the plan of the Township of Reayville, approved by the Governor in terms of section 18 of "The Land Act 1892".
- 03 February 1906 = letter head His Excellency the Governor is respectfully advised to sign as approval the accompanying plan of the Township of Reayville, Wellington Land District, in terms of section 18 of "The Land Act 1892". Signed Minister of Lands Duncan
- 25 January 1906 = Memorandum from Chief Surveyor to Surveyor General Township of Hokowhitu The surveyor has submitted the name "Reayville" in lieu of "Hokowhitu". If accepted will you please have the name amended on the plan with you.
- 10 January 1906 = Memorandum from Chief Surveyor to Surveyor General Township of Hokowhitu I have the honor to acknowledge receipt of your memo No 50236 of the 5th instant in reference to the above subdivision. This is not part of the subdivision known as Hokowhitu near Palmerston North which is possibly the one you refer to. I have written to the surveyor asking him to suggest another name to avoid any confusion with the existing one.
- <u>Plan</u> [1] = Township of Hokowhitu Reayville Upper Hutt 1905 part of section 120.
- 05 January 1906 = letter from Surveyor General J W A Marchant to Chief Surveyor Township of Hokowhitu referring to your memorandum of the 28th ultime forwarding plan of the Township of Hokowhitu for this approval of His Excellency the Governor under section 18 of "The Land Act 1892", I have to inform you that the plan will be recommended for approval.

Before doing so, however I should like to know if this is the Hokowhitu Township which has I understand been in existence from some years in the Wellington District, because if not another name will have to be submitted. Kindly advise me as soon as possible on subject.

 28 December 1905 = Memorandum from Chief Surveyor to Surveyor General – Township of Hokowhitu I have the honor to herewith plan of the above Township for His Excellency the Governor's approval, in terms of Section 18 of "The Land Act 1892". It is situated at Upper Hutt its position being shewn on locality plan in margin. King and Queen Streets are 66 feet wide, which I think sufficient in this locality, and I beg to recommend plan for approval. 




The map above had the name Hokowhitu but this had been crossed out and written above it was the name Reayville.
