## **ESTATES & DISTRICTS IN THE UPPER HUTT AREA**

The Hutt Valley was named after Sir William Hutt a British MP and chairman of the New Zealand Company. Sir William Hunt never came to New Zealand. However his great, great, granddaughter Lady Trail visited the Hutt Valley in May 1991. She was formerly Sarah Hutt who married Sir Alan Trail Lord Mayor of London. Lady Trail said she and her sister were the last of the Hutt line and that she was the first of the family to visit the Hutt Valley. The Hutt Valley was originally known by two names [1] Hutt - Lower and [2] Hutt - Upper. In the 1950's they became known as Lower Hutt and Upper Hutt.

The major development to the Township of Upper Hutt and Main Street and the surrounding area began between 1900 and 1910. Other subdivisions and roads surrounding central Upper Hutt began around 1907. The first development in central Upper Hutt began with George Brown gifting the Railway Department 28 acres for the railway station and yards. The following subdivisions were Melbaville, Waldegrave and Dominion Estate.

I have compiled the list below by researching at various repositories which include the 1991 publication "*Upper Hutt The History*" by J A Kelleher, Upper Hutt City website, Archives NZ Wellington Survey and Land Department records, Wises New Zealand Post Office Directories, newspaper collections searchable on Papers past website and numerous other websites, local publications and information from Upper Hutt residences.
