Prior to that date he served twelve years in the Postal Service of the United Kingdom. In 1901 he was appointed Postmaster at Ohaeawai Bay of Island and in 1909 he became postmaster at Upper Hutt. Mr Comesky who was a valued officer of the Department was a well-known bowler. #Accidents and fatalities - A bush casualty death of a sawmiller - At Whiteman's Valley Upper Hutt last Wednesday, Christopher Henry Clausen, a sawmiller met with an accident which ended fatally on Saturday. The circumstances were investigated at the house of deceased, Bridge Street Lower Hutt at 7 o'clock on Saturday evening by Mr Alexander Simpson deputy coroner. Evidence was given by William Baker, an employee of deceased. He stated that about noon last Wednesday he and deceased started to jack a log from the ground on to a trolley. The log would be about 20ft long and contain about 900 superficial feet of timber. They had almost accomplished their task when the chain from which deceased was jacking broke, causing one end of the log to fall. Deceased tried to jump clear but the log caught him and jammed him against a stump. Witness extricated deceased in about a minute's time by jacking the log clear of him. When he did this deceased remarked, "I'm done." Witness at once got assistance from the bush and carried him to the road, where he was placed on a vehicle and driven home. Michael Morran, brother in law of deceased stated that Mr Clausen was a married man about 40 years of age with a wife and five children. His wife was seriously ill and unable to attend the inquest. Dr Hector deposed that he was called to see deceased. He was then on his way from the Upper Hutt in charge of Dr Handcock. On Friday morning witness performed an operation with Drs Young and Ross and found an extensive internal hemorrhage. Death occurred next morning and was due to internal hemorrhage and shock. All that could be done for him was done. Brown (NZR), J Harrison and H Shaw. Nomination paper lodged on Monday evening March 15 – Virgil McGovern is a young New Zealander born at Kaitangata (Otago), a quarter of a century ago. He was educated primarily at Kaitangata and Taita State Schools and afterwards attended a three years course at St Patrick's College. He has considerable interests at stake in the township, the McGovern properties being valued at over £5,000 for rating purposes. This candidate has taken a keen interest in local politics and sports for the past ten years. At the Biennial Election of 1912 he withdrew his nomination on the Advance Upper Hutt policy side so as to avoid splitting votes. On March 4th while travelling to Wellington W Greig suggested V McGovern that if McGovern would stand for election he (Greig) would not be a candidate. Seeing that at the close of last Monday's town board

meeting no one had been nominated, McGovern decided to become a candidate and lodged a nomination. Evening Post newspaper 30 March 1914 - Story of the fire from the first alarm

No danger anticipated then the fatal explosion - The origin both of the fire and of the subsequent explosion is enveloped in complete mystery at the present. Messrs Benge and Pratt the proprietors of the store, left the premises on Saturday night about half past nine after making the usual tour of inspection. About half-past eleven Mrs Crabtree wife of the landlord of the Provincial Hotel, which is situated on the section adjacent to that on which the store stood, observed smoke percolating through the roof of the store. She at once gave the alarm and Constable Denis Mahoney the local police officer was at once summoned. He came and saw the position and went away with Mr RG Mabie, who had just arrived from town by the late train, to knock up the proprietors Messrs Benge and Pratt. When the party returned they found that a number of other residents had arrived on the scene, including a dozen railway men or so, who had come down from the station.

Getting out the stock - There does not appear to have been instant recourse to the fire hose and the use of the high pressure water supply with which the township has lately been equipped. There is no fire brigade in the Upper Hutt and all that was available in the way of firefighting apparatus was a hydrant and a hose 150 feet long, belonging to the Town Board. This was locked up and when Mr WG Goss Town Board water inspector, came to get it he had to break open the gate with his helpers, including Messrs A Hunter and Smith of the Government Laboratory, Benge, Milligan and others. This all took time and in the meanwhile the fire was gathering strength. Constable Mahoney organised the spectators into a band of helpers, to rescue the stock. About thirty were now on the spot and all joined in the good work. The books were all saved and a quantity of the stock. There was absolutely no indication of any extraordinary danger. The fire appears to have been at this above and at the back of the shop part of the building. It was like any other fire where property has to be saved.

At Midnight - It was then midnight and the fire was making headway. Fortunately for later developments it was a calm, warm night, with no wind to fan the flames. So far only those living in the immediate vicinity and those whose duties, as at the railway station, kept them up at so late an hour were about the place, with numbers gradually but slowly increasing. Had it been the previous night when there were crowds at the picture show in town the subsequent calamity might have been far worse, for there would then have been a throng of sightseers in front of the burning building and in line with the flying debris of the explosion, which wrought such havoc. The hose had not yet arrived, but the flames now licking about the roof to the rear of the old store a low building with a gable upper story began to threaten the Provincial Hotel alongside. The proprietor Mr Crabtree was up on the veranda overlooking the fire with Mr M Toohey who was playing a small garden hose on the roof of the burning building. The boarders in the hotel were up and preparing to get out with their belongings. Mr Samuel Hill Government Valuer, was gathering his plans and papers from a parlour on the ground floor overlooking the alleyway between the store and the hotel. A small party of helpers was getting out Mr Crabtree's motor car and managed to drive it through into the street and out of the way. It is said another car was also run through the gauntlet of the alleyway just in time.

Where the men were - Mr Herbert Benge after assisting the volunteers with the removal of his safe from the back of the store, out into the street, had returned again, and was with his partner, Mr Herbert Pratt at the back of the store again shifting stuff out of the bake house. Mr Pratt with a garden hose, was endeavouring to prevent the spread of the fire, which was now well going in the centre and rear of the building from spreading to the premises of Mr Hazelwood next door, and Mr Edwards's stables. With them were Mr RG Mabie and others. James Comesky the postmaster with a laudable zeal to save Government property, had gone into the little office of Mr Edwards the carrier, at the corner of Benge and Pratt's building, and was trying to pull off the telephone and get it away. Constable Mahoney with the volunteer band, had got the books out of Edwards's, and were in the shop working hard to save everything that could be saved in time, for the hose was not yet ready. The fire had crept up from the back and was now going strong up above in the upper story. In the shop were so far as can be ascertained, RF Storey, Alan Anderson, George Taylor, William Flynn, Herbert

Weaver, A. G. Collett, Thomas Costello, GH Lay, Everary [sic] Pelling, Vigil McGovern, Charles Walters, Norman Williams, John Wesley Vivian, and Constable Mahoney. They were moving quickly about picking up goods and carrying them out or handing them to others. There was a constant stream of the workers moving in and out of the building. Where each one exactly was when the explosion took place is almost impossible to say as most of them suffered so much by the shock that their recollection is far from clear of the actual occurrence. At all events there were about thirty people shortly after midnight actively engaged in salvage operations and others look on further away.

The Unfortunate Men - Biographical Sketches - The tragedy has removed from Upper Hutt one of the best known figures in the community in Constable Dennis Mahoney. He was an attendant at all public function in the township during the last nine years, and he was universally liked. He was born in Ireland thirty eight years ago and on coming out to New Zealand he engaged in mining at Waihi and Karangahake. Fifteen years ago he joined the Police Force. He was a fine stamp of man and a noted athlete. He was an adept wrestler and a heavyweight lifter, he was first stationed at Lambton quay and later was transferred to Woodville. In 1905 he was placed in charge at Upper Hutt. The late constable who was well known throughout the Dominion, has left a wife and three young children.

Walter George Taylor was only 19 years of age and resided with his parents at Upper Hutt. He joined the Railway Department two years ago and was making good progress.

William D Flynn was stationed at Upper Hutt. For the last seven years he had been engaged on trains in the Lambton Upper Hutt service and was well known by constant suburban travellers. He was married and leaves a wife and five step sons. He was born at Dunedin thirty-seven years ago.

John W Vivian a grocer's assistant was also a native of Dunedin. He was 35 years of age and for some time he was in business for himself at Lower Hutt.

Mr Michael Toohey was born in Tasmania about fifty-five years ago and was employed in sawmills in that country before he came to New Zealand. He was a fine axe man and was in the employ of the Maymorn Estate Company for some time.

Mr James Comesky was 55 years of age and joined the Post and Telegraph Department as a telegraphist in Auckland two days before Christmas 1881. Prior to that date he served twelve years in the Postal Service of the United Kingdom. In 1901 he was appointed Postmaster at Ohaeawai Bay of Island and in 1909 he became postmaster at Upper Hutt. Mr Comesky who was a valued officer of the Department was a well-known bowler. He has left a widow and several children, most of whom are grown up.

Injured Men in Hospital - A report from the Hospital today states that Pelling who was injured about the head, is in a serious condition. He is still unconscious. Hagan who sustained severe scalp wounds is a little easier. There has been a decided improvement in McGovern's condition since yesterday. He was cut about the head, legs and arms and several pieces of glass which had become embedded in his flesh have been removed.

Six lives lost tragic fire at Upper Hutt - Explosion in a burning store, scatters death among band of helpers postmaster and constable among the dead. Two railwaymen killed and several wounded. Origin of explosion a mystery. Shortly after midnight on Saturday at the township of Upper Hutt a tragic calamity occurred. A small store was discovered to be on fire just before midnight and in the interval before the fire hose could be secured a band of helpers, including many local residents and railwaymen, entered the burning building and endeavoured to save as much of the stock as possible. While they were thus engaged inside and just outside the store a terrific explosion occurred inside and completely wrecked the whole premises. Four men were killed outright, one died soon afterwards and a sixth man succumbed to his injuries shortly after reaching Wellington Hospital early on Sunday morning. Several others were more or less severely Injured with the flying debris and burning timber and after being attended by a number of doctors, who hurriedly summoned, were quickly on the scene, were conveyed by special train in record time to Wellington, where they were

received in the Hospital. The less seriously injured had their injuries tended and were able to get back to their homes. Many people had miraculous escapes in the fatal rain of flying debris, which spread havoc among all the surrounding property. The windows in adjoining buildings, the Provincial Hotel and in the Post Office across the main road and in dwelling houses and shops much further away were shattered to fragments by the force of the explosion. After the explosion the fire consumed the wreckage and assailed and gutted the next building a drapery store. It was finally suppressed, early in the morning after the worst was done, by a party of fire fighters with one lead of hose.

The six men who met their deaths through the explosion were:

- Constable Denis Mahoney aged about 38 years in charge of the Upper Hutt Police Station.
- James Comesky 57 years of age Postmaster at Upper Hutt.
- William Flynn aged 35 years railway guard.
- George Taylor 19 years of age railway porter at Upper Hutt.
- John Wesley Vivian aged about 35 years storeman in Benges's store
- Michael Toohey aged about 29 years bridge contractor.

Seriously injured - The following were seriously injured and are at present in Wellington Hospital

- James Hagan about 50 years of age caretaker of Trentham Rifle Range.
- Everard E H Felling [sic] 18 years of age blacksmith's assistant.
- Virgil M'Govern about 25 years of age a member of the Upper Hutt Town Board.

Many others were less seriously injured including the following:

- Charles Walters signalman at the Upper Hutt
- Thomas Costello shunter at Upper Hutt
- R F Storey tablet porter at Upper Hutt
- S H Weaver engine driver and chairman of the local branch of the Locomotive Engine drivers and Firemen's Association
- A J Collett local chairman of Amalgamated Society of Railway Servants
- C D Morpeth Accountant Wellington

Narrow Escapes after the Explosion – The affected area - At the time of the explosion there were at least a score of men engaged in and about the shop in the salvage operations. Probably actually inside the store there were at least eight men. Under the circumstances, therefore, it is simply marvellous that so many escaped. This is probably due to the peculiar nature of the explosion, which appears to have swept the ground over a certain area at a certain elevation and left the rest almost unscathed. Those at the north end of the shop, in the drapery department were nearly all uninjured. The explosion took effect more in a south easterly direction from the southern portion of the shop. It is believed that the youth Taylor, who was killed outright, was engaged at the time in saving goods through the broken shop window and got the explosion full through the confined space. Not far away was Mr C D Morpeth who was badly cut about the neck and head. Mr T Costello a railway shunter who was also close to Taylor was severely cut about the legs and sides. Everard Pelling who lies in a critical condition in the Wellington Hospital with a fractured skull was picked up near the late Mr Comesky in the ruins of Edwards's office. Virgil M'Govern was found nearly sixty feet away from the doorway of the building in which the explosion took place and probably received his injuries from flying debris at that distance. It is not at present known where Mr Hagan was found. Among those who had close calls was Mr R F Storey relieving tablet porter at Upper Hutt, who was in the shop with the late Constable Mahoney, John Vivian and others. He was blown through the door into the street. His injuries were confined to cuts on the neck and burns on the hand. At the time of the explosion he was bending down over a case and to this he attributes his life. Also inside the shop was Signalman Walters, who was knocked down by the force of the explosion and in falling drove Alan Anderson another signalman right through the door. The stationmaster Mr Kemp was quite close to the unfortunate Vivian at the time of the explosion, but got off without a scratch. T Croft and Norman Williams were blown right out of the shop, but without serious injury. Messrs Thomas, Wilkinson, and others standing close in front of the building, were lifted nearly across

the street with the force of the explosion. The landlord of the hotel Mr E Crabtree had a marvellous experience. He was mounting a ladder to the balcony when the explosion came which killed Toohy. Mr Crabtree was blown to the ground and stunned, but escaped further injury. The ladder was smashed to fragments. Messrs Collett and Weaver both prominent railway men, were injured about the legs and will be unable to get about for some time. Mr J Toohill engine driver, was another of those lucky enough to escape from the worst. He was detained by his wife at the moment of the explosion from going again into the shop.

Putting out the Fire - It was not till after the explosion took place that the hose was coupled up to the main and water played with any force on the flames. As explained the fire inspector (Mr Gosse) had been unable to gain access to the Town Board building where the fire appliances were kept, so he sent his son to obtain the key to the back entrance from Roadman Greenwood. He was however, according to report, unable to open the door as a duplicate key had been left in the entrance. The door was therefore forced and appliances obtained. The water was turned on the hotel which was saved. Then Hazelwood's building which is of brick, ignited by falling debris received the attention of the fire fighters. The operations were under the direction of George Mansell, a former employee of Jenkins and Mack, who held the nozzle. Among the helpers with the hose were Messrs Smith, Hooper, Phillips, and others. Though Hazelwood's shop was gutted the fire was checked from further progress.

The Hutt Tragedy - In connection with the tragic fire at Upper Hutt on Saturday night Mr Pratt, who received a cut on the temple in the explosion, was seen by the reporter at his residence. Naturally he is completely prostrated by the catastrophe and is confined to his bed. He was asked if he could advance any theory as to the cause and whether there were any explosives on the premises. There might have been a pound or two of blasting powder in the bottom of one of the kegs, he said, but he did not think there was more. There were two or three empty kegs which had contained blasting powder. His firm could not stock much of the explosive, as it was only kept for the convenience of customers who wanted to blast tree stumps. The powder was kept upstairs in a store room where raisins, currants, mechanical toys, and other goods were stocked. He was absolutely at a loss to account for the origin of the explosion. Any little blasting powder there might have been in stock would be rough powder, as rack-a-rock and other patent explosives were not stocked. The firm had occupied the premises for four years and he thought it was extremely unlikely that any explosives had been left, there by the previous occupiers.

The Injured Men - Mr James Hagan one of the three men now in Wellington Hospital, is about 52 years of age and is on the Defence Department staff. He has lived in the Hutt Valley for a considerable period and since 1906 has been caretaker of the Trentham Rifle Range. He is a member of the local School Committee. His wife was caterer for the men who took part in the recent Dominion rifle meeting. There is a large family, some members of which have refreshment rooms at the Upper Hutt. Mr Virgil McGovern also in the Hospital is a son of the late Mr Francis McGovern, who kept hotels at Kaiw-ira, Taita and Trentham at different times. He is a single man about 35 years of age and very popular in the Upper Hutt district. His mother and sister live in the district. He completed his education at St Patrick's College. On Wednesday last he was elected a member of the Upper Hutt Town Board in succession to Mr N J Bennington, resigned. His recovery is only regarded as a matter of time. Everard Edward Henry Pelling, whose condition is serious and who was removed to the Hospital soon after he met with his injuries, is eighteen years of age and a son of Mr Edward Pelling well known in Rugby football circles in past years. He is a blacksmith by trade and an enthusiastic footballer. It is feared that he has sustained a fracture of the base of the skull. Mr Thomas Costello, whose side and one of his legs are injured, is a married man and has been employed for the past three months as a shunter at the Upper Hutt railway station. He is under treatment at his own home. Mr Herbert Collett, chairman of the- Upper Hutt branch of the Amalgamated Society of Railway Servants, one of whose legs is hurt he also sustained a scalp wound, is lying at his own home. He has been in the railway service for many years. Another railway servant who is hurt is Mr Herbert Weaver. He is suffering from shock and

also from injuries to his legs. Mr C D Morpeth who was cut about the head, was well enough to be driven from his residence today to have his injuries attended to.

The Insurances - The insurances on the principal buildings destroyed or seriously damaged in the appalling calamity at Upper Hutt on Saturday night are as follows - Messrs Benge and Pratt's building (owned by Mr W J Wilkie of Upper Hutt) was insured in the Commercial Union office for £275. The stock was insured for £1800 in the Guardian office. Mr Benge estimates the value of the stock at £2800. Mr Hazelwood's drapery store totally destroyed, owned by Messrs Hazelwood and Co. was insured in the Alliance office for £900 and the stock and furniture for £1800 in the Alliance. The Provincial Hotel was damaged, chiefly by the force of the explosion, windows being smashed and the contents of rooms broken. The building is owned by Messrs Staples and Co., and insured with the Atlas office for £2700 and the outbuildings in the same office for £530. The stock and furniture owned by the licensee are insured in the Liverpool London and Globe office for £1000. The amount of damage which is considerable has not been estimated.

The Funerals - The funerals of the late Messrs James Comesky, Dennis Mahoney, William Flynn and Michael Toohey will leave the Courthouse Upper Hutt to-morrow morning at 10.15 o'clock for St Joseph's, where High Mass will be celebrated. The funeral of the late Mr W G Taylor will leave his father's residence Main road Upper Hutt at 2.45 pm tomorrow for the Wallaceville churchyard. All the police available will attend the funeral of Constable Mahoney and there promises to be a very large muster. Arrangements are in hand to make the funerals of a public nature. Mr TM Wilford MP for Upper Hutt, who was early on the scene, considers that prompt steps should be taken to assist the widows and children, and he has sent a telegram as follows to the Prime Minister "Trust that you will urge Cabinet to assist the widows and children of those who have lost their lives in trying to assist others and in carrying out a public duty.

Fire & Fatal Explosion - Seven killed, many injured and numerous marvellous escapes.

A fire only exceeded in the attendant loss of life on one other occasion in the history of the Dominion, broke out at the store of Benge and Pratt Upper Hutt, late on Saturday night, March 28, and an explosion of considerable violence occurred which wrecked the building, caused the death of seven most popular residents and injured a number of others. Just after half past eleven on Saturday night an inmate of the Provincial Hotel who was waiting up for an arrival by the last train, noticed smoke issuing from the store which is on the eastern side of the adjoining right of way and some 30ft distant. Constable Mahoney was apprised of the outbreak of fire and he roused some of those living in the neighbourhood and secured the attendance of one of the partners H L Pratt, who had a key of the burning building. Messrs Pratt, Mahoney and A Hunter then entered the premises through the front door at about 11.38 pm and rolled the safe out, end over end and across to the south side of the road. A half inch garden hose was got to work on the hotel and a messenger was sent to W G Goss the town board turncock, to bring along the fire extinguishing appliances which were kept in the town board office. Meanwhile the fire which appeared to be in the upper portion of the building, spread and the flames illuminated the vicinity. On the arrival of the first of the two late trains, a number of passengers and railway employees took a hand in the work of salvage. The fire gained in volume and by five minutes to midnight had illuminated the valley with such brilliancy that the time of a watch could be read a mile distant from the fire. Salvage work proceeded with vigour in front and rear and the side wall of the hotel was kept from burning by E Crabtree and M Toohey with the garden hose and so matters went on until about five minutes past when as the flames began to eat their way through the veiling of the front shop those engaged in salvaging were urged to have a care. At exactly 0.8 am just as Constable Mahoney was collecting his band of workers from the interior of the store, a terrific explosion took place dealing death and destruction in the immediate vicinity and sending a column of yellowish white flame and smoke skyward to a height variously estimated at from two to three hundred feet. Simultaneously the burning building appeared to twist round and collapse, except at the nor' eastern corner, while W H Edwards office was levelled to the ground and

the eastern wall of the hotel was forced inwards and the upper portion of the veranda blown away. Hardly a window was left unbroken in the Provincial Hotel, Pelling's boarding house, the Post office, Butler's, Lay's, Cooper's, and Cornwall's business premises. Up and down the roadway lay prostrate forms and to the onlookers at a distance it appeared that a dozen or more had been stricken down. After the first shock of surprise was over (for it had been #stated there were no explosives in the burning building) [continued on next page]

[continued from last page] (for it had been# stated there were no explosives in the burning building), those who had escaped with little or no injury to speak of ran to aid those who were less fortunate. Young Taylor who had been at work in the grocery window was found killed outright his head was almost wholly missing and a portion of the arm as well. He had been blown out of the window by the explosion. Vivian was picked up from under the debris and though living at the time was unconscious, and died about an hour later after his removal to the billiard room he was badly injured about the head, besides other hurt his case was hopeless. Postmaster Comeskey was removed from below the debris at the southwest corner. He was unconscious and died on the train before it started to town with the serious cases. M Toohey who was thrown violently on to the end of a seat on the broken hotel balcony was also struck by a flying missile and rendered unconscious. He died in the Wellington Hospital early on Sunday morning. Pelling junior, was removed from Edwards wrecked office crushed and in an unconscious condition. He never rallied but passed away at the hospital on the Monday afternoon. W Flynn's body was not found until after three o'clock on Sunday morning. As a matter of fact he was not known to be missing until his body was discovered lying underneath the wreckage and extinguished timbers on the footway with the feet burned, while searching for traces of the constable - death in Flynn's case had been instantaneous. The remains of Constable Mahoney were found some three hours later almost incinerated. He had evidently been driven by the explosion against the double wall dividing the drapery from the other departments. His legs had been broken and as the body was found near the centre of the disturbance it is certain that his death was instantaneous. The remains were identified beyond doubt by the presence of a pair of handcuffs. Of those injured the most serious cases are those of James Hagan and Virgil McGovern. Both were blown into the street and sustained serious wounds on the head and body and necessitating their removal to the Wellington Hospital as their condition was most critical and bits of debris had been forced into the flesh. Both are reported to be doing well the recovery in Hagan's case being most wonderful. Those sustaining injury to a lesser degree but who were rendered unable to work were Frank B Weaver, Charles Walters and Thomas Costello (all railway employees), Augustus Vosper, and Andrew Hunter. P Story was severely bruised about the right side and arm but has pluckily stuck to his work. E Crabtree, Albert Collett, Percy Stott and Charlton D. Morpeth received minor injuries which temporarily incapacitated them all were thrown down by the explosion. Mesdames Pratt and Swanson and Messrs G Lay, N Williams, C Broad, G Hutchins, R G Mabey, W Crossley, P Hall, K A M Anderson, L W Greenwood and W Wilkinson who were removing goods were in some instances propelled in some distance by the force of the explosion, and all underwent a term of daze or numbness during which they had no clear recollection of what was happening. In rear of the premises and at the bake house H V Benge, H L Pratt, G Taylor senior, T F Boyd, E Mudgway, J P Hall, T Cooper and G Nash were helping and had narrow escapes from flying debris. Willing hands were at work releasing those who were pinned by the debris of the two verandas' and the wrecked grocery building and to remove the wounded. Dr Kemp was quickly on the scene and was ably assisted in his work by H R Gibbs and W Wilkinson who were assiduous in their efforts to alleviate the sufferings of the wounded. Sisters M Ambrose and M Paschal of the House of Mercy also did yeoman service, Doctors Hector and Purdy arrived from the Lower Hutt later on in motor cars and did good work also. A special train was quickly arranged for to depart for town on the arrival of the last train from there conveyed M Toohey, E E H Pelling, J Hagan and V McGovern to Te Aro whence they were taken by ambulance to the hospital. They were attended to on the journey by Dr Kemp and H R Gibbs, accompanied by a number of local residents. The run down occupied forty five minutes. The women folk were as keen in helping minister to the needs of the injured and in comforting the relatives of the victims, as

the men folk were in tackling the rougher tasks. On the collapse of the grocery section as a result of the explosion, there was a perfect furnace of fire threatening destruction in every direction in addition to which flaming debris descended within a somewhat extensive area and called for immediate action. With a high-pressure water supply of over 90 lbs. to the inch and an 8 inch main alongside the burning building, no water was insight save a garden hose at the hotel and another one in rear of Hazelwood's till a little while after the explosion some three quarters of an hour after the alarm was given to the constable. A message had been sent to the turncock to get the hydrant, hose, branch and nozzle and bring them immediately to the conflagration. The appliances were in the public office of the town board, the main double doer of which was only secured by a small Yale latch on one half and a couple of cheap cast iron bolts on the other half. Ongoing to the board office building, turncock W G Goss found the doors locked, but instead of forcing the front door open or breaking a half crown pane of glass in one or other of the twenty one lower sashes and so gaining access to the standpipe and hose etc., he apparently contented himself with sending a boy about half a mile on a bicycle to wake roadman J Greenwood and borrow his key to the back door and when he got the key it was useless, as the town clerk had left the duplicate key in the lock on the inside, so that after all the turncock had to force the door to get the appliances. He considers that the three quarters of an hour delay in getting the water on to the fire saved many lives as there would have been more people on the scene at the time of the explosion and therefore more would have been hurt. [This statement was made in presence of witnesses on Monday last by the turncock to our representative. For our readers information and to show the capacity of the board's appliances we .quote a few facts in connection therewith. Pressure opposite Benge and Pratt's is 90 lbs. to the inch, or 30 lbs. more or than Petone. Size of nozzle $\frac{3}{4}$ inch. Discharge of water at 90 lbs. per inch is 1563 gallons per minute and would throw that jet effectively for fire extinguishing purposes to a vertical height of 81 feet, or a horizontal distance of 160 feet. In 30 minutes no less than 4680 gallons of water could have been delivered into the burning building by that single $\frac{3}{4}$ inch nozzle enough to fill a tank 10 ft. long, 10 ft. wide and 7 ft. 6 in. deep. The alarm was given 30 minutes before the explosion took place but the water was not got on to the burning wreck until nearly ten minutes after the explosion. The hose was only. about ten chains distant from the scene or the outbreak yet accuse those who knew where it was kept hadn't gumption enough to break a half-crown pane of glass, the fire was allowed to burn unchecked for over three quarters of an hour. The statement that the appliances are mere toys is untrue. They were made by T W Ballinger to Government pattern and tested by the city brigade. We contend and most people will agree with us that had the hose been got to work within ten minutes of the alarm being given, the explosion should not have taken place Editor] Water from the town board's appliances was available about a quarter of an hour after midnight and attention was divided between the burning wreck and saving the hotel. Fortunately there was no wind and the hotel was soon out of danger, the garden hose subsequently extinguishing incipient outbreaks. Meanwhile an outbreak occurred in the upper portion of Hazelwood's brick drapery store and efforts were concentrated on preventing its spreading. It was close on three o'clock ere the men on the hose achieved success and turned their attention exclusively to extinguishing the glowing furnace of embers which was all that remained of Benge and Pratt's store. As the embers were copied sufficiently to permit the search for the missing Constable, was prosecuted but it was not until after daybreak that the remains were found. The men on the hose did excellent work and all were included in the list of members of the Volunteer Fire Brigade handed in by acting secretary McCurdy at Monday's town board meeting. The list contained twenty four names and the services of the Fire Brigade were accepted by the Board Commissioners McCurdy and Robertson were appointed to represent the Town Board in connection with the Fire Brigade.

The Funerals - The first of the funerals left the court house and post office simultaneously shortly after ten thirty on the Tuesday morning after the fatality. The cortege was of considerable length and in addition to large representative bodies of police and railway officers and members of the Hilbernian Society there were the Hons. Bell, Fraser and Herdman, the Mayor of Wellington and the member for the district, postal, town board and harbour board representatives besides a large number of relatives and friends. Denis Mahoney was carried by his immediate relatives, James Comeskey by present and past town

commissioners, William D Flynn by railway employees and M Toohey by his May Morn comrades. As the mournful procession off there were few dry eyes among the thousand or more bystanders. At St Joseph's the cortege was met by the Rev. Father Daly parish priest, who was accompanied by His Grace the Archbishop of Wellington and a large number of the Catholic clergy of the diocese. Solemn High Mass was then celebrated by Father Daly and he afterwards delivered a soul stirring address to those present and a panegyric upon the four members of his flock whose obsequies were being then carried out. He also paid a feeling and appreciative tribute to the three other victims of the explosion who had accompanied his four parishioners in their journey beyond the veil. To the strains of the "Dead March" our late townsmen left St Joseph's for the last time and were laid rest.

Requiescat in Pace - At about 1.30 pm John Wesley Vivian's body was home by members of the Town Board

The Tragic Fire - Fourth day of inquest - Evidence of Herbert V Benge - Gelignite and other explosives - The inquest on the victims of this Upper Hutt explosion was resumed before Mr W G Riddell, SM District Coroner in the Magistrate's Court today the fourth day of hearing. The victims were Constable Denis Mahoney, James Comeskey late postmaster at Upper Hutt, William Daniel Flynn railway guard, George William Taylor railway porter, John Wesley Vivian shop assistant at Messrs Benge and Pratt's store, where the explosion took place, Michael Toohey bridge contractor, and Evard Edward Henry Pelling a youth of 18 years.

Chief Detective Broberg conducted the case for the police Mr C B Morison KC, with him Mr H. F O'Leary appeared on behalf of Messrs Benge and Pratt, Mr T M Wilford appeared for the relatives of the deceased, Mr E M Sladden watching the proceedings in the interests of the New Zealand Acetylene Gas Co. Ltd. and the Heat, Light and Supplies Co. and Mr H E Evans appeared for the Guardian Assurance Company in whose office Messrs Benge and Pratt's stock was insured.

Senior Partner in the Box - The first witness to day was Herbert Victor Benge senior partner in the firm of Benge and Pratt general storekeepers and drapers Upper Hutt. During the week ending 28th March (the eve of the fire) they were engaged stocktaking. Both himself and Mr Pratt and all the employees were helping in the work during and after business hours. Witness took some of the crockery and some of the hardware and some of the bacon, but none of the groceries. The staff comprised the late Mr Vivian employed in the grocery department, Mr Paton as carter, Mr Field as carter, Mr Clough baker, Mr Williams second baker, Miss Mitchell in the drapery department, Miss Hudden ledger keeper, and the boy Cooper. The premise were old. On the north side there was only one floor. The grocery department was on the south side. At the rear of the grocery department was a storeroom and office. On the south side there was an office occupied by Mr Edwards. In the rear north room there were a quantity of preserved eggs, kapok, egg earners, and some galvanised bars. In the north front room, were crockery, tea and table decorations. In the front room south there were empty butter boxes, a quantity of toys, bacon that was all. In the room behind this were patent medicines, cream of tartar and soda also some pickles, he thought and matches. The cartridges were kept on the ground floor. He had no idea how many except 150 of Nobel's ballistic he knew that. He did not know of any flasks of powder. The Chief Detective - When did you finish stocktaking? 'We hadn't finished.

Where the Explosives were - You have been in the habit of stocking gelignite, blasting powder and detonators - Yes. Where were the detonators kept? - Out in the back shed. Where was the gelignite kept? - Upstairs in the south front room. And the blasting powder - Also there. Had you taken stock in this room? - No sir; we hadn't taken any of the upstairs at all. Where are the stock sheets - Burnt they weren't taken out of the fixtures. Had you any gelignite on the night of the fire? - I believe not. Had you any blasting powder? - May have had I could not say. When was the last purchase of explosives? - I couldn't tell you sir. How was that - I never bought it so I could not say. I believe it was 6th February but it's only what I hear. Did Mr Pratt do the whole of the buying? - Practically all. Do you know it was usual to stock a case of gelignite at a time? - No I believe it was usual to get a case if we had an order. When were you last in that front south room? - I haven't any idea. Were you in that room in the week ending 28th March? - Not that I remember. Would it be quite possible for a case of

gelignite to be stored in that room without your knowledge - Yes. As much as 201b of gelignite? - Yes.

Sales Of Gelignite - What sales of gelignite do you know of since 6th February? - I know of two to Edwards. When were the two sales affected? - I couldn't say. Could you give us an idea? - Well I believe one was on the 14th March, I don't know the date of the other. How much on 14th March? - 5lb. By whom to whom? - By Vivian I believe, to P T Edwards a labourer Upper Hutt. What information have you about that sale? - I have Mr Edwards here. How did you get the information? - From Mr Edwards through an advertisement put in the local paper on Saturday night. When did he speak to you about it? - Yesterday. Was that the first you knew of it? - Yes sir.

Purchasers Discovered - What about the other sale? - About a week after the explosion Mr A R Edwards farmer Mungaroa sent word to me through Mr Wilkie's son that he had bought some gelignite from me. How much? - 5lb. Is Mr Edwards here today? - No I understand he was coming but he does not seem to have caught the train. What did Mr Edwards say? - He said he bought some gelignite from Vivian on a Saturday night. Did you ask him what Saturday night? - No. Can you tell me of any other purchases? - No I can't. You know that Mr Fothergill gave evidence as to the purchase of gelignite prior to 6th February? - Yes. You don't dispute it? - No. Do you dispute that Mr Carmichael did not purchase gelignite at your Store? - I still think that he did. But he swore that he did not? - Yes. You didn't keep an explosives book? - No. Apart from the sales to the two persons named Edwards you cannot suggest any other sales? - No. I feel positive I however, that Mr Carmichael purchased gelignite. Would you swear that? - No I wouldn't swear it. If 101b were purchased by the Edwards and 6lb by others recorded in the book, there were still 33lb of gelignite in the premises, so far as you know? - There might have been a ten there and I wouldn't know. Witness was then examined as to the circumstances of the circumstances of the fire and his own movements at the time. He had assisted in getting out the sale and the sewing machine. The fire was in the back south room about half way up the staircase. When the explosion came witness was in the rear of the building just outside the bake house. He heard no report and felt no shock, but saw and felt the flames and sparks. He ran to get out of the road of the falling bits. The bake house was intact? - Yes. And you felt no shock and heard no report? - No. Then why did you run? - To get away from the falling sparks. When did you first learn there had been an explosion? - Not for some long time afterwards. How long? - I couldn't tell you - Next morning some time. On the question of the acetylene generator, witness said the tap had not been turned off by Mr Pratt, who did not go outside the back door. The generator was charged by witness at a quarter to nine. It had also been charged earlier in the evening. Witness could not say whether the tap had been turned off. He personally did not turn it off. He left the premises at a quarter to ten.

A Mysterious Light - The Chief Detective - Who was last in the premises? - I was Mr Pratt went out at the front. I went out and locked the oil shed, the grain store, the bake house, and put the key over the ledge of the generator door. I then thought I saw a light in the upstairs window. I walked round to the front door of the shop, let myself in went upstairs, looked round to find nothing. I came down again. Then I discovered it was the reflection of the hotel lights I had seen. Did you speak to Clough? - He spoke to me. He said "Were you upstairs with the lights out." I said "Yes" and walked off. Did you see him next morning? - Yes. I said "That light must have been there after all." What did you mean? - Did you mean the place was a fire when you went in? - No. I thought I saw a, light and then found it explained otherwise, but I was wrong. You mean the place must have been burning? - You may put it that way. Did you strike a light? - Yes. Did you carry a candle? - No. Did you strike more than one match - Probably? Did you make a good search - Yes. How long were you up there - About two minutes. You were in the room where the gelignite was stored - Yes. And you concluded, when you spoke to Clough next morning, that the place must have been on fire - Yes. How long was it before the fire was discovered - About two hours. You were interviewed by Sergeant O'Halloran in connection with the fire? - No. He asked me a question about explosives or something to that effect on Sunday morning. Do you deny that you told him that you left the shop at 10 o'clock and everything was all right? - Yes. You deny that? - Yes. Did you tell him anything about being a light? - No sir. Did you tell any other person - No. The only person you discussed that with was the person who saw you go into the premises after

you locked up on Saturday night - Yes. If you concluded the premises were alight shortly after 10 o'clock on Saturday night, why didn't you tell somebody else about it? - I didn't conclude the place was on fire. Why did you not mention it to somebody else? - I never thought of it. You never thought of an important thing like that, that the place might have been burning a couple of hours before? - I didn't think it was the fire. I thought it was the reflection from the hotel windows. And next morning you told Clough that it must have been the light? - Somebody else might have been up there. Do you deny telling Sergeant O'Halloran that the gas was turned off at the meter? - I do. The Coroner - Do you know that the tap was found turned off - Yes. The Chief Detective - Here is the tap. Can you turn it - Witness (having tried) - No. Witness went on to deny telling Sergeant O'Halloran that Edwards's office was in flames when he came there, that he heard a big explosion. Did you use the words to Sergeant O'Halloran, "I did not stock any gelignite or dynamite" - I would not swear that I did not tell him. I have no idea now I told him I did not stock it. What was the value of the stock at the time of the fire? - About £2800. How do you arrive at that figure? - Our last stocktaking was £2500 and stock had increased considerably. Did you tell Sergeant O'Halloran that you had just finished stocktaking, and the stock was valued at £2800? - No. Did you tell anybody else that there were no explosives in the premises at the time of the fire? - Yes. Could you say whether you told a reporter you had absolutely no explosives on the premises? - I couldn't say. What insurance did you have on the stock - £1800. Had you any insurance on the bake house and contents - The bake house didn't belong to us the baking plant was not insured, but the stock was insured. Was there anything you know of a highly inflammable nature in the upstairs room - Nothing I know of. The witness was next questioned as to the acetylene gas generator. It was usual to turn all the lights off at 9 o'clock on Saturday night. Chief Detective - Did Clough say anything about smelling fire? - No. Have you had any conversation with .Bolton about his purchase of gelignite? No none at all. Have you any knowledge about the stocking of gelignite? - Only through Vivian. How do you mean? - He told me we were out of gelignite. Did you make a note of it? - Yes. Where is it? - I think it was destroyed in the fire. Wasn't it rather unusual for Vivian to tell both you and Mr Pratt about running out of gelignite? - Well we don't like to run out and have none. It was left in Mr Pratt's hands. Vivian told me so that we wouldn't miss it. The Coroner - You might ask the witness what precautions they took with explosives. The Chief Detective - Yes sir.

In the Explosives Room - Witness admitted he had been in the explosives room at 10 o'clock on the night of the fire. Why did you not tell me that before when I asked you Mr Morison - I submit that the presumption is unfair. The Chief Detective was enquiring about stocktaking. The Chief Detective - You had no license to stock explosives? - No. Where did you purchase your knee boots from? - It might be Bing, Harris, Sargood's, or Staples. Now, about these two Edwards are they any relation to you? - Yes cousins. Mr Wilford - Why did you tell Mr Broberg there might have been a ton of gelignite there for all you know? - Well I might say that there had been no sales of gelignite recently and I had not taken any special notice of it. Did you believe it required detonation to explode gelignite -Yes. You didn't know heat would or would not explode gelignite? - No. You would naturally believe gelignite safe if you had no detonators on the premises? - I wouldn't chance burning it. Do you know it is a general opinion that gelignite will not explode without detonators? - No I didn't know that. Mr Wilford quoted a report from an enquiry at Home to show that many fatal accidents had occurred through thawing gelignite or otherwise exposing it to heat. The Witness - I can assure you, if I had known there was gelignite there on the place, I would have been a long way from it. Mr, Morison - And got others away? - Yes.

Where bodies were found - Mr Wilford - The victims Flynn, Mahoney, and Taylor were immediately under the gelignite room? Yes. And these men were badly shattered? Yes. What do you suggest from that? I can't suggest anything. Can you suggest any other thing that could cause such an explosion as would kill Flynn, Mahoney and Taylor in that way? I can't suggest anything. Witness was shown the generator tap again and suggested it might have been touched after the explosion. There were no burners in the gelignite room.

Wax Matches - Mr Wilford - Where did you strike a match when you went upstairs to look at that light? I struck it on the box at the bottom of the stairs. It was a wax vestat. Did you strike another match when you got to the gelignite room? I can't remember. Did you go into the room with a lighted match in your hand? I don't know. It would take two matches? Yes.

More than two? I don't think so. When did the match go out? I can't tell you. Did you come downstairs in the dark? Yes. Did you throw down the last part of the match? I suppose I did. Do you remember whether you lit the second match from the first or the box? I don't remember. When you come down the stairs there was no light burning? No. Then it is quite clear that at ten o'clock that night when you came down there was no fire? That is so. **Reflected Light** - Why did you tell Clough that there must have been a fire? I said that it must have been the light. What light from the hotel could reflect on the window in the gelignite room? It was the back south window. After you came downstairs and out into the street you could still see the light in the back room window? Yes. Was it a steady light? Yes. You were satisfied then it was a reflection? Yes. Don't you think perhaps believing gelignite could only be exploded by detonators you thought it was safe? I assure you I believed that there was none there. Then what could have caused the explosion? The tap was turned off the generator? I couldn't say. You can't account for the sale of all the gelignite? No. You can't give any reason for the boy Cooper telling M'Curdy on the night of the fire before the explosion that there was gelignite upstairs? No. It might have been months before the explosion before I went into that room. I couldn't tell you what was in that room, only what was usually stocked there. To Mr Sladden - Witness had often smelt acetylene gas in the building. He had not the slightest hesitation in striking matches at 4 o'clock in the morning when he went through the shop. He had smelt no gas on the particular night when he went upstairs. The first chance of leakage in the main building would probably be in the drapery department. There were five drums of carbide in stock. At this stage the adjournment was taken. The evidence of the witness Herbert V Bengé was continued this afternoon. He was examined by Mr Sladden on behalf of the companies interested in acetylene as to the gas pipe reticulation of the building and other details of a similar character. There had been practically very little leakage. To Mr Evans - The 1913 stock sheets were in the office fixtures. The 1914 sheets were not yet made up. The particulars were only on loose slips of paper. No other books and papers were recovered except what were in the safe. To Mr Morison He did not at the time realised an explosion had occurred and he had not a very clear memory of what happened afterwards. People had told him he did things which he could not himself remember doing. He remembered putting Mr Pratt on a box after the explosion. Pratt was staggering. He had no idea what time this was after the explosion. He had no recollection of going to the generator house after the explosion. He had been told he had gone there. Later on he had taken part in trying to extinguish the fire. There were many rats in the building it was over-run with rats. The building had been used for a store for twenty-five years to the witness's knowledge. The walls of the upper room were lined, but he could not say whether there were any loose boards. He did not know whether any additional gas piping was put into the building when the new generator was installed. There was one small compo pipe; the rest were iron. (Proceeding)

Disaster attributed to Acetylene (Special to Herald) Wellington this day. Six men were killed and at least a dozen injured by an Explosion at the fire at Upper Hutt during the early hours of Sunday. The disaster generally attributed to acetylene gas. Bengé and Pratt, general storekeepers, who occupied the wrecked premises, state that nothing in the nature of high explosives' were kept. Half an hour after the fire broke out, on the upper floor there was a sharp swift outburst. The floor was driven with tremendous violence down upon the men who were on the ground floor endeavouring to salvage goods. Five were killed outright. A fragment of plate-glass from the shop window was blown into the street, seriously injuring several men. The dead are Constable Denis Mahoney married with five children, James C Comesky postmaster at Upper Hutt married with grown up family, Taylor railway porter single John Wesley Vivian grocer's assistant single, Flynn railway guard 35 years married, G Tuohey bush worker single. Those seriously injured are Virgil McGovern dentist Upper Hutt, E Palling blacksmith and boarding house keeper, Joseph Hagan Defence Department employee. These are suffering severely from concussion and were more or less unconscious during Sunday. Pieces of glass were embedded in their flesh and doctors had to operate to remove them. Hagan's upper jaw was smashed and his left arm and hand were badly lacerated by glass. The dead were in some cases, dreadfully mutilated. Constable Mahoney could

scarcely be identified. Another victim had his head and arm blown off. Tuohey who was alive when taken from the ruins sustained a fractured skull. He only survived till he reached Wellington hospital. Comesky the postmaster who was under the veranda at the time of the disaster was blown into the middle of the road and so badly injured that he died before a special train with the injured could be dispatched to the city. Benge and Pratts store and Hazelwood's drapery store adjoining were completely destroyed. One end of the Provincial hotel was damaged.

Dennie's Dowry - (Written for the Free Lance.)

It is safe to say that without the benign presence of Denis Mahoney, Upper Hutt is literally cut adrift from its moorings. Just as in life he was the guide, philosopher, and friend of all with whom he came in contact, socially and officially, in death he lives on its one shining example of purely disinterested heroism. All Upper Hutt's manhood - aye, and womanhood - young and old, respected him, and, what is more, trusted him. Their joys were his joys, their sorrows his sorrows, their misdeeds his shame. He mothered all their secret failings, nurtured their good qualities, and defended all their weaknesses. Out of a big store of generous impulses he lavished gifts in abundance out of a small purse he dispensed practical help to all and sundry in need of it. In the big, bustling city from which he had been transplanted to keep the peace of the Upper Hutt Valley, they had their Discharged Prisoners Aid Society, their Two. Garment Club, their Charitable Aid Society. In Upper Hutt after he came there was Mahoney. Who does not remember "Dennie" and the fine figure he cut on the few occasions he donned the uniform and helmet as the sole representative of Law and Order when high occasions warranted it? It was only yesterday, almost, when the Hon the Minister for Justice arrived in Upper Hutt with a big retinue of visitors to celebrate the opening of the waterworks, and in the main street a few feet away from the scene of his tragic death there was Mahoney. A giant, with the smile of a seraph and the heart of a child, yet with all, as courageous as a lion. The Minister knew that well known form, and, reminiscent of Court days on Lambton quay, they greeted each other warmly. No sycophant, groveller for preferment, "Dennie" was prepared to live and die in Upper Hutt, where, amid its peaceful seclusion, no bad character was allowed to sojourn longer than it took him to get a feed, his thirst quenched, and his swag up for Featherston. Dennie knew the curse of the big town's occasional habit of giving the hardened criminal twenty-four hours to quit and give the country a taste of his bad company. Upper Hutt trusted "Dennie." Thus it was a township and a district particularly free from crime. "Dennie" leaves a wife and three children two of them "wee men" with their mother's fine features and jet black hair, and the eldest, a girl, fair haired and blue-eyed, and who, when borne proudly aloft in big arms on Sunday, people said "Her father's girl," and "Dennie" smiled in a way good to look upon. Policeman's pay has advanced with the cost of living, but it was never so small that "Dennie" had not just a few shillings invested for his bairn, and her future, against a rainy day. It was an insurance policy to be drawn against the time of her coming of age in fact, a father's wedding, dowry. This Dennie once told me in confidence, It is some years since I was proudly let into the secret of "Dennie's" dowry. Two other little Mahoneys .have come since then, and I am troubled even now I write lest anything unforeseen and unrecorded may have intervened. This, I know, lapsed or in force, that policy shall be revived or kept up, as inquiry proves. Thousands would gladly raise a memorial of some sort or other to his memory but he would be glad to know his first parental vow remained fulfilled. "Gentlemen, to Dennie's Dowry. - UPPER HUTTITE

Another Tribute - On St. Patrick's Day the Upper Hutt school children were given a half-holiday and a picnic, but the local school committee had not provided any toys for the little ones. Constable Mahoney heard of it on the morning in question, and in about an hour had collected the sum of five pounds for toys. It was a happy policeman on the Trentham racecourse that day who, in the well-beloved mufti, superintended the furlong sprints for girls and boys, and whose one grand reward was their complete happiness. Peace to his ashes.

By the untimely death of Everard (Lofty) Pelling the Upper Hutt Football Club loses one of its most promising players. He could find the line from the three-quarter division at any angle and run like a deer. His death has almost put an end to Rugby in Upper Hutt. Percy Stott, another of the club's players to receive unexpected attention from flying debris the night of the

disastrous fire, was attending (in bandages) the funeral of the four victims buried in St. Joseph's Churchyard on Tuesday morning, when a telegram was brought to him announcing the approaching death of his mother in Wellington. Mr William Nidd brought him by car post haste into town, and that day another sorrow was added to Percy's lot.

In connection with the recent sad fatality at Upper Hutt, one of the outstanding features was the splendid efforts (for a time single-handed) of Commissioner (Dr) Kemp to succour the dying and the sorely wounded victims. Well may Upper Hutt be proud of its local doctor like Constable Mahoney, Dr Kemp never allows the one hand to know what the other is doing and parcels of good things have a habit of following him on his rounds amongst the poor (Reference Papers past website Free Lance newspaper 04 April 1914)

(page 12) James Gerald Comeskey sworn saith:-

My father's full name was James Comeskey. He was Postmaster at the Upper Hutt. On the night of the fire at Benges and Pratt's I was present. I saw my father there. When I first saw him he was just outside Edward's office. I see the office on the plan Exhibit A. I saw him come out and go for a screwdriver. I did not see him return and did not see till after the explosion & then saw him under some timber where Edwards office had stood. The office was not burning but was down. At the time of the explosion I was outside the door of the drapery department of Benges and Pratt's. I did not hear the explosion, but saw timber falling around. The timber came from Benges and Pratt's. I did not see Edwards office fall. The explosion was 5 or 10 minutes after I heard my father speak about a screwdriver. About a minute after the explosion I went over to where Edwards office had stood. I then saw my father under the fallen wall of the office. The South wall of Benges and Pratts building was down. I had to wait till the water was put on before going to my fathers assistance. The flames were coming from Benges and Pratts. After the water was turned on, I, with others got my father out from under the timber. After we got him out I went and got Dr Kemp who was just leaving home for the scene of the fire. He afterwards attended to my father and ordered his removal to the billiard room. From there my father was put on a special train to go to the Hospital at Wellington. He died before the train left Upper Hutt. I afterwards saw his dead body at home.

Benges and Pratts, has a telephone.

My father left the premises to get a screwdriver to get a telephone down. When his body was recovered he had the receiver round him. The telephone was screwed into the wall at Edwards place. My father as Postmaster had control of the telephone in the district. I can say that he met his death while trying to save Government property.

There was a small hose playing on the hotel.

(Other evidence) - Just after that a man whom I do not know came the door of Benges s shop, and called out "Are there any explosives on the shop?" and deceased Vivian called out "None whatever". After I had recovered to get Mr Comeskey from Edwards office. A man named Scott called out "For god's sake help me, a man had been burnt. The man that Scott referred to was Mr Comeskey. He was caught under the front of Edwards office. It had been demolished by the explosion. Scott, Walters and two of Comeskey's sons got Mr Comeskey out. (Other evidence)

(Other evidence) – While in the billiard room ther was bought in the body of Taylor who was dead, Mr Comeskey who was living and Mr Vivian also living. Mr Comeskey's injuries consisted of a few abrasions at the back of the head and forehead and burns on the left leg. He was

semiconscious. I at once ordered his removal to the hospital train. (Other evidence) – Shock was the cause of Comeskey's death. (Other evidence) – In regards to the caus of death of Mr Comeskey it was by concussion and shock. The superficial wounds he had could not have caused death. (Other evidence) – In Comeskey's case fire or cits had nothing to do with his death. (Other evidence)

Dear Sir

I have the honour of calling to your recollection a conversation between yourself & myself in reference to the representations made to me by the relatives of those who lost their lives during the Explosion at the Upper Hutt. You will doubtless remember sending telegrams of condolences to the relatives of the injured, after obtaining their addresses from me. It is of that occasion I write. I informed you at the time that the relatives required my services professionally to advise them daily and to act for them during the inquest proceedings & in advising in their claims against Benge & Pratt & C, and I asked you, Sir, whether the Government under the circumstances would pay the legal charges for them. You may remember Sir, that I informed you that if your Government would not pay the costs, I would do the work for nothing as I did not intend charging the widows and those who were left a single penny. I am still of that mind. Mrs Comeskey who has been generously dealt with has asked me what she owes me & I have told her she owes me nothing, & I have adopted that attitude all through. You will remember you informed me that your personally thought that I should act [sic] & that you personally thought the Government would be willing to recommend that the relative should not bear the cost, this you informed me that you would have to see Mr Herdman on the subject. Whether the matter has escaped your notice I do not know, but at any late I am sure you will pardon the reminder. In conclusion if you think that the Government should not pay, that is an end to the matter for all time, I shall not bother again on the subject & the work will not be charged for.
