1865	Leckie	John	Our Manufactures Brick and Tile Works In accordance with our custom of noting from time to time the progress of our manufactures we give today a brief description of the extent plant and production of two of our largest brick and tile manufactories in doing which we add further proof (if indeed that were necessary) of the progress of Auckland in the development of its own resources. It has even been our most pleasing task to encourage colonial industry and we trust that by a faithful description of what had been accomplished through the energy and enterprise of some other may be stimulated to increase effort in helping forward the general welfare of the colony. There is still a vast field of enterprise lying waste and if the right men could be found to enter into our requirements we believe the colony might soon be rendered independent of many of the importations which are necessary in our present condition. Much credit is due to those who after fighting against prejudice and almost insurmountable difficulties are now reaping the fruits of their enterprise.	Auckland	101

There are not a few such but we trust ere long their numbers will be greatly augmented.

It was our privilege on Saturday to walk over the brickworks just established on the most modern improved plans by Mr John Leckie of Cox's Creek Great North Road. Bricklaying has in all ages and from the earliest time been an occupation for man but by means of the perfection to which our machinery has attained the number of its workers is in these latter days greatly diminished. In the place of the slow hand-process which has during long centuries been the only discovered means of their manufacture we find at this establishment a machine capable of turning off 2,500 bricks every hour. We allude to William Ralston's patent one of which made at his works in Glasgow has been sent out to the order of Mr John Leckie and may now be seen at his brickworks in full working order. The manufactory has been in contemplation by its indefatigable proprietor for the past four years and several areas of ground were tested before the present site was fixed upon. Numerous expensive experiments were tried with our clays and their respective merits fully tested. Being sanguine of success from long practical experience the owner felt himself warranted in going to the expense of some £4,000 or £5,000 in the creation of a plant which should not only astonish the natives" but be of infinite value to the place and tend as much as anything to advance the interests of the inhabitants. Whatever convenience may be felt in a neat wooden structure for a dwelling house it must be admitted that brick is the material par excellence of all large buildings and business premises and of which even family dwellings themselves ought to be build as the colony progresses. With this knowledge then we hail with satisfaction such an extensive and economical method of multiplying this useful article. The works in question are eligibly situated about forty minutes walk from town with a good road to this ground although it might of course be improved here and there by a few loads of scoria. Besides the easy access to town, which a good road affords a tramway, is to be constructed over the short distance between the works and the creek on which there is as punt belonging to Mr Leckie capable of carrying

many thousands direct to the Queen Street Wharf. The works comprise some acres of ground in the vicinity of the creek and some capital drying-grounds have been provided. The covered ground for use in wet seasons is 120 feet by 24 a substantially built. Ralston's patent requires 12-horse power to work it and produces 50 bricks every minute. The machine consists of a crank and slide with drums and moulds four in number. The raw clay is brought along a tramway to the cylinder for the machine and is shovelled down as the supply diminished ion the same way as a furnace is supplied with fuel. The cylinder is fitted up with twelve large knives each about 50lb in weight set at right angles exactly in the same way as the screw of a steamer. The cylinder is of course kept in motion and the clay is by this means pulverised and brought to a proper consistency for the moulds when it is forced out underneath and a slide meets it whose work it is to cut it off to the proper size. The crank then falls on the moulding-box giving a pressure to the clay of 15 tons. There are four of these moulds – two on each side – at each of which a little boy is in attendance to receive the brick as it is ejected by the machine on to a small price of wood used for its carriage to the drying-shed. These boys are kept constantly at work receiving the bricks and transferring them to a barrow by their side, which is emptied every few minutes by labourers whose duty it is to supply the drying yards. The machine requires six boys to receive the fruits of its work who have only one minute in which to lift every 20 bricks. The moulds are being constantly watered as the machine is in full operation from a running pipe affixed over each and supplied from a tank above. This is to prevent the clay from adhering to the mould and give a smooth surface to the brick. The clay is sprinkled as it is supplied to the cylinder with scoria or other ask in the same proportion as an agriculturist seasons his grounds. This gives greater strength and durability to the brick and is absolutely essential to the production of good material. To show the perfection of the machinery employed we need only mention that there is a pan attached for the purpose of crushing this seasoning element to its proper fineness. The pan revolves by means of two shafts requiring ten horsepower to work them and is 6 feet 6 inches in diameter with a

false bottom and 20 inches deep with rollers 4 feet 2 inches by 10 and a half on the face each giving a pressure of 25 cwt. The scoria use is at present brought from Mount Eden but broken bricks will be crushed and made available as the works progress. The rollers are stationary – the pan containing the metal revolving and carrying its underneath their heavy tread. The rollers fall and cant to suit the material they contain. It is emptied and filled by hand labourer and only used when the brick machine is stopped in consequence of the heavy power required to work it. The engine – a model of mechanical skill – was also brought from the manufactory of Robert Drummond of Glasgow and is a 16 horse power horizontal very unique in appearance and admirably constructed. Both engine and boiler with the machinery complete were fitted up by Mr Leckie himself who is a mechanical engineer of considerable abilities. The cylinders are worked by one of Parnell's patent gutta-percha belts ten inches broad by sixty-three long and six ply thick supplied from the works of the North British India rubber Company (Limited) Edinburgh. The material is not very commonly used but has been pronounced unexceptionable by some of the largest manufacturing firms in Europe. The boiler from Drummonds Calton Foundry, Glasgow is characterised by the same superiority of make and supplied with all recent improvements for prevention of accidents. The patent indicator with which it is adored is so simple that "he who runs may read". The height of water is told by numerals the float in the boiler regulating the finger of the indicator – so that if the foreman will but use his eves occasionally in the same way as he acquaints himself with the time of day an explosion is next to impossible. The extent of the lever is 50lds weight. The boiler chimney is 5 feet by 34 feet in height. At present a sufficiently of water is available for the use of the engine from a 25 feet well but if the supply gets less it is intended to inset a bore. A force pump will also be erected to fill the tank for supplying the boiler of the engine with water the platform of the brickmachine and the cistern fro the pan. The patent tile-making machine by Anderson of Shuttleston has not yet been fixed up but when it is will be a most useful addition to the works. It is provided with dies from one and a half inch to six and a half inch horseshoe drain titles and can

			be worked either by power or hand. It is capable of producing 12,000 tiles per day with the attendance of three boys and two men. The clay is pressed through the mould by a piston and six tiles are cut off at once. The bricks produced at these works are stamped with the works "Caledonian" Brickworks Richmond Auckland and are of exquisite fineness and solidity throughout owing to the perfection of the machinery employed in their manufacture. The proprietor invites any experiment calculated to test their quality. Owing to the large number of bricks which this extensive plant is capable of producing daily – namely 20,000 in eight hours- it has been thought advisable by some to from a joint stock company for its working and we believe the idea will be carried out. That such a compact work should stay idle for any time is very undesirable the more so with our present and larger prospective demand for bricks. If our Lunatic Asylum was kept at a standstill through a failure in the supply of bricks by the original contractor how much more likely is it that when the erection of our public buildings is commenced the want will be even more felt. At such a time Richmond Works would prove most invaluable. For the present the works have been let to four or five practical hands who are to commence the working of the plant in good earnest during the present week. = Daily Southern Cross 2 January 1865

With indomitable pluck Leckie who is a lad about nineteen years of age bound up the mutilated hand and started on a run home about two miles distant carrying the gun in the same hand which had been so much maimed. On his way he found the ramrod had slipped out and he retraced his steps to find it. Feeling rather faint then he refreshed himself by bathing his forehead in a creek after which he again made for home. Yesterday accompanied by his brother he arrived in Oamaru after a journey of eight miles on horseback. Procuring the attendance of Dr Fleming that gentleman administered chloroform to his patient and proceeded to dress the wound. It was found necessary to amputate the two centre fingers which operation was very skilfully performed. The bones of the hand were most severely cut up and shattered a fact, which rendered the treatment of the wound of a very intricate nature. The young man bore up bravely and we believe is now doing well. We need scarcely state that had he delayed for a moment longer to remover his chin from his hands when in the act of lifting the gun the accident would certainly have been attended with fatal consequences. He had no appearance of having been drinking; other wounds had been lately inflected. This was plaintiff's case. Mary Leckie wife of plaintiff gave her version of the affair and said that "one was a bad as the other". She dragged the sleeve out of the plaintiff's shirt, dragged him into the bedroom and locked him in, but he afterwards went out by the window. Had she known that he was going into town he would never have got out of the house. Cross-examined by Mr Beveridge, She did not like her son better than her husband. She was disappointed when he came back from Australia. She wished to get away from her husband, and to live with he son. She was outside the house when the squabble between her son and husband began. The two were scuffling when she went into the bedroom, the noise attracted her then. She could not say whether her son was drunk, he might have had a glass. Her son was very excited. She could not say that he son was ever in her husband's bedroom since his return from Australia. Mr Keetly reexamined after which the Court examined at some length. A cross action – John Leckie was then charged by William Slater with having on the 17 th January violently assaulted him by striking him on the face &c –Mr Keetley for the complainant and Mr Beveridge for the defendant. William engineer gave the particulars of the origin of the quarrel – something about a "block" said to have been got from Thornton, Smith and Firth's mill. The evidence given was similar to that in the above case In cross examination it appeared that the ownership of the house in which the parties reside in Richmond was at the bottom of the dispute – Counsel having address the Court the Magistrate retired to consider their decision.
