Times began to improve for our MANSSEN family. On 21 October 1853 George MANSSEN purchased 35 acres of land at Suburban North, Wakapuaka, Nelson. He purchased part of section 20 from Dr J.F. WILSON. The 1845 census showed that section 20 was owned by Robert TOD but the New Zealand Company records state that Robert TOD had purchased section 21. The records showed that section 20 was originally Colonial Reserve and on 15 October 1851 Dr J.F. WILSON purchased about 475 acres of land in Suburban North and part of this land was section 20. Section 20 Suburban North was situated on the corner of Todd's Valley, and included the green gravel quarry, which I understand had not been quarried at this time. Section 20 cost 150 pounds. George paid a 60 pound deposit and took out a mortgage with Joseph Foord WILSON for the balance of 90 pounds. The interest was 10 pound per annum to be paid half-yearly on the 22 April and 22 October each year. The 90 pounds was to be paid in full on 22 October 1858.

George was recorded as living in Suburban North before he purchased section 20 Suburban North. This information was recorded in various Nelson newspaper articles.

Suburban North was made up of 39 Accommodation sections totalling 1, 950 acres and 10 Rural sections totalling 1,500 acres making a total of 3,450 acres in Suburban North.

THIS DEED made the Twenty second day of October one Thousand Eight Hundred and Fifty Three (22 October 1853) between GEORGE HENRY MANSSEN of Suburban North in the Province of Nelson in New Zealand Labourer of the one part and JOSEPH FOORD WILSON of the Town of Nelson Surgeon of the other part Whereas the said GEORGE HENRY MANSSEN being indebted to the said JOSEPH FOORD WILSON in the sum of ninety pounds sterling (£90) hath agreed to secure the payment thereof with interest after the rate of Ten pounds (£10) per centum per annum, in manner and at the time hereinafter particularly mentioned now this Deed witnesseth that in consideration of the sum of ninety pounds sterling (£90) so due and owing from the said GEORGE HENRY MANSSEN to the said JOSEPH FOORD WILSON aforesaid he the said GEORGE HENRY MANSSEN hereby convey and assure unto the said JOSEPH FOORD WILSON his heirs and assigns all that piece or parcel of land situated within the District of Suburban North aforesaid containing by admeasurement Thirty Five (35) acres little more or less and being part and parcel of the accommodation Section numbered Twenty (20) upon the plan of the District of Suburban North aforesaid bounded on the north by a road on the East by other parts of the same Section on the South by Section numbered Nineteen (19) upon the said plan and on the west by a road and which said piece or parcel of land conveyed and assured or intended so to be is more particularly delineated and described in the plan drawn in the margin of these presents and coloured pink Together with all the appurtenances to the same belonging To have and To hold the said piece or parcel of Land and premises with the appurtenances unto the said JOSEPH FOORD WILSON his heirs and assigns To the Use of the said JOSEPH FOORD WILSON his heirs and assigns for ever subject nevertheless to the proviso for redemption hereinafter contained (that is to say) Provided always that if the said GEORGE HENRY MANSSEN his heirs executors administrators or assigns shall and do well and truly pay or cause to be paid unto the said JOSEPH FOORD WILSON his executors administrators and assigns the sum of Ninety (£90) sterling on the Twenty Second day of October which will be in the year One Thousand Eight hundred and fifty eight (22 October 1858) and shall and do in the mean time well and truly pay or cause to be paid unto the said JOSEPH FOORD WILSON his executors administrators and assigns interest upon the said sum of ninety pounds (£90) after the rate of Ten pounds (£10) per centum per annum by equal half yearly payments on the Twenty Second day of April (22 April) and the Twenty Second day of October (22 October) in each year without any deduction whatsoever then the said JOSEPH FOORD WILSON his heirs administrators or assigns will at no time after such payments shall have been made at the request costs and charges of the said GEORGE HENRY MANSSEN his heirs or assigns reconvey the said premises with the appurtenances unto the said GEORGE HENRY MANSSEN his heirs and assigns as he or they shall appoint free from all encumbrances made done or committed by the said JOSEPH FOORD WILSON his heirs executors administrators and assigns in the meantime as witness the hands of the said parties the day and year above written.

The earlier 1849 Nelson census stated that there were no schools in the Wakapuaka district but did quote "A wooden building nearly finished, to be used for a Sunday and day school". An early school must have been completed after 1849 as I have located various information that the MANSSEN children attended Clifton Terrace School in Suburban North Nelson. (Reference Archives NZ Wellington reference SSD 3/2 repro 57 Nelson census 1849 also copy held at Nelson Museum)

George continued to appear on the 1853 – 1859 Jury lists for the Nelson district, but now his dwelling place was recorded as Suburban North.

#### Progress in Wakapuaka and Nelson

One month after George purchased the land, the new Nelson Provincial Council met for the first time. The Council started to work on the Education Act and Country Roads Amendment Act. The Education Ordinance Act was passed on 25 March 1856. George was elected to the committees for the Suburban North District Education and Roads Board (Reference New Zealand Government Gazettes, Province of Nelson issue Wednesday 30 September 1857).

The first rate Collector was Thomas DODSON the second Conrad MANSSEN when the depot was the MANSSEN house just south of the Tod's Valley corner.

At the end of the first year, the residence of the district were canvassed by the Committee for donations towards prize giving and the 1<sup>st</sup> February 1858 was a red letter day for both school. The committee met in a marquee erected by William SMALL on the Green at Ellendale for the purpose examining the scholars of both schools by Archdeacon Paul and Dr Greenwood and several other gentlemen from town.

After a most careful ad lengthy examination of the schools which gave great satisfaction to the teachers and pupils themselves prizes were bestowed on the following children.

Clifton Terrace School  $-2^{nd}$  Class = **Charles MANSSEN**

Note Charles MANSSEN was the son of Johanna and George. In the same publication as above it states that <u>Ellendale</u> was originally the property of Robert TOD and that George's stepson Charles Henry MARTIN retained the name of Ellendale for his property but documentation state that his property was known as Mount Hamburg. I believe that George and Joanna MANSSEN retained the name Ellendale for their property and that perhaps the marquee was erected on the MANSSEN property as George was involved in district affairs.

On 23 November 1858 George MANSSEN sold part of his property of section 20 to his stepson Charles Henry MARTIN. This land contained the Green Gravel Quarry known to locals as Martin's Gravel Pit.

Some documents left by Charles Henry MARTIN state that he named his property Mount Hamburg but another publication state that his property was called Ellendale. I believe that Charles's property was Mount Hamburg and that his mother and step-father's property was Ellendale which was apparently the original name given to the section owned by Robert TODD.

Two German settlers Conrad MANSSEN and C H MARTIN both settled on land around the corner where Tod's Valley joins the main road. Both men were well known in the district affairs. C MANSSEN had some to the colony in 1843 on the St Pauli with his wife Joanna. C H MARTIN opened the Gravel Pit and sold road gravel for many years. He was a well-read man who spoke English fluently but with a strong German accent. His mud cottage standing on the hillside near the pit was a familiar sight in the early part of this century (1900) and it was the delight of school children to call on their way home for a drink of cold water from Mr Martin's pump over the old well. He left the Martin Prizes to Hillside and Clifton Terrace School and to the Nelson school of Music as well as a piece of land for a public reserve. He seems to have retained the name of Ellendale for the property (originally Robert Tod's).

The Nelson Province registers at Archives New Zealand Wellington Office provided evidence that G.H. MANSSEN had written five letters to the Superintendent of Nelson between 1857 and 1862. These letters however were not traceable, they had been lost or destroyed. They contained tenders for firewood, cutting a bridle track to Pelorous, and improving the road to the new cemetery.

The Taranaki Wars broke out on the 17 March 1860 and many Nelson settlers volunteered for service. Family stories tell of George and Johanna's son Charles Frederick Henry MANSSEN, volunteering and the buttons on his uniform were kept and have been handed down the line to some of his descendants. I have not found his name on any of the 1860 volunteer lists, but I did fid him listed in the Wakapuaka Artillery Company in 1867 and have come to the conclusion that the buttons are off the Wakapuaka Volunteer Company uniform.

Nelson opened up its homes to 1,250 Taranaki refugees in September 1860, most of them being women and children. This was a very worrying time for the Nelson settlers with the Wairau tragedy not forgotten. The Taranaki refugees returned to their homes the following year in April 1861.

In the book "Early Tide to Wakapuaka" by P.V. and N.L. WASTNEY, additional information about our George MANSSEN tells of a political meeting held at the Black Horse Inn in 1863.

Mr MACKAY wanted the district to elect a vigilance committee "to watch not only over their representatives but over the School Committee and Country Road Board, and all other matters concerning the district". Mr MANSSEN said that if their representatives were not competent to look after and watch over the interests of the district without having a vigilance committee to look after them, then the best thing would be to respectfully ask them to resign.

George and Johanna's oldest daughter Caroline Louisa Henrietta MANSSEN married William PAGE on 04 April 1865 at School Suburban North Nelson New Zealand.

### The Legal Separation

On 22 September 1864 sadness was to fall on the MANSSEN household with the legal separation of George Henry Conrad MANNSEN and Johanna Catherine Elisabeth, his wife. They had been in New Zealand for 20 years, struggling together through the floods in Upper Moutere, near starvation when they returned to Nelson, breaking in their land at Wakapuaka, and the death of their daughter Eliza. It must have had a toll on their relationship. Detailed below is a copy of the Deed of their Legal Separation. I have not summarised this document, and you will draw your own conclusions.

Now this deed Witnesseth that in pursuance of the said recite agreement in that behalf and in consideration of the premises He the said George Henry Conrad Manssen Doth herby for himself his heirs executors and administrators covenant with the said William Page his heirs executors and administrators in manner following that is to say That the said Johanna Manssen may from time to time and at all times thereafter live separate from the said George Henry Conrad Manssen her husband as if she were sole and unmarried And that she shall be free from the power and command restraint control authority and government of him the said George Henry Conrad Manssen

and shall and may live and reside in such place or places and in such manner as to her for time to time shall seem meet – and that he the said George Henry Conrad Manssen shall not nor will molest or disturb the said Johanna Manssen in her person or in her manner of living nor at any time or times hereafter require or by any means whatsoever either by ecclesiastical censure or by taking out citation or process or by commencing or instituting any suit whatsoever seek or endeavour to compel her the said Johanna Manssen to cohabit or live with him the said George Henry Conrad Manssen or to compel any restitution for conjugal rights nor shall nor will for that purpose or otherwise use any force violence or constraint to the person of the said Johanna Manssen or sue or cause to be sued any person whomsoever for receiving harbouring protecting or entertaining her but that she the said Johanna Manssen may in all things live as if she were sole and unmarried without the restraint or correction of the said George Henry Conrad Manssen or of any other persons or persons by or through him means consent or procurement And further that it shall be lawful for the said Johanna Manssen from henceforth to have take and enjoy to her own separate and absolute use all such furniture clothes linen wearing apparel and the wearing apparel of her children farm utensils articles and things whatsoever which she now has or may hereafter purchased or which are or may in any manner become her property AND THIS DEED ALSO WITNEASSETH that in consideration of the covenants and agreements hereinbefore contained on the part and behalf of the said George Henry Conrad MANSSEN and for divers other good cause and considerations him thereunto moving He and the said William Page doth hereby himself his heirs executors and administrations covenant with the aid George Henry Conrad Manssen his executors and administrators in manner following (that is to say) That the said Johanna Manssen shall not at any time hereafter molest or disturb the said George Henry Conrad Manssen or require or by any means whatsoever either by ecclesiastical censure or by taking out any citation or process or by commencing or process or by commencing or instituting any suit whatsoever or in any other manner endeavour to compel him the said George Henry Conrad Manssen to cohabit or live with the or to compel any restitution of conjugal rights And further that he the said William Page his heirs executors or administrators shall and will from time to time and at all times hereafter will sufficiently save defend keep harmless and indemnified the said George Henry Conrad Manssen his heirs executors and administrators and his and their real and personal estate of from and against all and every the debt and debts which the said Johanna Manssen shall or may at any times hereafter during the said separation contract with any person or persons whomsoever and of and from all actions suits claim and demands whatsoever on account thereof AND THIS DEED ALSO WITNESSETH that in consideration of the sum of Twenty five pounds sterling this day paid by the said William Page to the said George Henry Conrad Manssen (the receipt whereof is hereby acknowledged) and also in consideration of the covenant He the said George Henry Conrad Manssen Doth hereby convey and assure unto the said William Page and his heirs All that piece of parcel of land situated within the District of Suburban North aforesaid containing by admeasurement Twenty Five acres little more or less and being part and parcel of the Accommodation Section numbered "20" twenty upon the plan of the District of Suburb and North aforesaid Bounded on the North and east by other parts of the Same Section on the South by Section numbered "19" upon the said plan and on the West by a road and which said lands and hereditaments hereby conveyed and assured or intended so to be are delineated and more particularly described in the plan thereof drawn in the margin on these presents and thereon coloured yellow Together with the Dwelling house erections and buildings now being upon the same or any thereof And all the appurtenances to the same belonging or appertaining to hold the said land hereditaments and all and singular other the premises unto the said William Page and his heirs subject to a certain Deed of Mortgage of the said premises bearing date the twenty first day of September (22 September) instant and made between the said George Henry Conrad Manssen of the one part and James Burnett of the City of Nelson in the said Province Of Nelson Gentleman of the other part for securing the repayments of One hundred pounds sterling (£100) and interest thereon at the rate of twelve pounds ten shillings (£20.10s) per centum per annum To the use of Johanna the wife of the said George Henry Conrad Manssen and her assigns during her life without impeachment of waste And after the death of the said Johanna To the use of the said William Page his heirs and assigns upon trust that the said William Page sell the said premise together or in parcels and either by Public Auction or Private contract and may buy in or rescind any contract for sale and resell without being responsible for loss occasioned thereby and may enter into execute and do all such agreements assurances and things for effectuating any such sale as he shall thing fit and shall hold the monies to arise therefrom and from every such sale (after payment thereout of all expenses) upon the trusts following that is say upon trust to pay the same equally among such of the Children hereinafter named of the said George Henry Conrad Manssen by the said Johanna his wife namely Charles Frederick Manssen, Caroline Louisa Henrietta Manssen and Mary Elizabeth Manssen as shall be living at the death of the said Johanna Manssen or shall be then dead – leaving lawful issue then living to be paid to his or their respective executors or administrators as part of his or their personal estate AND THIS DEED FURTHER WITNESSETH that for the considerations aforesaid He the said George Henry Conrad Manssen doth hereby assign unto the said William Page his executors administrations and assigns All and Singular the household goods furniture Farming Implements Chattels and other effects now being now being or which hereafter may be in and by upon the Dwelling house and on the premises hereinbefore described and intended to be hereby conveyed and assured To hold the same unto the said William Page his executors administrations or ## George and Johanna's Twilight years

I have been told that after George and Johanna signed the Separation agreement they continued to live in the same house but in separate rooms and never spoke to each other from that day.

Seven months after William PAGE made his mark on the agreement he married George and Johanna's oldest daughter Caroline Louisa Henrietta MANSSEN. Caroline and William PAGE first child, Caroline Mary PAGE, was born on the 19 February 1866. She became the first grandchild to our pioneer ancestor, George and Johanna MANSSEN. This was the beginning of the third generation of MANSSENS in New Zealand.

Wells, Esq., M.H.R. for the district of Nelson Suburbs, on Friday evening last attended a meeting of his constituents, which had been by him convened to be held at the Black Horse, Suburban-north, for the purpose of explaining the proceedings of the late session of the General Assembly. The meeting, which was well attended, was presided over by J. Mackay, Esq., who reminded the electors present that they had been called together for the purpose of receiving from their representative in the General Assembly an explanation of the manner in which he had voted upon the many questions brought before that body in its late session. He hoped they would give to Mr. Wells a patient heaving, and that, if they desired to put any questions to him respecting his votes, they would wait until he had concluded his statement. Mr Wells then addressed the meeting (various details of his address)

#### Financial Reform League

Mr. Manssen. - When the question was raised as to the consolidation of the different loans, you said it would prove of considerable saving to the colony now you say it was but an act of justice to the Bank of New Zealand

Mr Wells. - Not to the Bank of New Zealand alone, for there are other creditors. If the Government had declined the conversion as now to be carried out, and had gone upon the plan suggested by Dr. Featherston, much money might have been saved to the colony, but would it have been honestly saved?

and

<u>Mr Manssen</u>. - Did you support the Armed Constabulary Force for the North Island, though the northern members protested against it?

Mr Wells. - The Government said, if the Act were not passed they could not guarantee life and property in the outlying districts.

George did not appear on the list. It seems it was about this time George left the Nelson district. George appeared on the Electoral Rolls for the Nelson area, as he still had an interest in a property in the area mentioned in the Deed of Legal Separation. If anyone owned land in a district that they did not live in, they still had voting rights in that district. This makes it hard for anyone trying to find exactly where their ancestor lived in the early years of New Zealand. There was no trace of George in any directories.

On the 22 April 1877 at the age of 54 years, George Heinrich Conrad MANSSEN died in the Picton Hospital of Paralysis Anusarica. The duration of his illness was recorded as one year. I had great difficulty trying to find his death as it was registered under George Henry MANSEN. The death was registered on the 23 by the Hospital Warden J. KENNARD. The information he gave was "Not Known" for the details of father, mother and wife and "nil" for children. George was buried on the 24 April 1877 at the Picton cemetery. The Church of England lay reader I.A.R. GREENSILL took the service. The witnesses at the burial were I.A.R. GREENSILL and J. GARVIE, the undertaker.

The early Picton Cemetery records have been destroyed in a fire, so I could not find the plot George was buried in. There is no headstone at the cemetery bearing this name. The Diocese of Nelson could give me no extra information on George's burial. I found this a sad ending for our pioneer ancestor. George made a considerable contribution to the Nelson District in those early years of Settlement. This book will be the memorial to his memory.

George Heinrich Conrad (registered George Henry MANSON) MANSSEN died on22 April 1877 at Picton Hospital South Island New Zealand. He was born in Germany and dwelled in NZ for 30 years (arriving about 1847). Cause of death was Paralysis anussarica [sic] 1 year as certified by Dr W B TRIPE who saw him last on 22 Aprils 1877. Parent's details were unknown. He was buried on 24 April 1877 at Picton cemetery by I A R GREENSILL Church of England lay reader. Marriage and issue details were unknown. The witnesses were I A R GREENSILL and J GORRIE [sic] undertaker. The death was registered by J KENEDDY [sic] the Hospital Warden of Picton on 23 April 1877. The registrar was James ALEXANDER. (Reference RGO NZ death registration 1877 folio 541 line 25 web reg. 1877/974 Picton district registered under George Henry MANSON age 54 years born about 1823)

George was buried on 24 April 1877 at the Picton cemetery but there is no headstone bearing his name. The records of the Picton cemetery were destroyed in the Blenheim City Council fire so there is no record of where George is buried in the cemetery.

I wrote to the Archivist at the Diocese of Nelson and they stated that.

'I have searched the Picton burial register and the following is a copy of the entry'

No 85 George Henry Manson Abode Picton Hospital Buried 23 April 1877 J A R GREENSILL – layreader

'I am afraid the entry does not give plot numbers or block numbers'. (Reference Archivist at the Diocese of Nelson P O Box 100 and/or 218 Trafalgar Street Nelson)

In 1993 the MANSSEN family reunion was held at Founders Historical Park in Nelson to mark the 150<sup>th</sup> anniversary of the family's arrival in New Zealand. The committee used funds from the reunion to purchase a plaque and placed it below the headstone of Charles Frederick Henry MANSSEN at the Wakapuaka cemetery in Nelson NZ.

Unfortunately someone unknown removed the plaque from the headstone and so now there is nothing to commemorate our pioneer ancestors in either Picton or Nelson.

In 1879 Parliament passed the Act giving males over 21 the right to vote. It was not until 1893 that the women could vote. This meant I could not trace Johanna's movements. It is

always hard to trace the female members of the family. I have many details on George but so little on Johanna. We know she could read and write and was a semptress and able to make clothes for her family. Perhaps some of her handwork still exists and is held by some of her descendants. It was Johanna who registered her first grandchild, Caroline Mary PAGE. In 1882 information was gathered about the Freeholders of New Zealand and our ancestor Johanna was listed along with her eldest son:

She married 1<sup>st</sup> in Hamburg Germany to Henry MARTIN. She married 2<sup>nd</sup> in Hamburg Germany age 29 to George Henry MANSSEN. Her living issue were 2 males age 56 & 41 years and 2 females age 47 & 30 years. The undertaker of Nelson Alfred AMOS registered the death on 17 May 1889. The registrar was Rob KIRTON

Johanna Catherine Elisabeth MANSSEN, age 77 years, passed away at Wakapuaka on the 08 May 1889. The cause of death was listed as 'natural decay'. She was buried on 10 May at the Wakapuaka Cemetery in Nelson. Rev A.R. WATSON took the service. Details on the death registration stated that she was born in Hamburg Germany and that Johanna had lived in New Zealand for 46 years. Her marriage details record that she was 19 years old when she married Henry MARTIN in Hamburg Germany. Johanna's second marriage to George Henry MANSSEN was also in Hamburg Germany. Her maiden name was LISAHL and her father was a Tailor (her father could have taught her to sew). It recorded that her living issue were two males aged 41 and 56 years, and two females age 30 and 47 years. All the children's ages are correct except for the 30-year-old female. Johanna's youngest daughter Mary Elizabeth MANSSEN would have been 39 years old at the time of her mother's death. I wonder if Mary gave the details of their ages to the undertaker and made out she was younger. Johanna's death notice was found in two Nelson newspapers.
