I take this opportunity to remind you that I have already invited you to point out any way in which I can with propriety facilitate your carrying into some immediate execution the intentions of Chapeaurouge & CO in reference to the German Immigrants, and if the Suburban Sections already delivered are not all sufficiently eligible for immediate cultivation, that I could probable make arrangements to enable you to select a Rural Section at Choice No 4.

Mr **Beit** having however so distinctly disclaimed any such obligation on his part, and having unfortunately suffered serious misunderstandings to arise between himself and them which preclude the possibility of his being useful to them if he processed the inclination, I have felt it necessary to take some of them into the employment of the Company upon the public works.

I have to observe that the two first are questions, which I have been in the habit of putting either to the English Immigration Agent, or to the applicants for employment themselves, in all cases where the latter had been in private employment previous to their applying to me. In the present instance they were particularly necessary, as I had received four recent applications for employment, from labourers, who informed me that Mr Beit was indebted to them for several weeks' wages, their inability to get which was the cause of their applying for the Company employment. The third question relative to Bushels private means I put in consequence of his having informed me that he had paid a considerable sum of money into

Into Mr **Beit's** hands in Hamburg to be repaid in the Colony, no part of which he had since received, and which if he could have obtained, he would not have been obliged to apply to the Company for employment.

The Bearer Mr **Buschel** has been located for some time on our land in the Waimea, & entirely supported by us, in expectation to render him useful in our intended farming establishment there.

The proceedings of the Company officers, having in defiance of the positive engagement of the Company to their Land Purchasers, render labour for wages impracticable, we have been reluctantly compelled if not entirely to abandon, at least indefinitely to postpone, any considerable operations, and in consequence I have announced to **Buschel** that from the 16th Inst. I could only give him some employment in my family establishment here. **Buschel** has cultivated some portion of land on our sections, and is desirous to continue there but has no means of subsistence. He claims now to be admitted to the same privilege as his neighbours on Section 34 S.W. to be employed by the Company on the Public works and on similar terms.

However strongly I may condemn the course pursued by the Company Agents I am of opinion that such a deserving man as **Buschel** is fully entitled

He pointed out to me, that the expression of my opinion respecting the proceedings of the Coy. Officers, in that official application, was in called for; I think it right to explain, that the only object I had for inserting it, was, to guard myself against the charge of inconsistency, in recommending a man to participate in a description of employment, which I had frequently and loudly deprecated.

Your tardy and querulous reply of the 28th appeared to me, not only an undue interference, with the special duties of my appointment, but under concomitant circumstances, and the information already supplied in the recommendation above allowed to, as an intended and gratuitous insult. Under this impression, which is by no means removed I worded my rejoinder of the 28th which you have thought proper to return, and to which in the absence of the necessary explanations I must adhere.

Sir

I have the honor to report to you for the information of the Court of Directors of the Company that the "Skiold" 500 Tons arrived here safely on the 1st inst. From Hamburg. Amongst 140 emigrants on board there had occurred two deaths of infants and two births. The men evince a decided superiority over those who came last year in the "St Pauli".

Mr Beit waited on me in company with Mr Beniot who is The Secretary of the New Zealand Company in charge of the emigrants by the "Skiold" and I offered the latter every assistance in the power of the Company officers to afford, to secure the comfort of those entrusted to his care and a profitable occupation of land by them. At the same time I informed Mr **Beit** that I could no longer recognise him as the German Immigration Agent or communicate with Mr Benoit through him in that capacity. On the following day Mr Benoit wrote to me to say that "Under existing circumstances and after mature deliberation with his partners he could not come to any determination relative to his proceedings and should therefore defer availing himself of my offers of assistance until his plans were more matured." Upon a further knowledge, however, of the state of things here. Mr Benoit as decided on acting entirely for himself with respect to the disembarking and locating the immigrants without being influenced by Mr Beit, (who talked of the ship proceeding forthwith to Auckland under his direction) and I have now the satisfaction of informing you that they will be located on the 7 sections of land at the Waimea East allotted by exchange according to the arrangements made between Messrs Chapeaunrouge and the Court of Directors, subject to a further partial exchange in case some of the land may be found totally unavailable for agriculture. Should any such necessity occur the Resident Agent will apprise you of the steps he adopted in the selection of the land for these immigrants has been most fortunate. Its vicinity to the Town and the communication therewith by good roads combined with its proximity to the sections of several settlers, who have provided the quality and powers of the soil and with the intention of Mr Duppa, Mr Saxton, Mr Macdonald, Dr MacShane and other settlers to cultivate land in the same district render it much sought after just now.

As the German immigrants have a supply of provisions for more than twelve months, I have no doubt of their forming a thriving community to which will be attracted their countrymen who came here last year and who have been unfortunate in the selection of land in the Moutere, where their labours have been almost nugatory in consequence of its liability to inundation's and the poorness of its oil.

I have prevented any forth misunderstanding by informing our Emigrant Agent that the German Emigrants are exclusively under the care of their agent Mr Beit I have invited Mr Beit in his capacity of Superintendent to furnish me with the necessary statements of arrangement made by him during the voyage which he promised me and the fortnight having expired since boudry during which they have subsited in rations under from our stores. I have pressed Mr Beit to ether or arrangements for the future and tto explain to me this and their wishes and intentions especial as regards them future presents and location offing every facility

in my power to afford them and in pastuder and oppitunity of immediately selecting a rural section for their choice No 4 which has fallen to the Hamburg Company. Regret however to inform you that Mr Beit seems extremelly occupied with merchant affairs. Should any unforeseen circumstance prevent your departure for our settlement will you instruct me whether I am right in concluding that the German Emigrants have no claim for maintenance on employment out of the general fund at this settlement and no particular fund for their benefit arrary out of the purchase of land made by the Hamburg Company.

I feel that many of our townsmen are willing to breach between the Superintendent and the Emigrants all sorry themselves to become preoccupied partisans of the latter and that under Mr Beit promptly exits himself in a fayining and concilaty spirt to again his lessner influence with his country men the inaquity of these who have the means and who are consequally desiable settlers will by arrangement with the Captain of the St Pauli proceed elsewhere.

The Clergymen Fredere **Riemenschneider** & Joh. F H **Wohlers** and the Doctor J F **Goders** accompanying the German Emigrants on board the Hamburg ship St Pauli to New Zealand have approached me in writing & particularity requesting me to inform you by letter that great discontent had prevailed among the said Emigrants during the voyage to this Post, occasioned they say by the departure from the regulation & parish dietary Table placed in their hands by the Agent of the NZC of Hamburg previous to their embarkation. Likewise that much unconvinced has been expressed by them in consequence of their luggage & provisions being stored between decks.

The consequence of this statement can be ascertained on the arrival in Nelson should you consider it necessary.

I likewise acquaint you to the bequest was made to me by the Superintend for a survey what I granted authenticated copies of: report there upon in takes with him. It is stated to me by the Superintendent that beneficed alteration have been made here in the storage of luggage & provisions and that it is his intention to adopt a far as in practable the issue of rations in accordance with the table above attend to.

You are right in concluding that the German immigrants have no claim for maintenance or employment out of the emigration fund of the settlement. At the same time it is advisable that they should not be induced to leave Nelson for want of employment or to fall into destitution. I hope that the selection of the rural section which has fallen to the German Company will be able to induce those who have means self support to commence their contemplated operations on the land.
