"Stonestead has remained longest as a relic of old Te Marua. David Benge built it about 1860. Benge invested in Collins Creek saw-mill, with his sons six of them by now how took it over. Three years later he built a two stored, double-pitched colonial cottage which he called Stonestead, about 100 yards from the mill, alongside what is now the Main Road through Te Marua. He cleared the surrounding bush for a farm".

How do we locate the true story about the Stonestead homestead situated in Te Marua and when it was built? We begin with the folk lore stories then by researching primary source documentation the true story reveals itself.

It is important to begin the research in chronological order beginning with the history of the land in which the homestead is situated.

The land was part of Section No 111 originally recorded as the Hutt district on early survey maps. It was also records as being situated in the district of Mungaroa [sic].

As you locate the owners and occupiers of the land you follow this up with researching their family history and genealogy. Photographs are also valuable source.

We know that David eventually became the owner of Section No 111 but exactly when? Which part of Section No 111 did David and his family settle on? Which part of Section 111 was Stonestead built on?

The Blockhouse was completed by December 1860

The Golders cottage was built in 1876

The Stonestead homestead was built by David Benge and we can confirm that David and his family were resident in the Mungaroa [sic] district (Te Marua district) by 1859 and defiantly by 1864.

Perhaps we can now say that Stonestead was built in the early 1860s. What do you think?





Buck and Others - Mr Hart appeared for Mr E W Mills the plaintiff in the action, Mr Brandon for Messrs George Buck and James D Cruickshank, executors of the late Charles Mabey, of the Upper Hutt, farmer, Mr Borlase for the children of the testator and Mr Izard for Messrs Cleland judgment creditors. The facts of the case were these - Charles Mabey died in June 1864, being possessed of real and personal property, and having made a will, dated 2nd August 1838, which was proved by the executors, bequeathing to his four sons, and daughter his houses and live and dead stock in equal shares, no landed property or stock to be disposed of without consent of executors until the eldest son should be of age. The debts as proved amounted to £1,356 12s 2d, while the personal estate realized and realizable only In May 1865, Messrs Cleland commenced an action against the amounted to £700. executors for £771, and on the 18th August 1865, Edward W Mills, on behalf of himself and other creditors of the deceased who should come in and contribute rateably towards the expenses of the suit, commenced an action against the executors for the sum of £21 19s 8d, in default claiming to have the personal estate administered in the Court. The executors pleaded among other pleas in effect that they had no knowledge of the amount being due, that another action was pending, that the personal estate was insufficient to cover the debts, and that the testator had real estate, but that they were advised that they could not safely execute the trusts without direction of the Court. On the 7th October 1865 the defendants were ordered to sell the real and personal estate before the 06th of December of the same year, Messrs Cleland having obtained a verdict on the 08th September previous. On the 08th January 1866, it was ordered that the executors should pay into Court all sums in their hands belonging to the estate less legal and other expenses certified by the Registrar, and that the Registrar should report to the Court the amount of debts and the legal priorities affecting them, after which it appeared that the proceeds of real estate paid into Court altogether amounted to £694 6s 6d; that the executors had in hand £100 from the personality, and that Messrs Cleland were entitled to priority. Subsequently, however it was ordered among other things, that they should be paid out of the funds rateably with the other creditors. The questions for the Court were - Whether the Messrs Cleland were entitled to any priority over the other creditors, whether the Messrs Cleland have a priority which entitles them to exhaust the realty, if so, whether they are entitled as to, the residue of their debt to any payment in priority to other creditors out of the personality, or whether they are entitled only as to the residue of their debt to take payment thereof with the other creditors out of the personality, whether they are bound to take payment out of the mixed fund pari passu generally with the other creditors, whether having been paid a portion of their debt out of the proceeds of the realty, they are entitled to any further payment till the other creditors have been paid out of the personality. Mr Hart was addressing the. Court, when the Judges expressed their opinion that it was not shown on the case that there was a deficiency of assets, and that, therefore, the question of priority fell to the ground. The question of costs was deferred, as it was said that by saddling the children with the costs the assets might be made deficient. A Pioneer Passes - Seventy-seven years ago at Te Marua, at the old home known as "Stonestead" the "house with its quaint .steep two gabled roof, which is still standing, there was born John Thomas Benge. His father, John Benge, together with his three brothers Sam, Ned and Dave, ran a saw-mill and, when the bush was cleared, engaged in farming. Upper Hutt and its surroundings was dense forest when this band of stalwarts from Devonshire England, carved out their primitive dwellings. John Thomas, or as he became generally known, J T, was the first pupil to enrol at the Te Marua School, but being eager to go to work he left school when he had passed Standard 4. At the early age of 14 years he got a job bush felling at Ashhurst. On returning home he joined his father and uncles in the sawmilling business. At the age of 20 he married Miss Emily Collett of Mangaroa. Two sons and two daughters were born to them. His activities were next expended in running a milk round at Petone. Following this he took up farming on his own account at Mangaroa. Here he had the misfortune to have his home burnt, the old-fashioned wood-shingle roof being ignited by a spark from a railway engine. A new dwelling was built, which was family home until 1907 when the farm was disposed of and Upper Hutt became the headquarters. At this time the late Mr Frank man was engaged in sawmilling at Akatarawa and again Mr Benge rallied to a call for help in handling & tough bush proposition. His next venture was that of blacksmith coachbuilder and undertaker, the shop being located where Gibb's Chemist Shop now stands, but transferred later across the street to the premises so long occupied by the late Mr P Robertson. In 1911 Mr Benge entered the business partnership with Mr J A Hazelwood, in which he continued until the business changed ownership in 1944. In 1921 he took a business trip to U.S.A. which proved of success in obtaining of agencies which later on resulted in his making trips time after time to all principal towns of New

Zealand. Such was his remarkable strength and energy that since his retirement from business three years ago he chose to take on the breaking up and .draining of the swampland at Wallaceville Valley (an area of 782 acres), and was actively engaged in this work until two weeks before his death on Friday last. He was a man of genial and loveable disposition and a great lover of little children, never missing an opportunity to greet them with his bright smile and appropriate words. First and foremost of all his varied interests and activities were his long years of devoted service in the cause of the Church at the Gospel Hall. Here as an elder and member for close on half a century he was "a man greatly beloved." His funeral service was one of the most largely attended that our district has ever known. The service at the Gospel Hall was conducted by Mr J A. Hazelwood and Mr A E Salisbury and at the Akatarawa Cemetery by Mr. W N Pepperell and Mr S A Edwards. The deceased leaves a widow, two daughters, one son, thirteen grandchildren and six great grandchildren. Among those present at the funeral were Mr J Maher MP, and Mrs Maher, Mr J Blewman Mayor of Upper Hutt, Councillors K S and J Purvis, Mr K of J A numerous members of the farming community, including the President of the local Federated Farmers, Mr Les Andrews, Kenneth Douglass, Mr B M Wilmshurst, town Clerk; also a large number of the business community.

The Passing of Mr J T Benge - When Mr. Benge was laid to rest last Sunday about 80 cars followed the cortege. After a busy life of 78 years he has laid aside his trials and is in peace at picturesque Akatarawa, where the magic brush of Mother Nature has painted a picture truly beautiful to behold, the river sings a merry song ever hurrying to the sea and the night owl calls to his mate as the darkness comes over the earth. He was affectionately known by the people was a lover of little children. How often have we seen him bending down to shake the hand of some tiny tot or say a cheery word peeping into the pram to greet a little new strange? We shall miss the happy smile and nod of Mr J T Benge. -Ruakawa

"The youngest of the John Benge - Annie Wilkins family was a daughter Edith Rose who died when she was about 12 months after an accident with scalding milk. Her father is said to have been so heart-broken that his spirit became a <u>Stonestead ghost</u>, lamenting the loss of his baby daughter. "Mrs Leonie Bold, living in the house in 1990, told the writer the family understood the baby girl was buried in the orchard, out from the front door. Three enormous old pear trees still produced prolifically. The Bolds could only say that if a ghost was responsible for some of the things that had gone bump in the night since they moved in, it must be a friendly ghost. Leonie said "It's such a warm friendly house. I could never be frightened in it". It was possible to construct a logical explanation or the thing that had caused them to wonder. Sounds between the walls

could be linked to opossums that had got in. A boy pushed down some stairs could have been helped on his way by a brother. At first they thought the ghost didn't like some of the changes they were making, then they realised the ghost had got to know them, and approved their use of the house. He was, after all this time, a relaxed, happy ghost".





A very pleasing ceremony was performed on Wednesday 22nd ult., when Frederick Thomas only son of the late Mr Thomas Heard pf Balance was united in the bonds of matrimony to Charles Blanche (Lottie) of Laurel Villa Upper Hutt. The wedding took place at "Stonestead" the country residence of the bride's parents. The Rev George Bond of Newtown, an old and valued friend of the bridegroom's family preformed the ceremony in a Marquee erected in front of the house for this purpose. It was beautifully decorated with flowers and lycopodium. The bride was given away by her father Mr J Benge. Mr W Woodley acted as best man and Mr B Benge as groomsman.

The bride looked very handsome in a dress of blue and fawn shot voile velvet, Paris lace, and orange blossoms, a lovely embroidered veil and wreath of orange-blossoms. She carried a handsome shower bouquet of white Azaleas and clematis. There were six bridesmaids, Miss E Benge sister of the bride and Miss N Heard sister of the bridegroom both looked charming in cream lustre dresses trimmed with broche satin ribbons and lace. They also wore wreaths and veils and carried lovely shower bouquets of azaleas and snowdrops.

Miss Rachel Mabey nice of the bride and Miss G Jackson niece of the bridegroom look very pretty in pink spotted muslins trimmed with lace and ribbons. They also wore wreaths and veils and carried shower-bouquets of pale pink azaleas and clematis. Then came two sweet little tots with golden curls, Blanche Mabey and Wilma Benge nieces of the bridge, in dainty white frocks and wearing wreaths and veils and carrying crooks entwined with daises and ribbons. A prettier bridal is very rarely seen. The bride wore a gold brooch set with pearls and rubies the gift of the bridegroom. The bride's gift to the groom was a pair of handsome gold sleeve links. Each of the bridesmaids wore a very pretty gold brooch the gift of the bridegroom. The weather was perfect and the scene was a gay and festive one. Cake and wine were partaken of in the marquee, when the usual toasts were given and responded to, the Rev G Bond giving good and kindly advice to the young folks in a very happy speech.

After the toasts and congratulations were over all adjourned to the large dairy which had been transformed into fairy-land with ferns, flowers and abundance of lycopodium.

The table and other decorations were most artistic and were under the supervision of Mrs J C Mabey and Miss Ross of Taita. Over 50 guests sat down to a most sumptuous breakfast and after a most enjoyable time the happy couple left amidst showers of rice and flowers, to take train to Wellington where the honeymoon is to be spent. The bride's travelling dress was a handsome fawn cravenette [sic] cloth strapped with silk to match, tucked white figured silk vest picture hat of burnt straw with cream roses, lace and silk. The presents were too numerous to mention and many of them were very costly.

Mr and Mrs F Heard intend residing in Balance in which place Mr Heard may be called a pioneer, his family being the first to reside in that township. We wish Mr and Mrs Heard every good wish, health, prosperity and happiness.



He was managing director of the Bloomfield Farm Company in the Hutt Valley, chairman of directors of the Scoullar Company, and a director of the Wellington Investment Company. A Pioneer Passes - Seventy-seven years ago at Te Marua, at the old home known as "Stonestead" (the house with its quaint .steep two gabled roof which is still standing), there was born John Thomas Benge. His father, John Benge, together with his three brothers Sam, Ned and Dave, ran a saw-mill and, when the bush was cleared, engaged in farming. Upper Hutt and its surroundings was dense forest when this band of stalwarts from Devonshire, England, carved out their primitive dwellings. John Thomas, or as he became generally known, "J.T.," was the first pupil to enrol at the Te Marua School, but being eager to go to work he left school when he had passed Standard 4. At the early age of 14 years he got a job bush felling at Ashhurst. On returning home he joined his father and uncles in the sawmilling business. At the age of 20 he married Miss Emily Collett, of Mangaroa. Two sons and two daughters were born to them. His activities were next expended in running a milk round at Petone. Following this he took up farming on his own account at Mangaroa. Here he had the misfortune to have his home burnt, the old-fashioned wood-shingle roof being ignited by a spark from a railway engine. A new dwelling was built, which was the family home until 1907 when the farm was disposed of and Upper Hutt became the headquarters. At this time the late Mr Frank Whiteman was engaged in sawmilling at Akatarawa and again Mr Benge rallied to a call for help in handling a tough bush

proposition. His next venture was that of blacksmith coachbuilder and undertaker, the first shop being located where Gibb's Chemist Shop now stands, but transferred later across the street to the premises so long occupied by the late Mr P Robertson. In 1911 Mr Benge, entered the business partnership with Mr J A Hazelwood, in which he continued until the-business changed ownership in 1944. In 1921 he took a business trip to U.S.A. which proved of success in obtaining of agencies which later on resulted in his making trips time after time to all principal towns of New Zealand. Such was his remarkable strength and energy that since his retirement from business three years ago he chose to take on the breaking up and .draining of the swampland at Wallaceville Valley (an area- of 782 acres), and was actively engaged or, this work until two weeks before his death on Friday last. He was a man of genial and loveable disposition and a great lover of little children, never missing an opportunity to greet them with his bright smile and appropriate words. First, and foremost of all his varied interests and activities, was his long years of devoted service in the cause of the Church at the Gospel Hall. Here as an elder and member for close on half a century he was a man greatly beloved. His funeral service was one of the most largely attended that our district has ever known. The service at the Gospel Hall was conducted by Mr J A Hazelwood and Mr A E Salisbury and at the Akatarawa Cemetery by Mr W N Pepperell and Mr S A Edwards. The deceased leaves a widow, two daughters, one son, thirteen grandchildren and six great grandchildren. Among those present at the funeral were Mr J Maher M.P. and Mrs Maher, Mr J Blewman Mayor of Upper Hutt, Councillors K S Geange and J Purvis, Mr K Arthur present manager of J A Hazelwood & Co, numerous members of the farming community, including the President, of the local Federated Farmers, Mr Les Andres, Sir Kenneth Douglass, Mr B M Wilmshurst Town Clerk; also a large number of the business community.

The Passing of Mr J T. Benge - When Mr. Benge was laid to rest last Sunday about 80 cars followed the cortege. After a busy life of 78 years he has laid aside his trials and is in peace at picturesque Akatarawa, where the magic brush of Mother Nature has painted a picture truly beautiful to behold. Nearby the river sings a merry song ever hurrying to the sea and the night owl calls to his mate as the darkness comes over the earth. "J.T." as he was affectionately known by the people, was a lover of little, children. How often have we seen him bending down to shake the hand of some tiny tot or say a cheery word peeping into the pram to greet a little new stranger? We shall miss the happy smile and nod of Mr J T Benge.



The 24 April 1958 Upper Hutt Leader reads "A Te Marua landowner has been prevented from cutting up a block of land (etc.) - the subdivision was proposed by Mr C B Molloy". Around 1963 the sections were advertised for sale. Eric (Baldy) Alexander was the Contractor for the Molloys Road development.



One ground floor bedroom was just about in its original state, with layers of wallpaper peeling away, authentically, in a corner.

Kevin BOLT Eight years later when it came on the market, he bought it again, and a year later, he and his partner Yvonne opened Stonestead Devonshire Teas in the former garage. A modern cottage houses another Bolt business "Sawmillers Quiltery" shop.

Ghost of Stonestead

"The youngest of the John Benge - Annie Wilkins family was a daughter Edith Rose who died when she was about 12 months after an accident with scalding milk. Her father is said to have been so heart-broken that his spirit became a <u>Stonestead ghost</u>, lamenting the loss of his baby daughter. John Benge died suddenly of apoplexy on 16th August 1906 aged 64 years". (Reference Upper Hutt – The History by J a Kelleher page 164)

"Mrs Leonie Bold, living in the house in 1990, told the writer the family understood the baby girl was buried in the orchard, out from the front door. Three enormous old pear trees still produced prolifically. The Bolds could only say that if a ghost was responsible for some of the things that had gone bump in the night since they moved in, it must be a friendly ghost. Leonie said "It's such a warm friendly house. I could never be frightened in it". It was possible to construct a logical explanation or the thing that had caused them to wonder. Sounds between the walls could be linked to opossums that had got in. A boy pushed down some stairs could have been helped on his way by a brother. At first they thought the ghost didn't like some of the changes they were making, then they realised the ghost had got to know them, and approved their use of the house. He was, after all this time, a relaxed, happy ghost".

Question was the children and/or children buried on the Stonestead property?

John BENGE born 18 October 1841 Lower Hutt New Zealand died 16 August 1906 New Zealand married 1867 New Zealand Rose Anne (Annie) WILKINS born 1851 place unknown died 1933 New Zealand. They had 10 children but sadly lost two young children. Their son Leonard Bertram age 11 months accidently died of burns from a kettle of boiling water on 02 April 1881. Their daughter Edith Rose age 19 months died after an accident with scalding milk in 1886.
