Around 1965 the Brown Owl shopping centre was established in Akatarawa Road. It is not known when the Brown Owl Fisheries business opened or who the first proprietor was. The shop was later situated at 8 Akatarawa Road in the Brown Owl shopping centre.

I was told that a Mr Jenkins or Mr Jarvis owned the Brown Owl Fisheries shop. It was once the last shop at the end of the building but was relocated to the first shop after the Post Office was closed. I have been unable to confirm if either Mr Jenkins or Mr Jarvis was the proprietor of the Brown Owl Fish and Chip Shop.

There was also a mention of a Mr Lakis at the Brown Owl Fisheries shop. I have been unable to confirm who Mr Lakis but believe he may have been Foundoulakis.

I was also informed that Ari [sic Harry] Foundoulakis a Greek formerly of Clouston Park Fisheries became the proprietor of the Brown Owl Fisheries shop. Harry's real Christian name was Charalambos.

The 1987 Heretaunga Electoral Roll confirmed that Harry Foundoulakis resident at 96 Clouston Park Road was a Shop Proprietor

On the 10 July 2001 Harry handed Mrs Jacky Hunt her fish and chips parcel and as they were both walking towards the doorway of the shop Harry collapsed. Mrs Hunt's children were sitting in the car waiting for their mother to return with their fish and chips when this all happened. She immediately phoned 111 then began CPR until help arrived then she went home. Later she was informed that Harry had a massive heart attack and died before hitting the ground. The next day Mr Jacky Hunt placed flowers next to the shop.

Charalambos Foundoulakis age 53 businessman died 10 July 2001 and was buried at Akatarawa cemetery plot 401 area plaque 2 denomination Greek Orthodox. Headstone - In loving memory of Charalambos Foundoulakis 24.03.1948 – 10.07.2001 loved husband best friend & soul mate of Barbara cherished and loving dad of Spyridon, Efstratios, Ioannis & Kyriaky. A mighty oak has fallen.

## Central Milk Bar & Restaurant Ltd

Comment – The Central Milk Bar & Restaurant Ltd situated at 124 Main Road may have served fish and chips on their menu but I do not think it was a fish and chip shop.

The Central Restaurant recorded as a Fish merchant's retailer only appeared in 1970. All other records recorded it as the Central Milk Bar & Restaurant Ltd.

## **Thomas COOPER**

In 1911 Thomas Cooper was recorded as a fruiterer and had fresh fish and smoked fish for sale. This is the first record of a fish shop in the Upper Hutt district.

In 1914 Thomas Cooper sold the business to Louis Stanburg Schonfelder later known as Louis Stanburg Tremayne.

### Fish Truck & Fish & Chip Stall

In 1946 Richard Ophir Blackwell established a business driving a truck around the Upper Hutt district selling fresh fish. It was sometimes referred to as a Fish Stall. His late son told of how the business flourished at the beginning. A few years later the locals stopped buying fish from the truck and purchased the Friday fish from the fish and chip shops owned by Catholics. Richard closed the business around 1954.



Upper Hutt Leader 28 February 1946

That the Council agreed at their last meeting to grant permission for a person to sell fresh fish in the Borough daily, also to operate a fish and chip stall from 5 pm to 7 pm each evening. That this is yet another interesting matter to watch as it was not long ago a lot of trouble was caused by a pie-cart. That as one Councillor pointed out it would mean fresh fish for the people.

## Food Fish and Chips

Food Fish and Chips is situated on the corner of 81 Ararino Street and 32 Tawai Street. The building was once occupied by a Dairy. Many years later the Dairy became a Fish and Chips Shop but the opening date is unknown.

The Food Fish and Chips business is still operating on the corner of Ararino Street and Tawai Street in Trentham. The name of the proprietor is unknown.

## Frank's Restaurant Limited – 1<sup>st</sup> business

Around August 1952 Frank and Gladys Elizabeth Jurisich purchased a fish and chip business situated in the Askew Building on Main Street and named it "Frank's Restaurant Limited". This was their 1st business in the Upper Hutt district.

The Maidstone Restaurant was situated in the Askew Building in the Main Street of Upper Hutt. It is not known who the proprietor of the Maidstone Restaurant was. The next proprietor was Gwendoline Young and the shop then became known as Gwen's Fish Shop & Restaurant. The following proprietors were Frank and Gladys Elizabeth Jurisich and the shop became known as Frank's Restaurant Limited. In 1955 Wilhelm Theodore (William) and Maria Sinai became the proprietors and they renamed the shop to Upper Hutt Fish Supply Limited.

Last Friday Mr A A McLachlan S.M. awarded Frank Jurisich Fish Shop and Restaurant Proprietor £150 damages and costs for breach of covenant by Mrs Gwen Young Restaurant Manager. Counsel representing Mr Juriaich stated that by arrangement in August 1952, plaintiff purchased a business in Upper Hutt, known as Gwen's Restaurant from defendant, on conditions that she did not operate any similar business in the district for 5 years. On 23 February 1953 Mrs Young committed a breach by opening a place under the name of "Daphne Cookery" in the same district. In reply to questions by Mr Smythe counsel for Mrs Young, Mr Jurisich stated that when they signed the agreement, the purchase price was £3,500 and he was surprised when the Daphne Cookery opened up. Before Mrs Young commenced duties in the Daphne Cookery she opened the shop as a florist but on 20<sup>th</sup> February an advertisement appeared in the local paper announcing the opening of the "Daphne Cookery"

### Scoops Fish & Chips Shop

The Scoops Fish & Chip shop on the corner of Ward Street and Miro Street in the Trentham district was originally a Butcher shop owned by Gear Meat Company.

The previous fish and child shop was closed for some time after major fire damage to the building. I do not know what the name of the previous fish and chip shop was.

It was some time before the shop was repaired but it was eventually re-opened under the name Scoops Fish and Chip shop. I do not know who the proprietors are.

### Silverstream Fish Market – Silverstream Fish Supply

Around 1956 the Silverstream Fish Market was situated on Main Road Silverstream opposite St Patricks College. It is not known when the business was established or who the proprietor was.

### **South Pacific Fish Supply - Whakatiki Fish Shop**

Around 1963 Ruedolf (Rue) Wiley established the South Pacific Fish Supply shop often referred to as the Whakatiki Fish and Chip shop. The business was situated on 272 Main Road renamed 681 Fergusson Drive next to the former Gear Meat Company building situated on the corner of Whakatiki Street and Ferguson Drive.

Around early 1955 the new Brooks Buildings on Main Road now Fergusson Drive near the Trentham School was completed and various shops opened for business including a butchers shop.

In the Trentham shopping complex there are now 2 shops that sell fish and Chips. The Oyster Palace situated at 579 Fergusson Drive and Imperial Chinese Takeaways situated at 581 Fergusson Drive both in Trentham north of the Trentham School.

Comment – I have been unable to locate additional information about the 1951 Trentham Fish Shop or who the proprietor was.

## Upper Hutt Fish Supply

The Upper Hutt Fish Supply shop was once situated on Main Road near the corner of Pine Avenue in Upper Hutt central. The evidence proved that Trifton or Frifton Poulas was the proprietor of the Upper Hutt Fish Supply shop.

Mr Trifton Poulas was recorded as a fishmonger residing in Alexander [sic Alexandra] Street in the Electoral Roll dated 1938, 1941 and 1949.

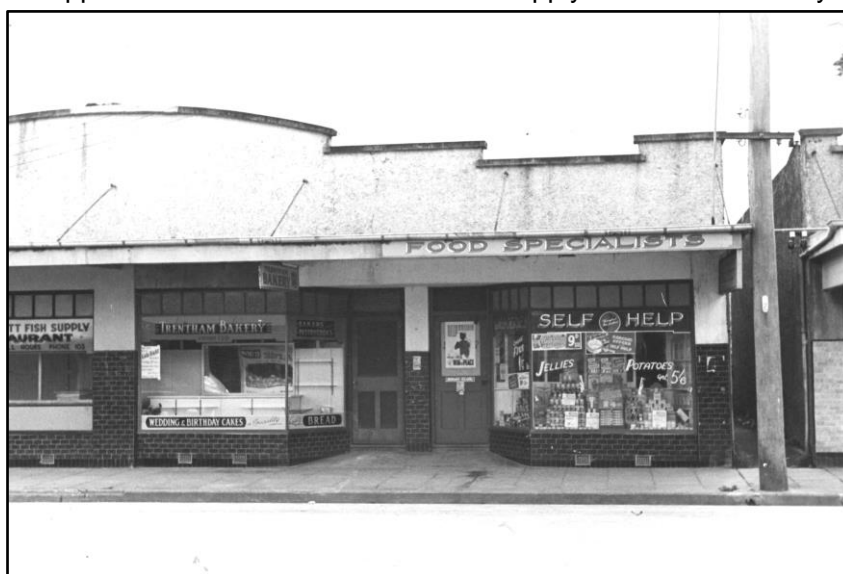
