#Wallaceville Resident Killed - A motor accident which occurred on Mangaroa Hill late on Friday night last resulted in the death of Mrs Mary Alexander of Wallaceville. From accounts it is learnt that a motor car containing three passengers deceased her son Mr Henry Alexander farmer of Wallaceville and Mr J Mahar left Upper Hutt on Friday evening for Mangaroa Station. After the car began to make the ascent about 10.40 o'clock it was discovered that the benzine was low and to obviate the trouble the car was backed up the hill. In the darkness it ran over a bank and fell about 40 feet. Mrs Alexander was killed and her son was injured. He is reported to be progressing favourably. Mrs Alexander's

#Shocking Motor Fatality - Farmers wife killed - Car goes over a bank - (By Telegraph own correspondent) Wellington this day - Mrs Mary Alexander wife of Mr Henry Alexander famer of Wallaceville was killed instantly by the capsizing of a motor car which fell over an embankment on the Mangaroa Hill road and dropped into a gully about six feet below. Mr Alexander who was driving the car sustained injuries to his skull and chest. Another occupant of the car Mr James Maher farmer of Mangaroa escaped injury by leaping from the car before it toppled over. It is stated that the car had climbed some distance up the hill when it came to a sudden stop owing to the benzine supply running down. The driver thought he could meet the situation by turning the car and he did so proceeding uphill for about five chains and hugging the bank. A rut in the road caused another stoppage but the car was got moving again. Suddenly however it shot towards the embankment. Mr Maher anticipating the worst had opened the door and as the car left the road he jumped clear. He called to Mrs Alexander to follow him but it was then too late for the car had gone right over the bank. Mr Maher got down the bank and found the car lying across Mr Alexander's chest. Mr Alexander was alive and was removed to his sister's home at Wallaceville.
