Garden Fete - A Successful Function - A most successful garden fete in aid of the Upper Hutt Plunket Society's funds was held in the beautiful garden and grounds belonging to Mrs Balcombe Brown at Maori Bank, Upper Hutt, on Saturday afternoon, when there was an excellent attendance. Mrs Balcombe Brown had not only lent the garden for the party, but the house also, and a car to bring and take visitors to the train. Afternoon tea was served in two rooms. On the verandah was a happy crowd of children, who were highly entertained by the Rev Mr Haight with ventriloquism, the various stories, etc., being received with great joy. A Christmas tree and bran tub were also placed on the verandah, while the garage was in use for cakes and produce, and, with the ice cream stall, which was outside, did a fine trade. The fete was opened by Mrs Macarthy Reid, who stated that £295 was owing on the Plunket rooms. Mrs. Balcombe Brown and Mrs Macarthy Reid had promised £100 each if the remaining £95 was raised by next March, and it was towards this end that the fete was held. Bouquets were presented to Mrs Reid, Mrs Robertson (Mayoress of Upper Hutt), and Mrs Leckie (president of the local Plunket branch). The stallholders were - Cakes Mrs. Macarthy Reid, Mrs Blakeley and Mrs Tweed, produce Mesdames Mumby, Leighton, and E Campbell; ice creams Mesdames Nicol and Jones, bran tub Mrs O'Connor, Christmas tree Mesdames Youngman, Hanron, and Young, afternoon tea Mrs Dick, Miss O'Hara Smith, Mrs Thomas, and Miss Grensin. "Father Christmas" was impersonated by Mr Chapman, and the Upper Hutt Band gave its services and played on the lawn. Mrs. Roger (honorary secretary of the local society) was in charge of all arrangements. There was a competition among the children for decorated dolls prams, etc., and the prizes were won as follow, Flower-trimmed pram, Miss S Shepard 1; Miss Blackley 2,. Paper trimmed pram Nola Jameson 1, Jean Campbell 2, Decorated tricycle Vera Marshall. Prizes were donated by Mesdames Deller, Kitchen, and Kemp. Competitions of different kinds were held. One for a Teddy bear was won by Captain Orr-Ewing, and another for a quilt was won by Mrs Mundy of

Lower Hutt. Very hearty thanks were accorded to Mrs Balcombe Brown, Mrs Macarthy Reid, and all who had assisted to making the fete such a success.

#New Zealand Wedding - Balcombe Brown – Guy – (from our own correspondent) London March 29 – At the city church of All Hallows, Barking-by-the-Tower, a wedding of New Zealand interest took place. The bride groom was Mr Denis Roberts Balcombe Brown, BA Oxon, only son of the late Edward Balcombe Brown and Mrs E M Balcombe Brown, of Amherst, Maori Bank, Wellington. The bride was Miss Eila Mary Guy, only child of Mr and Mrs R G Guy, of Hamilton, Waikato. The bride recently arrived from New Zealand, but her parents, unfortunately, were unable to come to England for the wedding as they could not be so long away from their home. In the absence of Mr Guy the bride was given away by her godmother, Miss Maude Wheeler (Wellington), who had been a bridesmaid to the bride's mother. It was desired that the wedding should be a quiet one, a few friends only being invited. The church, which is usually referred to as "Toc H Church," had been beautifully decorated for the Easter festival, and the flowers remained for the wedding - a choral ceremony - which was performed by the Rev E C Crosse MA (late headmaster of Christ's College). The bride was in a Patou model dress of parchment ring velvet, with a coatee of gold embossed georgette, and touches of the same on the dress. Her veil of Old Limerick lace had been worn by three generations in the bridegroom's family. It was a present in 1857 by the father of the late Earl Roberts to the bridegroom's grandmother Miss Cynthia Fell (Chingford, Nelson), who was at Nga Tawa (Wellington Diocesan School for Girls) with the bride, was in attendance, wearing a dress of apricot charmeuse with coatee of a deeper shade. The best man, Mr T V Scrivener BA Oxon, was a contemporary of the bridegroom at Oriol College. During the progress of the service the hymn, "O Perfect Love," was sung, and Mendelssohn's Wedding March was played as a recessional by Mr Bowden, organist of the church. Among those present were, Mrs T Grenfell Morgan (Wellington, a sister of the bridegroom), who travelled to England with the bride, Mrs Balcombe Brown (mother), Miss Wheeler, Mr and Mrs Lindo Levien (Wellington), Miss E M Townsend (Nelson), Mr and Mrs Clifford and Miss Eileen Clifford (Wellington), Miss Mae McRae (Wairoa), and Mr Maurice Smith (Pahiatua). On the night of Easter Monday (the eve of the wedding), Mrs Balcombe Brown held a reception with dance at Dartmouth House, in honour of the bride. #Obituary - Death of Mr W R E Brown - An early Wellington resident has passed away in the person of Mr WR E Brown, who died at his residence Tinakori road, on Saturday, after a brief illness, in his seventy-eighth year. The deceased was the son of Major Edward Brown, of the 63rd Regiment, and his mother was the daughter of Colonel John Balcombe, of Reading. As a youth he was educated for the army, but, having a fondness for travel, he abandoned this and went to Cape Colony on a hunting expedition. After returning to England for a brief sojourn, he came to New Zealand on the barque Surge, arriving in Wellington in December 1855, with his wife, the daughter of the Rev John Tucker of Keynsham, near Bath, whom he married the previous year. Shortly after his arrival Mr Brown took up land on the old Ohariu road, near Johnsonville. In 1868 he was appointed Clerk to the Bench in Wellington, riding to and fro daily. In the Maori trouble that arose the following year, necessitating the enrolment of the militia, he was appointed captain of a town company, which however, he had to relinquish under a regulation requiring Civil Servants to resign their commissions. Mr Brown was later appointed Curator of Intestate Estates and Inspector of Bankruptcy, holding these in conjunction with his other duties. On the abolition of these posts he took up the duties of private secretary to Mr (afterwards Sir) William Fox, then Premier, and later was appointed Secretary to the Cabinet, which position he held under the Premierships of Sir William Fox, Mr Waterhouse, and Sir Julius Vogel, subsequently relinquishing the post to take that of Registrar General, which he held until his retirement in 1892. His wife predeceased him by two years. Deceased leaves the following sons and daughters Mr Edward Balcombe Brown, of Messrs Brown and Dean, Mr F B Brown of Wanganui, and Mrs William Taylor of Feilding, all 1 of whom are at present on visits to Europe; Mr C W Brown lately of Shannon, who was staying with his father at the time of his death, Mrs A E Knight of Napier, and Mrs Brownlow Horrocks of Parnell Auckland. - NZ Times reference Fielding Star newspaper 09 September 1907 page 2
#Mr William Robert Edward BROWN the ex-Registrar-General and the only surviving son of the late Major E Brown, 86th Regiment was born at Reading, Berks England in 1830 and was educated in Jersey Schaffhausen and the London University College School. When twenty-five years of age, he sailed with his wife, a daughter of the rector of Keynsham near Bath for New Zealand arriving in Wellington in December 1855. Turning his attention to framing pursuits Mr Brown bought a homestead near Johnsonville where he lived till 1874, subsequently residing in Wellington. In 1863 he accepted the position of Clerk to the Bench at the District Court. Three years later he became Clerk to the District Court, Curator of Intestate Estates and Inspector in Bankruptcy. Estates for the Colony. In 1873 Mr Brown was appointed Registrar General which position he filled until 1892, when he retired from a lengthy service to the Colony on a pension. In 1860 at the time of the Maori Wars, Mr Brown entered the militia as Lieutenant and four years later obtained the rank of Captain. Mr Brown is a member of the New Zealand Institute. #Death of Captain Baillie - The death occurred last evening off the Hon Captain William Douglas Hall Baillie, MLC, at the ripe age of 95 years, at the residence of his daughter, Mrs Balcombe Brown, Upper Hutt. The late Captain Baillie, was one of the older school of politicians, a right worthy resident of the Marlborough Province and a soldier, with a long record of service in India in the years when campaigning, spelt bitter work indeed. He was the last of the life members of the New Zealand Legislative Councillors, his service as a Legislative Councillor dating back to 1861. He had been an invalid for some time past. He came of an old Scottish family, which moved overseas to Brunswick Canada, where he was born on 22nd February 1827. He was educated at the Military School Woolwich, and at the age of nineteen he entered the British Army as ensign with the 24th Foot and went to India, where for six years he served under Sir Hugh Gough and Sir Colin Campbell, afterwards Lord Gough and Lord Clyde. Ensign Baillie was in the Punjab Campaign of 1848-49, and at the battle of Chilian Wallah his regiment was much cut up by the Sikh Army under Shere Singh. At the end of 1853, Lieutenant Baillie returned to England, and obtained promotion to the rank of captain in 1854 and was commandant at Chichester until he came to New Zealand in the ship Oriental in 1857. Captain Baillie settled in the Wairua district, where he remained for several years, but he afterwards disposed of his run and lived on his estate near Picton. For over thirty years he was connected with the volunteer movement, and for the greater portion of that time he was Colonel Commandant of the Marlborough Volunteer Forces. In 1881 he accompanied the expedition to Parihaka. His political career commenced in 1861, when he was returned as a member of the Marlborough Provincial Council, in which he sat until its abolition in 1876. He was the second Superintendent of the province, holding office in 1862-63. He was appointed to the Legislative Council in 1861, and for twenty two years consecutively he was elected Chairman of Committees. For very many years he was a member of the Marlborough Education Board. His wife died three years ago, and of his three sons but one, Mr W Baillie survives him.
