After living in Victoria for about four years John and Christina arrived in the Dominion in the ship Bella Schones and landed on the beach opposite Barrett's Hotel in Wellington New Zealand. They then took up land in the Upper Hutt district.

Mr Izard opened the case and called - Tena Wheta - I live at the Hutt I know the prisoner I recollect the 18th April last I saw the prisoner on that day near our place about 5 o'clock in the morning he was driving some cattle that is all I saw at that time I saw him set a light to the hay about 7 o'clock he set fire to the hay-stack with a fire stick a fire was burning near the sack from which he got the fire stick I saw him go and fetch the fire stick and set fire to the hay it belonged to Mr Perry the hay stack was burning and the boy ran away and E Paua went to call the owner many of us saw it we were only a short distance from the boy. Cross examined by Mr Allen I knew the boy before I had seen him that morning before, we lived nearer the stack than where the boy was the first time, the Boy was driving the cattle he passed our place and drove them past the hay stack he did not see us the first time there were three men and several women present, I saw him again between 5 and 7 the boy was there all the time looking after the cattle when the stack was burning he ran away he left the cattle to set fire to the hay stack. I think it was on Monday the fire was a big one, had been burning for some time and was about nine yards from the stack. Mr Perry set a light to the logs the boy knew that the Maori were present about 7 o'clock, he talks Maori I called out Perry's stack is burning the boy went home to his father's house. E Kraitua and Piripi Tiri Kingi, two other natives were examined and corroborated the evidence of the first witness. Christiana Hagan I am the mother of the prisoner he is turned 10 years of age he can read but not write he has been taught the "belief" and he understands religion very well for his age. Mr Allen on behalf of the prisoner addressed the Jury at some length and quoted law authorities showing that children between 7 and 14 years of age cannot be convicted of certain offences when no malice or craftiness was shown. The Crown Prosecutor then withdrew the case and his Honor directed the Jury to return a verdict of "Not guilty" and after admonishing the boy he was discharged from custody reference National Library of NZ papers past New Zealand Spectator and Cooks Strait Guardian 08 June 1864 page 3

defendant was not quite sober although he could not be called drunk. To Mr Buckley was sure that the parties in the room were not all travellers several of them might have had their meals in the house. Sircom for instance but Valentine was not quite in a fit state to have been served with drink. Richard Hagan deposed to having been in the hotel on the day referred to he went in on business with Mr Wilkins and when talking with him Valentine offered to shout and he accepted a drink immediately on which the constable came in. None of them were drunk although they were slightly "merry". Valentine was not drunk and witness did not see him tumble off his horse. #Law Reports Supreme Court Fortunes of a Hutt Farm Intricate deal - Practically the whole day was occupied in the Supreme Court yesterday in hearing a case in which an Upper Hutt farm of 1935 acres formed the centrepiece. The plaintiff was William Charles Alfred Dimock, and the defendants were Mary Ann Wilkins of Upper Hutt, and the Public Trustee. His Honour the Chief Justice was on the Bench. It appeared from the proceedings that Mrs Wilkins had been owner of the property. In March 1910 there were three mortgages on the land one of £2900 to the Public Trustee, one to Dimock on which £360 was owing and a third of £170 to Veitch and Allan. In addition to these Mrs Wilkins had other liabilities. Dimock had been about to exercise his powers under the mortgage and it was thought that had he done so. Mrs Wilkins would have been left with nothing. Instead of his exercising those powers however, Dimock and Mrs Wilkins had entered into certain arrangements whereby she transferred the whole property to him for a consideration of £4100, including the total amount of all mortgagees, with interest etc. and all the liabilities. At the same time she got two leases back one a house and four acres (for the period of her life) which she was allowed to hold at a nominal rental and also the rest of the property was leased to her for her lifetime at a rental consisting of the payment of certain interest charges. At that time the whole property was valued at over £10,000. In August 1910 (after Dimock had acquired it) a special Government valuation was made and the land was assessed as being worth £7899. About a year ago the Public Trustee was appointed manager of Mrs Wilkins's estate under the Aged and Infirm Persons Act, 1912. The appointment was made on the ground that she was unable through excessive dunking to manage her affairs. The present proceedings were commenced by Dimock and were for cancellation of the lease of the farm on the ground of non-payment of rent and breaches of covenant. The Public Trustee counter claimed that in spite of the form of the transaction, the relationship between Dimock and Mrs Wilkins was that of mortgagee and mortgagor and that Mrs Wilkins was entitled to redeem her property on repayment to Dimock of the total amount owing to him. It was also put forward in the counterclaim that at the time that the transfer of the property was made Mrs Wilkins (by reason of excessive drinking) was not in a fit state to manage her business and that Dimock used his position as mortgagee to influence her to enter into the transaction and sell her property to him at a considerable under value. In defence it was urged that Mrs Wilkins had a solicitor acting for her at the time of the transaction and that the price given by Dimock was a reasonable one in view of the state of the property market at the time and of the benefits which she received from the leases. It was said also in defence that no influence had been used by Dimock, but that Mrs Wilkins was independently represented by a solicitor and was made thoroughly aware of the nature of the transaction. Mr AAS Menteath appeared for the plaintiff and Messrs JV Macdonald and FE Kelly for the defendants. Some evidence was heard and the
