By March 1860 Edward PLAYER and his family were resident in the Upper Hutt district.

Sir, I should be glad if you would give me a corner of your valuable paper to state the inconvenience the inhabitants of the Upper Hutt are under through the present postal arrangements. Strange as it may appear it requires no less than four days to answer letter per return of post either to the Hutt or Wellington. Our postal delivery rather arrival is on Wednesday and Saturday nights on early occasions at 8 30 pm but more generally 9 o'clock thus taking in its conveyance from Wellington from 5 and a half to 6 hours and the mail bag is made up for return the same night at 9 o'clock sometimes before the arrival of the bag our post leaves here on the following morning at half past 6 o'clock consequently we have no means of sending by post for three days after our receipt. When the last English mail arrived the bag was made up for return within 10 minutes of its arrival entirely cutting off all possibility of answering our English letters per return and this is not a solitary instance. The last English mail arrived on one Saturday and departed on the following our letters did not reach us until the Wednesday night 9 o'clock or after and we had no postal communication with Wellington until the following Monday 2 days after the mail had gone. Should the insertion of the above clause a slight alteration in the arrangements it will be doing the Inhabitants of the above neighbourhood an essential service and for which we should obliged. (to the Editor of the Wellington Independent) Upper Hutt 20th March 1860.

Sir - A Public Meeting was held on Monday evening last at the "Highland Home" Upper Hutt take into consideration and for the adoption of such measures as would best calculated for the prevention of the inhabitants drawn or to be drawn as Militia being guartered away from their own neighbourhood. Mr French was called to the chair and after addressing the meeting and explaining the cause of its being called read his Excellency the Governor's Proclamation also for the further information of the meeting the leading article of the Wellington Independent of the 13th instant remarking at the same time every information was so plainly set forth in it that any comment would be useless. The meeting being proposed by Mr Freeland and seconded by Mr T Wilkie. The seconder made the following observations his reason for seconding it was the amount of property that would be left unprotected were the Militia which may be drawn in this neighbourhood quartered away from it. The Upper Hutt being a Mill district containing three timber Mills employing about 60 men and if an attack were made upon these mills would cause the stoppage of the principle trade of the place and be the ruin of many families. proposed by Mr Heese and seconded by Mr Payer that a petition be forwarded to Major W Rawson Trafford commander in chief of the Militia Forces offering the male adult population of the Upper Halt as Volunteers to serve as Militia and to do duly as he may think at from Stokes Valley to the Mungaroa.. After some little discussion upon the proposition it was put to the meeting and carried unanimously. A proposition was then passed that a deputation wait upon Major Trafford with the petition and Mr French and Mr Heese were chosen as the delegates the expenses being defrayed by the meeting and the following morning appointed for the delivery of the petition and interview with the Commanding Officer. At the close of the above meeting a petition to his Honor the Superintendent was presented to the meeting praying him to have the Upper Hutt Gazetted as a town to be named by the present meeting. It was proposed seconded and carried unanimously that the name of the town be McHardie Town and on the carrying the proposition the chairman remarked he did not think a Better name could have been chosen. He was sure he (Mr McHardie) was the only land owner in the neighbourhood who had assisted the working man in getting himself a little home and comforts about him it was his land that had been cut into small sections and caused settlers to come up it was he who had given the settlers the comfort and produce of their gardens it was he who was getting the land cleared improved and cultivated and he the chairman would merely direct the attention of the meeting to the side of the road where Mr McHardie's section was improving daily and to the opposite side of the road sections and see what had been done in the shape of improvement there. In conclusion the chairman regretted as chairman it had not been in his power to make the proposition but felt satisfied the neighbourhood was now worthy to become a town and it could not bear a more worthy name than the one which had been proposed and carried. The petition then received the signatures of the meeting which was unanimously attended and after returning thanks to the chairman separated about 10 o'clock. Edward PLAYER

(to the Editor of the Wellington Independent) Sir - On the 8th last you were kind enough to insert a letter for me demanding a public explanation of the treatment I had received from the Military authorities on the calling out of the Militia which not having been done and having received an official letter upon the subject from Major Gorton I have to ask you the favour to publish the following correspondence. Upper Hutt 16th August

Sir - It is now some weeks I received information from Captain Cruickshank that you had requested me to act as Ensign to the 3rd Company of the Hutt Battalion of Militia on the same grounds as the other officers via. That be would be gazetted as Captain, Pierce Cotter Esq., as Lieutenant and myself as Ensign. I also beg to state I have by his directions acted as such and have been looked upon by the Company as one of their officers. Not having received any written authority and my name being omitted in the Gazette I felt I could s act no longer. You are aware I have been acting in the capacity your attention being to called to the fact on the day the arms and ammunition were distributed and on other occasions by written communications from Captain Cruickshank. I now have to request you will send me a written explanation and I trust a trust a truthful one of the insulting and ungentlemanly behaviour I have received if not at your hands from those in high military authority. I say written and truthful in consequence of a verbal explanation having reached me by Captain Cruickshank which I am sorry to say was very far from the truth. I should feel obliged by an early reply.

I am Sir, Your Obedient servant E Player.

To Capt. Ludlam Commander Hutt Militia - Upper Hutt 23rd August 1863

Sir - On Monday last I posted a letter to you requesting an early answer not having received it I send you a second trusting it will meet with more success than my former one.

I remain, Your obedient servant, Edward Player Captain Ludlam, Commander Hutt Militia.

Receiving no reply to the foregoing I communicated on the 24th of August with Major Gorton upon the subject who favoured me with the following official letter.

Militia and Volunteer Orderly Room, Wellington 07 September 1863 [No 445]

Sir - In reply to your letter of the 24th August, I have the honor to inform you that I referred it to Capt. Ludlam commanding Hutt Battalion for an explanation and have this day received his reply enclosing a copy of a letter written to him by you on the 16th August 1863 which letter I consider most insubordinate and intemperate showing an utter want of respect or any kind of discipline and it clearly proves to me you are not only totally unfit to hold a commission in the Militia but also the responsible post on a non-commissioned officer.

I have the honor to be Sir Your obedient servant Edward Gorton Major Commanding Wellington District Mr E Player Upper Hutt

Upper Hutt, 10th Sept, 1863,

Sir - I have the honor to acknowledge the receipt of yours of the 7th instant in which you make the wording of my letter to Capt. Ludlam the pretext for avoiding the explanation I demanded, and carefully conceal his Capt. Ludlam's reply. I beg to state I am at present in no way connected with the military and from the conduct of some connected with that service who should be gentlemen I feel highly satisfied such is the case. Your thrusts in the dark by the use of the words insubordinate and discipline display a great lack of generalship giving your antagonist an advantage over you in consequence of your not discovering his position. I must be shallow indeed not to see the subterfuge you have resorted to in the hope my request may be insultingly put down. I now demand after waiting thirteen days for your private reply, a public and truthful again I say truthful statement of the insulting treatment I received previous to the date of my letter to Capt. Ludlum of the 16th of August. With regard to your expression respecting may unfitness for the responsibility of a non-commissioned officer. I beg to state if the Province were canvassed whether you or I were to hold the office of Commander-in-Chief of the Militia forces I should feel no alarm as to my being defeated.

I have the honor to be Sir Your Obedient servant Edward Player Major Gorton Commander-in-Chief Wellington Militia

Why my demand both private and public is not complied with I know not I have given a candid and open challenge and waited thirteen days since my last. And now leave the public to judge on whom the discredit rests. I beg leave to acquit Capt. Cruickshank and Lieut. Cotter from the slightest participation in the affair and I should be neglecting a duty did I not assert they have in every way acted as gentlemen towards me neither have I much right to find fault with Major Gorton he having replied to my letter yet I cannot help thinking he has yet to discover a most important line in his military capacity between the terms of discipline and tyranny. As regards Capt. Ludlam's contemptuous treatment I can only account for it by his knowing he has done a very unsightly action too dark to bear the light of day and did not discover the consequence until he found he had caught a tartar. My letter to him of the 16th was not written until I knew full well he was making me a matter of convenience only which he has found I was not mean enough to submit to. I am sorry to occupy to much of your valuable space but the circumstance being partially known I trust you will see that I have been compelled to lay the whole of the facts before the public - I remain your obedient servant Edward Player.
