An Inquisition indented taken for Our Sovereign Lady the Queen at the House of John Chaney at Criterion Hotel of Upper Hutt in the said Colony on the second day of February in the year of our Lord one thousand eight hundred and seventy eight before John G F Wilford one of the Coroners of our Sovereign Lady the Queen for the said Colony on view of the body of Charles Rouse then and there lying dead upon the oath of James A Mackie Foreman – Horace Ames – Alexander Cruickshank – Edwin Butler – Isaac Wilkins – James Golder – James Brown – George C Palmer – George Brown – Timothy Tuomey – William Bowyer – John N W Petrie - good and lawful men of the neighbourhood duly chosen and who being there and then duly sworn and charged to inquire for our Lady the Queen when, how and by what means the said - Charles Rouse came to his death do upon their oaths say that Charles Rouse was accidentally drowned in the Hutt River, near Mr Cruickshank's Upper Hutt on Friday 01 February 1878 by the upsetting of a punt – The punt at the time being overloaded. In Witness whereof as well the said Coroner as the said Jurors have hereunto set and subscribed their hands and seals the day and year first above written. The above named Depositions of John Johnson, Alfred Lucas & Henry Freeman written on six pages of papers numbers consecutively from one to six and by me affixed together were taken and sworn before me at the Upper Hutt in the said Colony on the second day of February 1878 J G F Wilford Coroner

Information of witnesses severally taken and acknowledged on behalf of our Sovereign Lady the Queen touching the death of Charles Rouse at the dwelling house of John Chaney known by the name of Criterion Hotel in the Province of Wellington in the Colony above mentioned on Saturday the Second day of February one thousand eight hundred and seventy eight before John G F Wilford one of the Coroners for the said Colony on an Inquisition then and there taken on view of the body of Charles Rouse then and there lying dead as follows to wit.

John Johnson being sworn saith that on Friday Feb 1st deceased was attempting to cross the Hutt river in a canoe in company of myself and three other, we were crossing near Mr Cruickshank's house in a canoe kept by him for the purpose, as soon as the canoe with the whole of us on board left the bank and got into deep water the canoe sank the weight being too much at our end, we were all thrown into the water deceased seemed quite powerless in the water and seeing his head under water I got hold of his coat at the back of his neck and endeavoured to keep his head above water deceased then tried to get hold of me and just after I felt the rope attached to the canoe about my legs this caused me to let go deceased and look after myself to getting ashore and at once untangled the canoe & went to the assistance of deceased where we got him out he was apparently quite dead we used all means we could think of to restore life but without effect. I have never been more than three in the canoe before. The water is seven or eight feet deep where we were crossing no current was running. It occurred just before eight o'clock in the morning we were all perfectly sober. The accident was in my opinion due to the heaviest weight being in the stern, I am not sure that the canoe would take five men a cross the river however loaded it might be or –that out. There was no skylarking what so ever going on nor was there any doubt expressed as to the number getting into the canoe we tried for six or eight minutes to restore canoe ashore but without effect. By a Juror - I have no idea that the canoe was incapable of carrying five across the river. The river may be about twenty yards wide signed John Johnson

Alfred Lucas being sworn saith that I was one of the five men who attempted to cross the Hutt River near Mr Cruickshank's as soon as we parted off from the shore & got into deep water the canoe went down stern first. I struck out for shore looking back I saw deceased struggling in the water – Johnson was near him I saw Johnson suddenly leaving him saying the canoe rope was about his legs I saw no more of deceased till we got him out I consider the sinking of the canoe was due to the heaviest weight being in the stern if properly loaded I think the canoe capable of carrying five people across the Hutt river We were all sober & no skylarking was going on deceased from the way he conducted himself in the water evidently could not swim a stroke signed Alfred Lucas

Henry Freeman being sworn saith that I was one of the occupants of the canoe yesterday I was in the stern of the canoe the accident was due to there being too much weight in the stern the canoe has taken five men across the river before and is in my opinion capable of doing so if property loaded – By the Juror Not a word was said about five being too many for the canoe to carry signed Henry Freeman

An important case came before the Chief Justice this afternoon in the matter of an application by Lady Olivia Caroline Amelia Bentinck to bring part of section No 125, Hutt district, under the Land Transfer Act 1885, and caveats by (1) John Craig, David Brown, Joseph Bowyer, Edmond Greenwood, William Rouse, and Janet Brown, under one caveat, and (2) Elizabeth Kelly, Susannah Rouse, and Mary Greenwood, all of the Upper Hutt, forbidding the bringing of the land under the provisions of the Act. The caveators were summoned to show cause why the caveats lodged by them should not be removed and an order be made against them for costs, on the grounds that none of them could establish such length of possession of the land as would under the statute 3 and 4 William IV bar the applicant's title thereto that it would be an abuse of the process of the Court to permit them to bring an action to establish their title to the land, because the law and the facts showed that such action must fail that the caveat was lodged for the sole purpose of preventing the applicant from obtaining certificate of title, and of disposing of the land, and for other reasons set forth in an affidavit, Mr Stafford appeared for Lady Olivia Bentinck, and Mr Jellicoe for the caveators. Mr Stafford submitted that he should be allowed to examine the persons who had filed affidavits. In reply to his Honour, counsel for the applicant said he would endeavour to show that he could prevent the other persons bringing this action. The case is proceeding as we go to press.

Evening Post newspaper 09 May 1902

The Chief Justice gave judgment today in the summons to remove two caveats lodged against an application by Lady Olivia Bentinck to bring part of section No 125, Hutt district, under the Land Transfer Act. The caveats were lodged (1) by John Craig, David Brown, Joseph Bowyer, Edmond Greenwood, William Rouse, and Juliet Brown, and (2) by Elizabeth Kelly, Susannah Rouse, and Mary Greenwood, all of the Upper Hutt. Mr Stafford appeared for Lady Olivia Bentinck, and Mr Jellicoe for the caveators. Considering the case from every point of view, it was, in his Honour's opinion, clear that on the uncontroverted facts the "caveators could not make title, and it would be only inducing useless litigation and causing unwarranted expense and delay to order an action to be brought. He therefore ordered that the caveats be removed and the caveators on each caveat pay £5 5s costs and disbursements. His Honour agreed to the extension of the caveats for fourteen days from the date of expiry under the statute, to give time for the consideration of the question of appeal.

Court Of Appeal Judgments - Two judgments in cases heard by the Court of Appeal at the recently concluded sittings were read by the Chief Justice and Mr Justice Denniston this morning. Upper Hutt Land Case - In the appeal of Kelly and others v, Bentinck, Elizabeth Kelly, Susannah Rouse, Mary Greenwood, John Craig, David Brown, Joseph Bowyer, Edmond Greenwood, and William Rouse, of Upper Hutt sought to have reversed a decision of the Chief Justice who had ordered the removal of two caveats brought by the appellants against an application by Lady Olivia Bentinck to bring certain Upper Hutt land under the Land Transfer Act. Mr Justice Williams held that the caveators must fail on the ground relative to the Statute of Limitations and on the ground alleging ownership by possessory title. He was satisfied that the caveats should be removed, and that there was nothing to prevent Lady Olivia obtaining a

certificate from the Land Registrar. Mr Justice Denniston was of the same opinion, and was satisfied he also believed the other members of the Court were similarly satisfied that the caveators had no claim on the merits. Mr Justice Cooper concurred in the reasons given at length in the preceding judgments. The appeal was therefore dismissed with costs on the middle scale. Mr Jellicoe, for the appellants, moved for leave to appeal to the Privy Council. Mr Stafford, for Lady Olivia Bentinck, opposed the application, argument by which was adjourned for a fortnight.

#At half-past 4 o'clock yesterday afternoon Mr H W Robinson, RM, held an inquest at the Railway Hotel Wallaceville, upon the remains of Joseph Rouse, the circumstances of whose death by suicide we fully reported yesterday. The evidence as to the deceased's mode of life, and the finding of the body by his two brothers, was substantially the same as was related yesterday. Dr Whitehead said that the deceased some three weeks ago consulted him for a complaint which did not exist. The deceased appeared to be somewhat depressed in spirits, and the doctor treated him for sleeplessness and want of appetite. The deceased, when leaving the surgery, asked if there was any danger of his becoming insane, and said that rather than go into an asylum he would hang himself. The doctor reasoned with the man, and he left in a more rational frame of mind. Witness said that he had no doubt but that at the time the deed was committed the deceased was suffering from a fit of mental depression, which would practically render him temporarily insane. The deceased was last seen by Mr Arthur Cudby about 9 o'clock on Wednesday morning, and he was then walking up and down in front of his residence. He had previously told his brother William that he thought he was going off his head. #A Farmers Suicide - Wellington 13 December – The reported suicide of Joseph Rouse of the Upper Hutt is confirmed by the receipt of a telegram from the policeman there.  - #In the civil action in which the Public Trustee, administrator of the estate of Jabez Rouse, deceased, claimed £6 5s 6d from the New Plymouth Borough Council, as balance payable for medical and funeral expenses of the deceased under the Workers' Compensation Act, 1908, judgment was given for defendants by Dr McArthur, SM, in the Magistrate's Court today. In the original account the expenses were set out as follows - Maintenance in New Plymouth Hospital, £23 2s funeral expenses, £6 10s, and medical attendance, £1 1s, and the question the Court was asked to decide was whether or not the medical and surgical expenses included maintenance. His Worship held that they did not include maintenance, and consequently defendants were not liable for maintenance. Costs were allowed against the defendant.
