1860

The first building used for a Court House in the Upper Hutt district was situated in the Blockhouse then accessed from Fortune Lane off the road now known as Fergusson Drive. The Blockhouse if now situated in Blockhouse Lane from McHardie Street of Fergusson Drive.

The Blockhouse was also used as a Police station and the home for Constable David Lyster and his family. On the 90th birthday celebration of David Lyster's daughter Mrs Selina Hepburn in 1946 she shared her memories of the blockhouse in the early 1860s.

"Her father the late Constable Lyster joined the Armed Constabulary and later on the formation of the Police Force was appointed Constable at Upper Hutt and surrounding districts including Pahautanui which in those days was menaced by troublesome Maoris. The Block House at Trentham was erected in those days for the safety of the civilian population but was seldom used for that purpose. Mrs Hepburn lived there as a child and went to the Government School with her six brothers and-sisters where they paid 1/-per week. She also remembers Court Days being held at the Block House where she used to hold the reins of the Judge's horse while he presided at the session. Her father in his duties as Constable had frequent searches for the "Red Coats" as they were called who deserted from their ships while in port. Mrs Hepburn was the eldest of seven whose mother died when she was 16 years of age leaving

her to care for her father and the rest of the family. She later married the late Mr William Hepburn then a member of the Armed Constabulary at Wellington."

In reply to your Memo No 336 of this date I beg to inform you that since I have been in charge of this District the Upper Hutt Sub District had been exceedingly orderly and free from crime. During the year ending 31st December 1879 the total number of offences reported was twenty two, of these sixteen were for drunkenness, two for breach of the peace, two for housebreaking, one for indecent exposure and one for vagrancy. The only case of Carrikinism reported from there was an instance of some cayenne pepper having been put on the floor of a room in which a dance was being held. Four trains arrive and four depart daily. I estimate the population of the sub district at 500 of all ages and sexes. I have been informed that it is the intension of the New Zealand Bank authorities to withdraw their agency from Upper Hutt whether the Constable is allowed to remain there or not. Instructions have already been given to the Constable at Lower Hutt to visit Upper Hutt periodically

Evening Post newspaper 29 July 1880

Deputation from Upper Hutt - A deputation of residence in the Upper Hutt district waited on the Hon Mr Bryce Defence Minister to-day to protest against the proposed removal of the constable hitherto stationed at Upper Hutt. The deputation comprised Mr Mason, MHR, Dr Wilford, Messrs Morgan, Cruickshank, Brown and Bishop.

The deputation represented very forcibly to the Minister the hardship which would be inflicted on the district by the removal of the resident constable. They pointed out that a constable had always been stationed at Upper Hutt for twenty years past and the population had doubled during the last few years that of the district new being fully 700 adults. Several important roads converged there and it was also the terminus of several trains from Wellington. It thus formed a sort of outlet for the criminal population of the town who generally got as far as that by the evening trains and remained there for the night committing various petty thefts and other crimes. Most of the criminals cases dealt with at the Lower Hutt Court came from Upper Hutt. There were numerous sawmills in the vicinity and the mill-hands when they were paid their wages wer very apt to go on the spree and then to commit all sorts of excesses. There were three hotels there and the men would arrive intoxicated and call for more liquor threatening the landlords with personal violence if it were refused. Only last night one landlord was threatened to be stabbed because he refused to supply a drunken man. Then some of

the young men were very unruly and addicted to breaking windows and doing mischief so that the ladies and children could not attend church in the evening or go out at night in safety unless it was known that a constable was within reach. The deputation went so far as to declare that if the constable were taken away the place would be a little hell upon earth and would be quite uninhabitable. This would be a grevious hardship to many who had lived there more than 20 years and had erected homes there. Besides the bank manager had said the branch would have to be closed if there were no resident Constable. Sawmill accidents also were somewhat frequent involving inquests. It would cost so much more to serve summonses &c than now that no real saving would be effected indeed the fines &c collected more than compensated for the expenses. The deputation therefore urged the Government to reconsider their determination and presented a memorial to the same effect signed by 112 residents.

The Hon Mr Bryce reminded the deputation that retrenchment was forced on the Government by the Position of the colony and this was one of the directions in which a saving could be made. Probably an equally strong case could be made out by each district from which it was proposed to remove the constable. There was very much in what they said and no doubt the presence of a constable tended somewhat to prevent crime. Although their population might have increased so had the facilities for communication by railway and telegraph which would enable the services of a constable to be obtained at very short notice. The deputation urged that this was no remedy as most of the necessity arose in the evening after railway and telegraph hours when nothing could be done until the next day. A constable also would need to be used to the place to find his way alone about the various roads and bush tracks. Mr Byrce said he would compare the district with others and if he found the case was so exceptional as the deputation contended he would give their application his serious and favourable consideration. The deputation thanked him and withdrew.

I submitted characters from Victorian & Queensland Police for about four years' service and now as I see no chance of appointment here for some time to come I am anxious to get back to Australia but although I have been working hard since my arrival I have not yet sufficient money for that purpose. In case an Escort is required to any of the Colonies I would be willing to give my services free providing my passage be paid, I believe it is probable there still be one to Sydney shortly as there is at present a man named Robinson in custody in Wellington for an offence committed in Sydney N.S.W. I may also mention that I intend making application for an appointment to

the New South Wales Police and perhaps Escorting a prisoner from this colony might in a small degree assist in my purpose. Hoping you will consider my application favourable and thereby confer a great benefit upon me I will conclude.







New Courthouse Upper Hutt's Progress - The Building Opened - Upper Hutt's new courthouse was opened this morning before a large gathering of the public and the legal profession. The building is a handsome concrete one standing well back from the main Hutt road near the centre of the town. In comparison with the old courthouse it is commodious in the extreme. Besides the courthouse proper the building contains a public office magistrate's room and waiting room. The furnishings throughout are in rimu. The Mayor (Mr Robertson JP) on behalf of the Upper Hutt Borough Council and the local justices welcomed the Magistrate members of the Bar and local constables to their new quarters. In 1916 he said the Minister of Justice had acquired the land for the Court and frequent representations by the Borough Council had at last secured the building. They had had the unique experience of a Minister poking his stick through the old courthouse and saying that it would not lend dignity to a justice let alone a magistrate. The building of the new courthouse was a fitting climax to the interest taken in the district by Sir Thomas Wilford. He asked Mr W H Woodward SM to convey to the Justice Department the hearty appreciation of the borough for providing the building. In a short speech the senior Justice of the Peace r P D Davis traced the history of the council's efforts to secure the new building. Mr R H Webb spoke on behalf of the legal practitioners. He congratulated the borough on having acquired such a handsome addition to its building as the present Courthouse. Mr Woodward added his felicitations to those already given and promised to convey to the Justice Department the borough's appreciation. That the council had got a new building he though was largely due to its own efforts and to the goodwill of Sir Thomas Wilford.



The building which was owned by the Department of Justice was insured for £100 and the furniture and effects were insured for £100.

Growth of Upper Hutt - The advertisement in this issue of the Leader for a cadet for the Justice Department is a still further indication of the recent growth of Upper Hutt and the results of that growth. There has been a Magistrate's Court at Upper Hutt since 1894. Up to 1930 the

Courthouse was behind the Post Office building on the corner of Station Street the old Courthouse was formerly the old Post Office. The new Courthouse was erected on its present site in 1930. What a wealth of local history must have been revealed or made in the old building. What far reaching changes it must have witnessed. Up to 1955 a succession of police officers tilled the position of Clerk of the Court or later Registrar of the Magistrate's Court and what a job they made of their dual roles. However the police work and the court work had both grown to the stage where a civilian Registrar was needed. With the court work still increasing and the Births, Deaths and Marriages registration and Electoral work taken over the present building is much too small and additions are now being planned but who in 1930 could have foreseen the growth of the 1950s. We take courts and their work so much for granted that it is useful sometimes to pause and consider just what courts mean to the community. One of the first things done when New Zealand became a British possession was to set up a judicial system and from New Zealand's earliest days there has always been a judiciary unfettered by political or administrative control in the exercise of its judicial duties. But if by some mischance there were no courts, how would the community enforce sanctions against offenders? What sanctions could the police How would penal institutions receive their prisoners? We could perhaps have the concentration camp and the secret police but would they be possible under our Parliamentary system? The only answer to the absence of courts seems to be dictatorship. Indeed we are inclined to underestimate and undervalue the worth of the judiciary. The court staff is the right hand of the judges and magistrates and whoever is the youth selected for the staff of the Upper Hutt Court he will have the satisfaction of knowing that he is serving the community in a rewarding role. Youth of today have great opportunities. They start their working life at a time when slump, war and aftermath of war have successively robbed employing authorities of a continuous line of young staff. As a result today's youth will rise rapidly to top positions. They have great opportunities and grave responsibilities.

A number of settlers from the Upper Hutt waited on me this morning and asked that the S.M. Mr Martin should hold a fortnightly sitting of the Court there.

Mr Wilford Solicitor introduced the deputation and stated that the settler in the back part of the district were put to very great inconvenience and loss in having to go to the Lower Hutt to attend the Court. He further said that he had spoken to Mr Martin and found him willing to go to the Upper Hutt once a fortnight and allow the Justice to preform the work at the Lower Hutt on that day.

I respectfully that during the last two weeks this district has been greatly settled in and the Court work has been increasing during the quarter ending the 31st March 1894 there were 13 Police cases and about twice as many Civil Cases but this is nothing like what business would be done if there was a regular Court held here it is a great drawback to the inhabitants to have to go to Lower Hutt or Wellington for the sake of small debt Cases & for extra expense they will nto bother no trouble recover their debts.

The inhabitants of this district number from about 1,800 to 2,000 & to get to the nearest Court Lower Hutt some of them have to travel about 30 miles there as the people living at Akatarawa & there has been a great number of people settle there during the last 12 months Pakuratahi people would have to travel about 22. Whitemans Valley, Mungaroa, Prouse Valley & Moonshine people about 17 miles there each times as Summons come one.

The Plaintiff has to visit Lower Hutt or Wellington twice one to get summons Issued and obtain at the hearing & in some cases I have known the summons not been served and he would have to attend the third time I know that there are a great number of cases held over as they expect that a Court will be opened & for this upon they have only summered in Cases when foreman not there is not the slightest doubt that the work will increase the distance from the Township here to the Lower Hutt Court House is 11 miles.

I have been informed that the old Post Office here can be had for use as a Court House & as it is a Post building there would be expenses in that way it has been lately used as a store but is now closed & there would be very little expenses to make the necessary alterations and it is Situated in the centre of the Township.

Attached you will find report from the Clerk to the Court Lower Hutt and also from Constable McKinnon at Upper Hutt for the information of the Minister.

I was at Upper Hutt yesterday and find that the old Post Office building could at very small expense be converted into a court house in fact all that is necessary is removal a partition. This will give a court room and three small rooms which could be used as a general store but I was informed the storekeeper has assigned his estate and it will in a few days be empty. Many settlers urged on me the necessity of a court being need arguing that in cases where the amount owing are small it pays them better to lose their money than receive the expense of coming and bringing witnesses to the Lower Hutt or Wellington.

During the past year several cases from the Upper Hutt district have been dealt with by me here. I can I think arrange to have a court at Upper Hutt once a week if the Minister thinks proper. Then all no arrears of work here now and two during each month allowed be sufficient to dispose of the Trust Commissioners work respectfully if my suggestion made some time back as to charging fees for adjournments and in cases which were stuck out for nonappearance were carried out as parties would then rather care to be prepared to your with their cases when they came on for hearing and each days list would be comparatively a small one.

Should it be decided to establish the court all that would be required in the way of furniture would be two good sized tables a few chairs & say three mats there is no necessity to build a bench.

I have now to report on the above mentioned subject as follows

The building is of good construction and the timber on it is ground it would if put into repair make a very good Court House and as centrally situated the process would however be a better premise as the place has been disused (except as a store for which purpose it was at one time rented) for many years the Post Office having been kept in the Railway Station. I should not judge that any repairs have been carried out on the structure during the period above allowed to. At present the place is not utilised in any way. It is altogether too low the floor being level with the road and a hollow underneath on which drainage gathers and stagnates. If to be made use of it is essential the level should be raised say 2 feet and the hollow referred to filled in the surrounding level new piles being provided together with a new base course. The partitions in

the building should be removed & except at required one room 8 x 9 at what would be the bottom and of the Court Room this room would be required as an office for the Stipendiary Magistrates during his visit and at other times by the Constable in charge. The arrangement suggested would be additionally adountaglous [sic] as making available for a bedroom the room (one of the cells) at present used as an office by the Constable in his own quarters. As the Constable quarters are somewhat confined and his family a large one this would be confenilul [sic]. It would not however obviale the necessity as to which you have leave previously advised for construction a two Cell lock up at this station. The double chimney would have to be taken down and the brick used to build a single chimney in one of the said walls in the partition at present occupied by a small lean to which should be shifted and made to act as a wood and Coal store. The locks of doors need repairing and the windows should be fitted with sash fasteners and should have the bottom sashes being throughout. The building should be painted twice in two coats to preserve it form Decay and equally it should be thoroughly cleaned and painted in three coats in order to secure to sanitary condition. The roof covering is sound and does not leak except the large boards which are perished. The guttering equally requires renewal. To prepare the Court for use the following furniture and fittings would be necessary. A Bench, witness box, dock and rail, two tables, six chairs, three forms, forty feet of shelving, fifty yards, con making, seven window blinks. An estimate of the costs of the work summated herein is approved (signed)

Committee rooms in the old Courthouse building. It was suggested to the Association that arrangements be made directly with the R.S.A. for the use of the rooms as a sub-tenant. Apparently arrangements must have been made along the lines. The War Veterans Association request of course cannot be considered. Apparently some offer of free labour is being made and this should be investigated when you are considering the whole question (see my memorandum of 12tj idem) Under Secretary
- 01st October 1945 Copy South African Veterans Association of NZ (Inc) Hutt Valley Association to District Engineer Courthouse Upper Hutt Fire Damage and Repairs In reply to PWDO 2/11 of the 26th Ultimo these rooms are very popular in Upper Hutt and during the War we allowed any patriotic concern the use of them free. Our Association made no revenue out of the rooms except that casual letting paid rents, rates insurance and licence. We have been approached by organisations who made use of the rooms in regard to repairs and we are prepared to restore the building to a better condition than it was before the fire with only any insurance funds available. Although at the moment I cannot find receipts my books show the rental paid to 31/3/43. Probably the reason the rent was unpaid in 1944 is due to not having received and account although I hold receipts for rates, rubbish collection, insurance and Hall license paid to 31st May 1946. I was in the regular forces in 1943 working up to eighteen hours per day but I distinctly remember sending a P.N. for the rent to Upper Hutt. We would be pleased if we could be allowed to proceed with the restoration as at the moment our organisation with others is without a home. If allowed to proceed we could affect the repairs with our own labour within one month. C H Ritzema
- 09 October 1945 to Under Secretary PWD Upper Hutt Courthouse Fire Damage and Repairs With reference to your memorandum PW 22/182 of the 18th September I now attach for your information copy of a further letter received from the Secretary South African Veterans Association of New Zealand. I have not yet been able to ascertain to whom rental has been paid but am enquiring further in this connection, The £50 insurance has not yet been uplifted from the State Fire Office but in the meantime I should be pleased if your would advise whether or not the South African Veterans Association are to be permitted to carry out reinstatement at their cost with a limit of £50 as the Governments contribution District Engineer
- Upper Hutt Courthouse Fire Damage Precis (1) This building has not been occupied by a Government department for at least fifteen years. In 1930 the Justice Department thought it should be condemned. The District Engineer however advised that it was in a condition sufficiently sound for leasing and that the site was of potential value to the State. He suggest that it could be leased the term to be not longer than five years. (2) Accordingly the building was leased to the RSA (Upper Hutt) and for a time in 1933/34 to a Mr C G Marshall. The terms of the lease have varied from time to time. The lease expired on 28/2/43 and does not appear to have been renewed. The main terms in the last lease were (a) Annual rental £6 payable monthly in advance (b) Lessee to pay rates, taxes etc., (c) Lessee to maintain the premises the principle being that no further expenditure should be incurred by the State. (3) Public Works Department took the property over from the Justice department in 1933. (4) In October 1940 the South African War Veterans Association stated that they advised that the

RSA was vacating and asked that the building be let to them. They were advised that the lease with R.S.A. would not expire until 1943 and it was suggested that they obtain possession by arranging to sublet. (5) Apparently the Veterans Association made an arrangement with the RSA whereby the RSA continued as lessee but with the Veterans Association paying the costs (6) A fire recently occurred in the premises the cost of repairs being estimated at £300. The Veterans Association asked permission to do the repair work the Department to pay for materials. (7) Having reference to the insurable value as compared with repair costs the District Engineer was requested to report on the position along the lines that it would be better to demolish the building altogether rather than to repair and to continue at such a low rental (8) The War Veterans Association have now requested approval to repair the premises at their own cost the Departments liability to be limited to the £50 (recovered from the Insurance Company). (9) Having regard to all the circumstances I would suggest that the following action be taken (a) That the District Engineer confirm that the RSA is no longer interested in the lease and (b) That the War Veterans Association be permitted to carry out the repair work provided that (1) a new lease is executed between the Department and the Veterans Association (2) The term to be limited to 5 years (3) Any arrears of rent be fully paid up to date (4) The Departments Liability for repairs to be limited to £50 (5) the repair work be of a standard of workmanship satisfactory to the Department (6) thr Department not to be responsible for compensation in respect of any improvements effected by the Veterans Association in the event of the land being required at the expiration of the lease (with consequent demolition of the existing building) [2 copies]

- 01 November 1945 Old Upper Hutt Courthouse Fire damage and Renewal of lease I have to advise that the above property has been held over the past fifteen year because of iys potential value as a site for a Government building. The Post and Telegraph Department has now indicated that it desires to purchase this land for a building purpose but it appears that the Railways Department also has plans that embody its use. The Railways Department claims tht it has title to this particular site. In view of the fact that it may be some time before a decision is reached in ultimate use of the property will you please inform the Secretary of the South African Veterans Association of the position. There is a possibility that the New Zealand Railways may concur in the transfer of the particular section upon which the old Court House stands to the Post and Telegraph Department and that the Post and Telegraph may not procced with its building programme for some year. If this is so it may be possible at a later date for the Veterans Association to negotiate with the Post and Telegraph Department for a short term lease of the existing building.
- Foot note to above In Conversation with Mr Davis (NZR Department) he advised that all the land in the area in which the old courthouse is sited was originally purchased for NZR and is required by that Department for building purposes. He states however that in all probability his Department will be prepared to allow the Post and Telgraph Department to take over the Courthouse site. Will you please advise the legal position regarding this land that the Department's dealing with the South African War Veterans Association may be placed on a satisfactory basis

In addition I would appreciate advice of any details you may have regarding the original transaction whereby your Department was given the use of the land
