





Mrs Neta Islington LYONS

Kaitoke Post Office - postmistress 1952-1981

Neta Islington LYONS was the post mistress at the Kaitoke Post Office from 1952 to 1981. She also ran the Kaitoke Store which was situated in a hut next to the Post Office on the main highway. The store and post office were situated on the left after the bridge at Kaitoke before going towards the Remutaka hill.

"In June 1952 the YMCA National Secretary advised the Post & Telegraph Department that the Kaitoke Camp was to be closed on 20 June. The office was transferred from YMCA control on 21 June. Although keen to continue in the position Mrs Hoey found it impractical and the position was offered to Mrs Lyons who operated the Kaitoke Cash Store on State Highway 2 near the camp. The postmaster at Upper Hutt reported however that there is no accommodation suitable for post office facilities in Mrs Lyons's store and she has been informed that unless this is provided control cannot be passed to her. The difficulties were soon overcome when the Ministry of Works provided a small hut which was placed against one wall of Mrs Lyon's store and her appointment as postmistress too effect from 08 July 1952 at a salary of £95 per annum. So began an outstanding example of community service for Mrs Lyons was to continue to operate the post office for the next 37 years."
