
Fern Ground Volunteers 1870-1873

The Fern Ground Volunteers Company was established around 03 September 1870. Captain James Cruickshank was the commanding officer. On the 05 April 1872 the early records of the Fern Ground Volunteer Company were destroyed in a fire at the Fern Ground saw mill owned and operated by Captain Cruickshank. The Fern Ground Volunteer Company was disbanded on 28th May 1873.

Fern Ground was the name given to an area north of Upper Hutt near Maoribank. James Cruickshank established his saw mill in the same area and named it Fern Ground. Captain Cruickshank may have had some influence on the naming of Fern Ground Volunteer Company.

Evening Post Newspaper Wednesday 14 September 1870

For some time past the formation of a Volunteer Company has been in contemplation in the Upper Hutt, and it was generally understood that the last monthly drill-day of Militia - Tuesday, the 6th inst. - would have witnessed initiative measures, but the inclemency of the weather, postponed (according to understood usage) any meeting on the day in question. Since then, however, circulars, numerously posted, and bearing the signature of Jas. Cruickshank, Captain of Militia in this district, announced that members of that force were ordered to meet at the Highland Home Hotel at two o'clock on Tuesday last, to receive arrears of pay, after which those who intended to identify themselves with the volunteer movement would proceed to the stockade, and after delivering their arms and being sworn in, be enrolled, and receive new rides. This was done on Tuesday last. The following officers, in addition to four sergeants, were eventually elected: - Captain James Cruickshank, Lieut. Henry Burt, Ensign Frank Smedley Searancke. The company bears the name of "The Fern Ground Volunteer Company." (Reference National Library of NZ Papers past website Wednesday Evening Post Newspaper 14 September 1870 page 2)

Colonel Moule – You will observe by Colonel Readies memo that the record book of this Corps has been lost by fire. This should have been reported at the time and another would have been applied. I think the claim may pass as all are qualified except (7) seven men who want only one parade and the reference is that has been performed signed James Stevens 28-5-72 [28 May 1872]

Captain Lockett informs me that the books belonging to the Fern Ground Volunteers were destroyed by fire when the saw mill premises were burnt down consequently the records of Company Parades is lost. He informs me however that the men have all attended - - of Company Parades signature?]


