Charles Hayward Izard (1860-1925) a Wellington Barrister and Solicitor owned a house on the corner of the Main Road (north) and Cruickshank Road. During World War One Charles offered his house to the Defence authorities for the use of a convalescing home for wounded service personnel. It was known as the Izard's hospital but was also referred to as the Measles hospital and Upper Hutt hospital.

Convalescent Home for Soldiers – Mr C H Izards offer accepted - The Minister for Defence (Hon J Allen) has received, from Mr C H Izard an offer of help on behalf of the Expeditionary Forces which will, doubtless, be greatly appreciated. Mr Izard has informed the Minister that he is willing to place at the disposal of the Defence authorities his house and grounds at the Upper Hutt as a convalescent home for sick and wounded, troopers coming from the front. The Minister, accompanied by the Commandant (Colonel Robin), the Hon R. H Rhodes, Dr Frengley (District Health Officer), the Government Architect (Mr J Campbell), and Major Morton (City Engineer), paid a visit to the house on Saturday, and after inspection expressed themselves as being highly pleased with the offer, which the Minister, on behalf of the Government, readily accepted. The house is to be placed at the disposal of the Government free of rent, and it is almost completely furnished. The occupants will have the use of the grounds and the vegetables growing there, with the exception of those that Mr Izard requires for his own use. I am sure, said the Minister, in making known the offer, that the public generally will be gratified to learn that such a beautiful place will be ready for our sick and wounded when they return to us.

I desire again to draw attention to the splendid offer made by Mr C H Izard to place his house at Upper Hutt at the disposal of the Department as a convalescent home for returned sick troopers. It is a beautiful place, and well adapted for the purpose. The house, he continued, would accommodate about twenty four men, and Mr Izard had in his offer intimated that the Department could enjoy the free use of all the fruit and vegetables already harvested. As to the water supply, Mr Izard had offered to pay the cost of connection with the Upper Hutt Town Board's supply, or, if the Government decided to obtain water direct from the river, he would pay the cost of a windmill and reservoir and half the cost of the pipe-lines. If the Government desired to substitute acetylene lighting for the present oil lighting system, he would bear half the cost. If the Government decided to institute electric lighting he would pay for the machinery and half the cost of the lines and other necessary accessories. The house was to be at the disposal of the Department so long as it was required. The offer is a most generous one," remarked the Minister, and I had no hesitation in accepting it on behalf of the Government.

In 1915 – 1916 there was an outbreak of measles at Trentham Camp and the patients were moved to Izard's hospital. This is why it became known as the measles hospital but it was also referred to as the Upper Hutt Hospital.

Measles at the Camp - Still better quarters - Better arrangements have been made for the accommodation of soldiers recovering from measles, a disease which is now fairly prevalent at Trentham camp. It was intended that sick men should go to the General Hospital, and that during the period of convalescence, they should go to Berhampore and then to special quarters at the camp. It was considered, however, that the Plague Hospital at Berhampore was not an ideal establishment for patients, and the Defence Department have now secured the use of Mr C H Izard's house, situated in the Hutt district, as a home for convalescent men. The Plague Hospital is being renovated, and it will be a reserve for use in cases of emergency, such as a rapid spread of the disease.

Mr Izard some months ago offered his house to the Defence authorities as a hospital for wounded soldiers returned for the front. In view of the present difficulty, however he had been good enough to place it at the disposal of the Defence Department unreserved for any hospital purpose. It will now be used as a convalescent home for measles patients. In conversation with a reporter yesterday the Defence Minister expressed his great appreciation of Mr Izard's generosity.

The Measles Outbreak - A home of the Convalescents - The Defence Minister mentioned yesterday that the task of dealing with the outbreak of measles at Trentham camp had been simplified by the generosity of Mr C H Izard in placing his home unreservedly at the disposal of the military authorities. Some time ago Mr Izard offered his residence for use as a hospital for wounded men. Now he had offered it for any purpose for which it might be required, and the Defence Department proposed to place the convalescent soldiers there as soon as they were ready for removal from the general hospital in Wellington. The Berhampore hospital would be kept as a stand by in the case of a rush of cases and in the meantime would be placed in better condition than it was in just now.

The arrangements for the treatment of the measles outbreak appeared now to be complete, added the Minister, and he believed that the plans made would work in a thoroughly satisfactory way. The doctors of the Defence staff would handle the cases in the hospital ward, while the general control of the institution would remain in the hands of the medical superintendent. The men would receive the best of attention, and he hoped that the outbreak would be brought to an end speedily.

The Outbreak of Measles - You can't have 7000 men together in a heap without, some ailment attacking them, and we have been jolly lucky up to the present. This was a medical man discussing the outbreak of measles at Trentham camp. Already the old Fever Hospital at Berhampore is full of cases, and there are three or four marquees at Trentham where infected troopers are being treated, and fresh cases are being reported every day. A good proportion of the cases are said to be light, and in the case of an otherwise healthy man there is no special danger of serious developments arising out of measles. A convalescent home is being established at Mr C H Izard's country house at the Upper Hutt, and all reasonable precautions are being taken to cheek the spread of the malady.

The Measles Epidemic - Preparations at Kaiwarra - It is expected that by tomorrow afternoon Messrs Levin and Co.'s large store at Kaiwarra will be ready for a number of soldiers, convalescent from measles. The present intention is to continue the use of two Public Hospital Buildings (including the Victoria Women's Ward). The patients, when regaining strength, will be moved on to Kaiwarra and to Mr C H.Izard's house in the Hutt Valley. There will be accommodation for a hundred men at Kaiwarra and for thirty to fourty at Mr Izard's well appointed house, which has been placed wholly and unconditionally at the Defence Department's disposal during the period of the war. Berhanipore may take up to forty convalescents, but the least possible use will be made of that little hospital, which was originally designed for only ten patients. Complaint is made that the measles convalescents are allowed too much liberty at Berhampore. It is stated that "truants" have mingled with members of the public, and the "contacts" may spread the disease. It is urged that improvements are necessary in the measures taken to minimise the risk of infection among people who go by train to Trentham.

Soldiers Health in our Training Camps – General Henderson added that Izard's meales hospital at Upper Hutt had been in occupation so long that it had been decided to have the place thoroughly cleaned and disinfected. The majority of the patients therefore had been removed to the Trentham Racecourse Kiosk which had been taken over temporily in order to enable the removation at Izard's to be done. Fresh measles cases from Trentham were also being admitted to the Kosk at present instead of being sent along to Izard's as formerly. The fact that th Racecourse Kiosk had been taken over was no indication that there had been fresh trouble at Trentham it had been taken over puriley temporatily for the purpose he had stated and those who heard alarmist rumours accordingly could set their minds to rest.

The Hon James Allen replied that if there were any such rumour being circulated, he was glad to have an opportunity of giving it a complete denial. There was extra hospital accommodation at Trentham, and Mr Izard's house at the Upper Hutt was being evacuated. He also emphatically denied that there were two deaths per day. There had been only three deaths at the Upper Hutt from pneumonia, and two in the camps from meningitis recently. During the last few days the number in hospital had been reduced by 20 or 30 patients.

William Guy Dabbs was born 1894 Hastings New Zealand. His parents were Caroline Isabel nee Sheild (1869-1942) and William Dabbs (1856-1894) who married in 1893 New Zealand. William was an only child. He attended Wanganui College. William was a farm hand when he enlisted and entered Trentham Military Camp on 04 April 1916. He was promoted from Private to Lance Corporal with the Camp Military Police. He was admitted to Trentham Hospital on 05 June then transferred to the Izard hospital with measles. William developed pneumonia and died at 5.30pm on 14 June 1916 and was buried at Karori Cemetery in Wellington with full military honours. William never married.

Francis Richard Linnell was born 10 June 1882 Kaiwaka New Zealand. His parents were Mary nee Hull (1844-1907) and George Frederick Linnell (1844-1936). Francis had 7 siblings they were Elizabeth Kate, George Frederick, Alicia Mary, Lily, James Everard and 2 were not named. He was a stockman and later farmer at Kaiwaka in Northland. Francis enlisted on 01 May 1916 in Trentham. He was admitted to Trentham Hospital on 03 June 1916 then transferred to Izard Hospital Upper Hutt where he died at 3 am on 22 June 1916 of broncha-pneumonia from measles. Frances was buried at St Michael churchyard Kaiwaka Kaipara District Northland.
