Maori Deaths and Prisoners of New Zealand Wars

While researching information about the deserters of the New Zealand Wars, I came across some interesting information about Maori deaths and prisoners of War in the 1864 AJHR.

We all know that there were prisoners of war in World War One and Two but I had never given it a thought about any prisoners during the New Zealand Land Wars.

Locating information about Maori deaths during this early period is virtually impossible so imagine my surprised to find details such as name and date of death in the "Daily Reports on Maori Prisoners". In these reports there is a lot of statistical information but I have only extracted brief details on prisoners who are named and include some who died.

For those who are undertaking early Maori research the journals are well worth looking at. Vessel – Date - Remarks

- HMS "Curacoa" 30 Nov 1863 Chief Te Oriori of Ngatikoroki from Arikima received three
 wounds in engagement at Rangiriri etc. The old Chief Parioroku Tuhikaitai of the Ngatikoroki
 from Nukuha, Waikato received a wound etc. Peneamene Ngatipa of the Ngatitawhaki from
 Peria was wounded etc.
- HMS "Curacoa" 24 Dec 1863 Pairoroku Tuhikitia is quite recovered of wounds in the back. The sick and wounded are progressing favourably. The prisoners were removed this day to the "Marion" Hulk, at 4 and 5 p.m.
- "Marion" Hulk 29 Dec 1863 Tangataware Iwitaia was arrested etc and taken to goal Total 177 prisoners on board
- "Marion" Hulk 11 Jan 1864 Te Wirihana Huiputea of Ngatimahua received aboard Total prisoners 178
- "Marion" Hulk 14 Jan 1864 Four prisoners re4ceived aboard Paratene of the Ngatinaho (with Te Wheoro at Te Ta in August 1863); Manahi Ngatimahuta from Wahi; Hami Te Komekome from Wahi, Hori Te Whana from Wahi.
- "Marion" Hulk 21 Feb 1864 Te Rakatau sick on-board etc.
- "Marion" Hulk 22 Feb 1864 Te Rakatau very weak
- "Marion" Hulk 24 Feb 1864 Chief Te Rakatau improving etc. Teoriori Te Hura discharged
- "Marion" Hulk 25 Feb 1864 Chief Te Rakatau better etc. Karaka sick etc.
- "Marion" Hulk 28 Feb 1864 Chief Te Rakatau poorly etc. Karaka weak etc.
- "Marion" Hulk 29 Feb 1864 The Chief Te Rakatau had a sudden turn yesterday at 3.p.m.; he gradually became weaker and ejected blood profusely from the mouth. He suffered little or no pain and expired 7.40 in the evening. [Later reports on diseased meat fed to prisoners]
- "Marion" Hulk 8 Mar 1864 Prisoner arrived yesterday Te Kemene Kahika of the Ngatinaho who was taken at Rangiawhia
- "Marion" Hulk 13 Mar 1864 Tuhikatia recovering etc.
- "Marion" Hulk 14 Mar 1864 Tuhikatia convalescent etc.
- "Marion" Hulk 15 Mar 1864 Tuhikatia fast recovering etc.
- "Marion" Hulk 16 Mar 1864 Tuhikatia improving etc.
- "Marion" Hulk 17 Mar 1864 Tuhikatia improving etc.
- "Marion" Hulk 27 Mar 1864 Three Maori prisoners were received on board last evening etc. taken in engagement at Rangiawhia named Hoepa Paituri of the Ngatiapakura; Penetita Te Wharaunga, Ngatiapakura; Kereopa Paraki from Kawhia total number of prisoners aboard
- "Marion" Hulk 3 Apr 1864 Half-caste boy Henry Wheeler delivered over to Bishop Pompallier.
- "Marion" Hulk 19 Apr 1864 Three Maori prisoners received Wi Karamoa of Ngatihinetu; Te Rewarewa of the Te Patupo, and Wi Hiore of the Rongowhakaata from Tauranga (Poverty Bay) all taken at Orakau
- "Marion" Hulk 21 Apr 1864 Werahiko Te Koputa had tumour removed etc. Chief Te Kepa refuses to wash etc.

- "Marion" Hulk 26 Apr 1864 Panapa weak etc.
- "Marion" Hulk 29 Apr 1864 Panapa depressed state etc. Ririmu a lad about 18 year of age looks in decline etc.
- "Marion" Hulk 30 Apr 1864 Panapa little better etc.
- "Marion" Hulk 1 May 1864 Panapa and. Ririmu very weak etc.
- "Marion" Hulk 2 May 1864 Panapa and. Ririmu better etc.
- "Marion" Hulk 3 May 1864 Panapa and. Ririmu still very weak etc.
- "Marion" Hulk 4 May 1864 Panapa and. Ririmu no change etc.
- "Marion" Hulk 5 May 1864 Panapa and. Ririmu taken on shore and lodged at Hone Ropiha's etc. Total prisoner 195
- · Mohi Tahuri doing better etc.
